Shoalwater Bay Tribe	May 2010 – Tribe sent ACF letter of intent to begin TANF in July 2011, but has not yet contacted DSHS to begin negotiations on a TANF agreement.
Cowlitz Tribe	Dec 2011 – Jim Sherill shared that Tribe is exploring TANF.

Chehalis, Colville, Jamestown S’Klallam, Nisqually, and Tulalip	Each Tribe originally submitted letters of intent to operate a Tribal IV-E program
