

**INVOLUNTARY COMMITMENT INFORMATION**  
**(Adults and/or High Risk Youth)**  
 (Revised 9/15/2009)

Revised Code of Washington 70.96A.140 authorizes a designated county chemical dependency specialist to investigate and evaluate specific facts alleging that a person is incapacitated as a result of chemical dependency. If the designated chemical dependency specialist determines that the facts are reliable and credible, **the specialist may** file a petition for commitment of such a person with the superior or district court.

Each county has been asked to designate chemical dependency specialists to carry out the duties mentioned above. To find who the designated specialists are in a specific county, consult the listing below. For additional information you may call the Division of Alcohol and Substance Abuse (DASA) Regional Administrator for your area. You can find the name and telephone number for the DASA Regional Administrator on the inside front cover of this listing.
