<u>TREATMENT FOCUS:</u>	Indicates when the focus of treatment is intended to serve a particular group of people. This designation is provided to the Division of Behavioral Health and Recovery (DBHR) by the certified agency.
<u>MISCELLANEOUS</u>	
An Asterisk (*):	Indicates a service for which there is a state or county contract, or both, or Medicaid (Title XIX), commonly called "publicly funded treatment."
CARF:	Indicates the provider meets standards for accreditation of rehabilitation facilities set by Commission on Accreditation of Rehabilitation Facilities (CARF) , 4891 East Grand Road, Tucson, AZ 85712; telephone: 520-325-1044 or Toll Free 1-888-281-6531, http://www.carf.org .
COA:	Indicates the provider meets standards for accreditation of substance abuse chemical dependency programs set by the Council on Accreditation (COA) , 120 Wall Street, 11th Floor, New York, NY 10005; telephone: 212-797-3000 or Toll Free 1-866-262-8088, http://www.coanet.org .
THE JOINT COMMISSION:	Indicates the provider meets standards for accreditation of alcohol and substance abuse facilities set by The Joint Commission , One Renaissance Boulevard, Oakbrook Terrace, IL 60181; telephone: 630-792-5000, http://www.jointcommission.org/ .
COD:	Means this agency provides outpatient services for persons with "Co-Occurring" mental health and chemical dependency disorders. These services have formerly been referred to as dual disorder or Mentally Ill Chemical Abuser (MICA).
COD-MHC:	The adult residential treatment programs with the COD-MHC designation offer the following: 1) on-site mental health screening and assessments by a DBHR contracted mental health counselor (MHC), 2) access to psychiatric medication and medication management, 3) linkage to community mental health services, and 4) on-site co-occurring education groups.
NATIVE AMERICAN:	Indicates services are designed primarily for clients who are Native Americans.
NCCHC	Indicates provider meets accreditation standards for the quality of health care in jails, prisons, and juvenile confinement facilities set by the National Commission on Correctional Health Care (NCCHC) , 1145 W. ON-LINE REPORTING:	Indicates when an agency reports directly to DBHR through an on-line computer modem.
PREGNANT AND POST-PARTUM (PPW):	Indicates the agency provides chemical dependency assessment, referral, and/or treatment to pregnant and post-partum women.
SPANISH SPEAKING:	Indicates the provider has Spanish speaking counseling staff and provides educational materials, lectures, and counseling services in Spanish.
YOUTH:	Means a person seventeen years of age or younger.
