Changes to Long-Term Care Worker Training Requirements and Actions You Need to Take as a Currently Approved Core Basic Trainer DDD Residential Services Instructor June 2011

The purpose of this email is to clarify staff training requirements and important actions you must take as an agency.

The Governor signed legislation on June 15th to delay the two elements listed below:

- The 75 hour training, home care aide certification and the federal background check requirements for all LTC workers until **January 1, 2014**.
- The continuing education hours increase to 12 until July 1, 2014.

The training requirements revert to what was in place on December 31, 2010. See the table on page 2 of this email for a full list of training requirements for each support setting.

What Does This Means for Your Training Program?

Recently your Training Program was contracted with DDD to provide the core basic training for DDD Residential Service providers.

• As of July 01, 2011, this contract will be null and void. DDD will not make any reimbursements for any training offered under this contract after June 25, 2011.

Actions You Must Take - Handling Core Basic Trainings Scheduled, In Process, or Completed.

If you have orientation, safety, core basic training and/or population specific training(s):

> Scheduled

- Effective immediately, stop providing these courses or advertising them.
- Cancel any of these trainings you have scheduled.
- Notify workers registered for these trainings that the law has changed.

> Core basic training in process but not completed

- Have those staff complete the 40 hours of the core basic training.
- Provide the remainder of the topics that are required under chapter 388-101 WAC
- Issue the staff the DDD 40-hour Core Basic Training course certificate.
- Request reimbursement for the trainer through the Survey Monkey.
- Request reimbursement for staff time through your Regional Resource Manager.

There may be cases where staff or your agency may choose to complete the entire 75 hours of training. In these situations DDD will provide the 75-hour certificate for the staff. The agency administrator may request the 75-hour training certificate from the Regional Resource Manager (RRM). However, DDD will not be able to pay for instructor costs or staff time beyond June 24, 2011.

Completed

Staff who have completed the 75 hours of the Training Program during this time can use their training certificate to demonstrate they have met the basic training requirement.
