Eddo ko Am (Kwōj Aikuj)

- Letok melele ko kim aikuj ñan lale elañe kwōmaron ebōk jibañ.**
- Letok kamool ñan kim ilo ien kim aikuj.** Kim maron böke ñan kwe. Melele eo kwōj lelok ñan opij eo enaj aikuj kamool jen ritjerbal ro an federal im state. Kein kamool emaron koba armij ro ñan kebaak in bar lale jen rijerbal ro an opij ekoba rietale ro ikijen koot.
- Melele eo ej ripoot lok ñan Department of Social and Health Services (Ra eo ej bōk eddoin Kakien ko rej Jibañ Armij im Ejmour)** emaron jelöte am maron töbrak ñan injuran in taktō eo ej kōmadmōd jen ibben Health Care Authority (Opij eo an kien ej bōk eddoin jikin ko rej lelok jibañ in ejmour) im Health Benefit Exchange (Jikin eo ej jibañ bōk injuran in taktō eo edik wonnen).
- Ripoot oktak ko** (einwōt, atorej, kolla, bar juon) einwōt aikuj ilo WAC 388-418-0005. Ripoot kaki mokta jen 10 raan in allōñ eo juon.
- Karejar ibben Division of Child Support (Opij eo ej bōk eddoin kakien ko rej kejbarok wonnen lale ajiri, DCS)** ñe kwōj ebōk jāān in jibañ jen TANF. Kwōj aikuj jibañ DCS kōmmame, uköt, ak kabine jibañ eo an ajiri ñan ajiri eo/ro kwōj lale, im kōmmame peba ko rej kwalok woñ jemen (elañe aikuj). Kwōmaron makoko in karejar ibben DCS elañe kwōmaron kwalok ewōr wūnin am tōmak ke DCS ej liküt kwe, ajiri ro nejum, ak ajiri ro kwōj lale ilo uwōta in jorrāān jen jinen ak jemen eo im ajiri eo ejab bed ibben.
- Kateruru ñan** im kōmmame jerbal eo emmon jjoñan ñan böke kolla eo kwōmaron jen jikin ko jet ilo ien am kajjitök ak ebōk jibañ in jāān.
- Kadedelok ripoot im etale ko rej mennin aikuj.**
- Loor mennin aikuj ko ikijen jerbal** ñan jibañ in jāān im jibañ in mōñā.
- Ba ñan kim** ñe kwōkōnaan an bar juon armij kōjerbal jibañ in jāān eo am ikijem
- Karejar kin etale ko amim rej Kejbarok Joñan Emmon in Jerbal**
- Kōjerbal jibañ in jāān** wōt ñan wia mōñā ñan armij ro ilo mweo imōm.
- Kōjerbal jāān in jibañ** wōt ñan jibañ armij ro ilo mweo imōm.
- Kwōj aikuj lelok Social Security Numbers (Nomba in Social Security ko, SSN)** ko ak peba in immigration an armij ro wōt rej kateruru ñan jibañ. Ñe kwōnaj kelet in jab lelok SSN ko ak peba in immigration ñan armij ro ilo mweo rejab kateruru, aoleb kolla ko an armij ro ilo mweo im mennin jibañ ko rej bōki renaj aikuj wōt kamool, elañe aikuj, ñan lale ñe remaron töbrak ñan jibañ.

Maron ko Am (Jej Aikuj)

- Bōk juon ablikajon** ebed etam, atorej, im Jain in etam ak etan armij eo emōj kōmelim an jutak ikijem.
- Jibañ kwe kanne peba in DSHS ko.**
- Kōmadmōde kajjitök** eo am ñan jibañ in mōñā iloan 7 raan elañe kwōmaron töbrak ñan jibañ eo emokaj lok.
- Lewaj juon rijit** ñe kwōnaj kajjitök juon ilo ien am letok peba ko.
- Lewaj jemlok eo ilo jeje, ilo elōñ wāween ko, iloan 30 raan.
- Kwōmaron makoko in kenono ñan juon rietale jen Fraud Early Detection (Madmōdin Jerbal ñan lale ñe ewōr koot, FRED)** jen Office of Fraud and Accountability (Opij eo ej bōk eddoin kakien ko rej kejbarok jen koot im lale Jimwe in Jerbal). Kwōjab aikuj kadeloñ rietale eo ñan iloan mweo imōm. Kwōmaron kajjitök an rietale eo bar rool waj ñan mweo imōm ilo bar juon ien. Mennin ebañ kakkure am maron töbrak in ebōk jibañ.
- Kwōmaron kajjitöke juon kōmadmōdin ien roñjak** ñe kwōjab errā kin jemlok eo an opij kin kej eo aō. Kwōmaron bar kajjitök an juon supervisor ak rikōmadmōd etale jemlok ak makütük eo emōj jumae ilo an jab kakkure maron ko am ñan juon kōmadmōdin ien roñjak.
- Kim aikuj kōjellaik kwe kin** kin kakien eo kin joñan jemlok eo ej 60 allōñ iomwin burokraam eo an Temporary Assistance for Needy Families (Jibañ an Jidik len ñan Baamle ro rej Aikuj, TANF). Joñan jemlok in ien eo ejab jerbal ñan Mōñā Basic eo am, ak wonnen lale ajiri.

Melele ko Kwōj Aikuj Jeāā kin Kaat in EBT eo m

- Bōd Kōjerbal Jibañ in Jāān:** Jibañ in mōñā im jāān ko rej ajej ilo kaat in EBT renaj lelok melele kin jikin ko kwar wia im kōjerbal jibañ ko am ñan DSHS. Opij eo enaj kōjerbal melele in wia ko ilo etale ko kin an bōd kōjerbal jibañ in jāān ak jañiji jibañ in mōñā ñan jāān ak bar jet mweiuk ko ewōr joñan aer aurok (wia kake).
- Kōkkāāl kaat in EBT:** Kim maron lewaj wonnen an kōkkāāl kaat in EBT ko. Kejbarok kaat in EBT eo am im personal identification number (nomba eo ej kalikar kwe make, PIN) ilo juon jikin eo ewōr kejbarok im ekon.
- Kaat in EBT ko Elab Joñan Pelan:** Ñe kwōjab kōjerbal jibañ ko am iomwin allōñ ilo juon wōt ien ak koba peba ko relab joñan ālikin elōñ allōñ ko, kim maron kebaak kwe ñan etale wāween eo am ak aikuj eo am ñan jibañ ko.

Melele ko Kwōj Aikuj Jelā (Mōñā Basic)

- **Kim ej jilkinlok melele** kin armij ro rej kateruru ñan Mōñā Basic ñan opij ko jet an Federal ñan lale ñe ejimwe melele ko. Ñe jabdewōt melele ebōd, armij ro rej kateruru remaron jab ebōk Mōñā Basic. Ñe juon armij enaj lelok melele eo rejelā ejab jimwe, remaron ioone kaje ko kin ruprup kakien. Kaje ko kin am jelā ilo am rup kakien ko an Mōñā Basic oktak jen am jab tōbrak ñan burokraam eo, ñan bakkin ko, ak emaron kalbuj.
- **Ñe kwōnaj wia kake, kajeoñ in wia kake, jañij, ak aje jibañ in mōñā eo am** ñan jabdewōt men eo ewōr joñan an aurok einwōt jāän, wúno kajur, kein uror, ak jabdewōt mweiuk eo ejab mōñā jen juon jikin eo emōj kōmelim an wia kake mweiuk (wia kake), kwōmaron jab tōbrak jen am ebōk jibañ in mōñā ñan juon ien eo edik tata ej juon iiō lok ñan labtata eo ej aoleben ien am mour im jab tōbrak jen bōd eo kein kajuon. Am jab maron tōbrak enaj woñmaanlok jekdoon kwōnaj emaküt jen State eo an Washington im kateruru ñan jibañ ko ilo bar juon state.
- **Ñe kwōj aikuj bōk kwōnaam ilo mennin aikuj ko ikiken jerbal ñan Mōñā Basic**, im likjab in bōk kwōnaam, kwōmaron jab tōbrak iomwin juon allōñ im mae ien kwōnaj loor mennin aikuj ko ikiken jerbal ñan likjab eo kein kajuon; jilu allōñ im mae ien kwōnaj loor mennin aikuj ko ñan likjab eo kein karuo; im jiljino allōñ im mae ien kwōnaj loor mennin aikuj ñan ien eo kein kajilu im kajojo ien tokelik.

Melele ko Kwōj Aikuj Jelā (Jāän)

- **Ilo am ebōk Temporary Assistance for Needy Families (Jibañ an Jidik len ñan Baamle ko rej Aikuj, TANF)** kwōj lelok maron ko am ñan jibañ eo ikiken ajiri im armij eo belem ñan Division of Child Support (Opij eo ej bōk eddoin kakien ko rej kejbarok wonnen lale ajiri). Melelein mennin ke DCS emaron kejbarok jibañ eo remuri ñan kwe, lok ñan joñan jibañ in kien eo kwar bōke. **Kwōj aikuj kaju ba ñan DCS elañe kwar ebōk kolla ak jibañ kin jibañ in lale ajiri ñan ajiri** eo ilo ien am ebōk TANF.
- **Ñe ebōjrap am ebōk TANF** kwōj aikuj ba ñan DCS kin jabdewōt oktak ko rej ukōte jibañ eo ñan lale ajiri, einwōt an ajiri eo emaküt ak oktak atorej eo aō.
- **Ñe kwōj ebōk TANF, kwōmaron kajjitōk lablok in jāän** ñan jibañ kolla wonnen imōn jokwe ko an kōtāän im idin ien.
