### Developmental Disabilities Administration Who might be eligible for services?

#### RCW 71A.10.020

(4) "Developmental disability" means a disability attributable to intellectual disability, cerebral palsy, epilepsy, autism, or another neurological or other condition of an individual found by the secretary to be closely related to an intellectual disability or to require treatment similar to that required for individuals with intellectual disabilities, which disability originates before the individual attains age eighteen, which has continued or can be expected to continue indefinitely, and which constitutes a substantial limitation to the individual. By January 1, 1989, the department shall promulgate rules which define neurological or other conditions in a way that is not limited to intelligence quotient scores as the sole determinant of these conditions, and notify the legislature of this action.



If DDA determines that you are eligible to be a client of DDA, your access to services as a DDA client depends on your meeting eligibility requirements for the specific service. DDA paid services are described in WAC 388-825-057.

### Who might be eligible for services?


- All services are not entitlements.



We support families by providing respite, therapies, community guides, personal agents, and information and education to help families remain as primary care givers.



### Home and Community Based Services Waivers

Under Section 1915 (c) of the Federal Social Security Act, states are permitted to request a *waiver* of their Medicaid state plans.

The waiver allows states to offer additional services and supports, not available under the state plan, which enable individuals to live in the community rather than in institutional settings.

These waivers are called **Home and Community Based Services (HCBS) Waivers** by the federal government and are administered by the Center for Medicaid Services (CMS).

Participants in federal waiver programs must meet an *institutional level of care* and *choose to live in the community* rather than an institution.

States must assure that the cost of waiver services will not exceed the cost of institutional services.

#### There are currently five DDA HCBS Waivers:

- **Basic Plus**: Supports individuals who require waiver services to meet their assessed health and welfare needs in the community. This can be provided in their own home, and Adult Family Home or Adult Residential Center.
- **Core:** Offers residential options to individuals at immediate risk of out-of-home placement. Individuals have an identified health and welfare need for services that cannot be met by the Basic Plus Waiver.
- **Community Protection:** Offers therapeutic residential support for individuals who have been assessed to require 24-hour, on-site staff supervision to ensure the safety of others.
- Children's Intensive In Home Behavior Supports: Supports youth at risk due to challenging behaviors. The CIIBS model involves wraparound planning and family-centered positive behavior support.
- **Individual and Family Services:** Is a budget based program with annual allocations ranging from \$1200 to \$3600 per year to support individuals living their family home.

#### **Legislative Direction for CFCO - Savings**

#### **HB 2746 Refinance Medicaid Personal Care**

- 56% federal match (currently 50%).
- Will create state savings reserved for potential investments.

### SB 6387 Specific investments in developmental disabilities services

- 4,000 more served by new Individual and Family Support waiver; and
- 1,000 more served by Basic Plus waiver by June 2017.

### What is the Community First Choice Option?

A new optional Medicaid state plan option established by the Affordable Care Act (ACA) that allows states to receive an additional six percent on their current federal match for approved services and provides more flexibility to clients
