Questions & Answers

Question	Answer
Should the hour block on the SNTL equal to 60 minutes maximum?	That is correct. Please refer to the times listed on the top of the PDN skilled nursing task log. You will notice that they are aligned by hour increments, i.e. 8 – 8:59 AM, 9 – 9:59 AM, etc. You will document your time of providing care in the corresponding column.
There has been difficulty reaching case managers. What should we do?	Please make attempts via telephone and e-mail. Allow for appropriate turn around. Please make more than one attempt. If still no response, please reach out to their supervisor. Also, consider speaking with them about how to communicate to ensure client care needs are being met. Please follow your judgement for additional ideas.
Can we fill out more than one SNTL per day if there are multiple providers?	Yes.
PDN providers are performing case management tasks. How do we document this?	There is a blank place on the log you may include this. However, I would encourage you to work with your client's NCC.
