CE Requirements for LTC Workers



CE Requirements for Long Term Care Workers

WAC 388-112A-0611

LTC workers required to complete CE must have 12 hours of continuing education by their <u>birthday</u> each year:

- Certified Home Care Aides (HCA)
- A long-term care worker who is exempt from the seventy-hour long-term care worker basic training under WAC <u>388-112A-0090(1)</u> and (2)
- Certified Nursing Assistants (NAC)
- Persons with an OSPI Special Education endorsement
- Assisted living facility administrators or the administrator designee

Only courses approved by DSHS may be used to fulfill the CE requirements!

Approved DSHS continuing education courses will have an approval code:

CE Requirements for Long Term Care Workers

WAC 388-112A-0600

CE topics might include:

- Personal care services
- Mental illness
- Dementia
- Depression
- Communication skills
- Positive resident behavior support
- Developing or improving resident centered activities
- Dealing with wandering or aggressive resident behaviors
- De-escalating challenging behaviors
- Medical conditions



CE Requirements for Long Term Care Workers

Some topics can be repeated up to 5 hours/year:

- Bloodborne pathogens and infection control
- CPR training
- First-aid training
- Food handling training
- Health insurance portability and accountability act (HIPAA)
- Medication assistance
- Disaster preparedness
- Aging sensitivity
- Resident rights as it relates to caregiving issues
- Resident safety
- Abuse and neglect identification and mandatory reporting
- Topics where the provider can demonstrate a need for retraining

Getting Your Own Continuing Education Approved

Facility and Community Instructors with approved training programs may create their own continuing education courses!

- Courses must align with the CE topics outlined in WAC 388-112A-0600
- Application is made using the <u>DSHS Curriculum Approval Application</u>
- Online courses must meet the <u>ALTSA Online Training Standards</u>
- No more than 12 course hours can be submitted on one application




Updated Emergency Rules Related to Continuing Education

Updated <u>emergency rules</u> went into effect on April 6, 2022 Allowing additional time for workers to complete continuing education requirements

RCW 74.39A.074: Training requirements for LTCW - Rules

(4) If a pandemic, natural disaster, or other declared state of emergency impacts the ability of long-term care workers to complete training as required by this section, the department may adopt rules to allow long-term care workers additional time to complete the training requirements.

COVID 19 Training Challenges

Limited long term care workers' ability to complete continuing education classes

Continuing Education Emergency Rule

For any additional hours beyond the 12 granted that became due while training waivers were in place:

- Workers have until December 31, 2022, or 120 days from the end of the COVID-19 training waivers established by gubernatorial proclamation, whichever is later.
- If a worker's next birthday allows fewer than 120 days after the waivers are lifted to complete required CE for their **current renewal cycle**, the worker will have 120 days from the end of training waivers to complete the required CE.

Emergency Rules Extended for Home Care Aide Training and Certification



Updated <u>emergency rules</u> went into effect on April 6, 2022

- The runway for both HCA certification and specialty training deadlines have been extended
- An additional cohort was added for workers recently hired

Updated *Training* **Deadlines** to include specialty training:

10/1/2020 to 4/30/2021	1/31/2023

10/1/2022 - 12/31/2022 or the end of the COVID-19 training waivers established by gubernatorial proclamation, whichever is later	9/30/2023 or within 120 days after the end of the COVID-19 training waivers established by gubernatorial proclamation, whichever is later

4/1/2022 to 9/30/2022	11/19/2023
10/1/2022 - 12/31/2022 or the end of the COVID-19 training waivers established by gubernatorial proclamation, whichever is later	12/19/2023 or within 200 days after the end of the COVID-19 training waivers established by gubernatorial proclamation, whichever is later
After the end of the COVID-19 training waivers established by gubernatorial proclamation or beginning 1/1/2023, whichever is later	Standard training

Standard Training Requirements

Within 14 days of hire

- Submit WA State DOH's HCA Application Packet.
- Register for 70-hour long-term care worker basic training.


Within 120 days of hire

• Caregiver must complete the 75 hours of long-term care worker training.

Within 200 days of hire

- Caregiver must successfully complete Prometric Testing and have active credential.
- **Or**, if a long-term care worker is limited-English proficient <u>and</u> the Department of Health has issued them a provisional certification, caregiver must successfully complete Prometric Testing within 260 days of hire.

Application Process for Community Instructors and Facility Training Programs



Instructor Qualifications

All instructors must:

- Be 21 years of age.
- Have **not** had a professional health care or social services license or certification revoked in Washington state.
- **Must** meet the instructor qualifications for DSHS approval including work experience, teaching experience, and any pre-requisite courses or documentation.
- Review the DSHS <u>Community Instructor Qualification Requirements</u>
- Review the DSHS <u>Facility Instructor Qualification Requirements</u>

 - Core Basic Training
 - Population-Specific
 - Specialty Courses (Dementia, Mental Health
 - On-The-Job 75 Home Care Aide Certification

Application Process & Forms For Community Instructors

- Complete and submit a Contractor Intake Form (DSHS 27-043) with a copy of your business license
- Complete a Community Instructor Training Program Application and Updates form (DSHS 15-551)
 - This form tells DSHS what courses, instructors, and curriculum you want to use
 - Establish a new training program
 - Add or remove instructors
 - Request approval for curriculum
- Complete a Community Instructor Application (DSHS 15-550) to teach:
 - Core Basic
 - Population Specific
 - Nurse Delegation Core
 - Nurse Delegation Diabetes
 - Dementia Specialty Training
 - Mental Health Specialty Training




