#### WA CARES – INVESTMENT PLAN OVERVIEW



- Our goal is to include the most advantageous implementable investment program permitted under the law
- We expect to develop a dedicated investment portfolio specific to WA Cares because of the unique characteristics involving limited available investment types combined with a long program duration
  - It will not be an off-the-shelf solution
- Due to the constraints specified in the state constitution, defining available investments will require research, and that phase is currently underway
- As with all our investment programs, our mission is to maximize return within prudent levels of risk, for the exclusive benefit of our stakeholders and beneficiaries

We have established a working team and clear strategic goal for the plan:

- Our team has started the onboarding process including account setup, performance preparation, asset allocation and compliance monitoring
- The investment team will prepare a proposed investment policy which will be based on actuarial studies, program expectations, permissible investments, implementation considerations, and legal parameters that apply to the account







#### WA CARES – CURRENT STATUS AND NEXT STEPS

We will currently be limited to a single asset class – fixed income

- The exclusion of equity investments will limit expected return for the program
- The wider the of range of possible investments within the class, the better equipped we can be to satisfy the performance and diversification needs of the program
- Research into permissible fixed income investments and implementation methods is underway and will be completed during the fall
- A proposed investment policy will be drafted once the permissible range of investments is identified
- Updates will be provided to this subcommittee in advance of consideration of the investment policy by the WSIB board

#### **Update timing**

- While research into the permissible investment question is underway, we do not have a definitive completion date
- WSIB staff will provide WA Cares and OSA staff interim updates as the plan is developed during Q4
- WA Cares staff can identify the appropriate timing for the next committee update
