

# **MAXKAMADDA SARE EE DEGMADA THURSTON**

*Liang, et al. v. State of Washington Dep't of Social & Health Services (DSHS), et al.*

Haddii aad tahay ama aad ahayd Ade eg-bixiye Shaksi ah (IP) oo daryeel shakhsiyeed u fidiye y daryeel shakhsiyeed macaamii saacadahooda daryeelka ee lactooda la bixiyay ay yare ysay waaxda DSHS taas oo sabab u ah xeerarka "dheefta la wadaago", waxaad lacag-bixin ka heli kartaa maslaxo dacwadeed uu qof ama koox ay maxkamad geeyeen iyagoo ku hadlaya afkooda iyo afka ciddii kale ee ay khuseyso.

*Maxkamad ayaa oggolaatey ogeysiiskan. Kani ma ahan weyddiisasho ka timid qareen.*

Maslaxada waxay bixin doontaa \$116 milyan oo lagu bixinayo xaq-sheegashooyinka Aeg Bixiyeasa ha Shakhsiga ah (IPs) kuwaas oo daryeel shakhsiyeed u fidhiyey macaamiisha saacadahooda daryeelka ee lacagta lagu bixiyo ay yareysay waaxda DSHS taas oo sabab u ah xeerarka "dheefta la wadaago" ee DSHS inta u dhaxeyso 7-da Maarsa, 2014 iyo 28-ka Febraayo, 2021.

Maslaxadu waxay xallin doontaa dacwadda ku saabsan haddii IPs-yada loo diidey dhammaan magdhowga saacadaha ay shaqeeyeen iyadoo sabab u ah xeerarka dheefta la wadaago; uu lacago siyo IPs; ka fogaado halisaha sii wadista dacwadda; lacago siyo IPs-yada adiga oo kale ah; oo ka siidaayo/qaad DSHS iyo eedaysanayaasha kale mas'uuliyadda.

## **MACLUUMAADKA AASAASIGA AH**

### **1. Maxay tahay sababta aan u helay ogeysiiskan?**

Sababta aad ogeysiiskan u heshay waxay tahay in diiwaannada Waaxda Adeegyada Caafimaadka iyo Bulshada (DSHS) ee Washington ay muujinayaan in aad tahay ama aad ahayd Bixiye Shakhsii ah (IP) oo ay qandaraas la gashey waaxda DSHS waqtii dhaxeeyaa 7-da Maarsu, 2014, iyo 28-ka Febraayo, 2021, si aad adeegyada daryeelka shakhsiyeed ugu fidiso macmiil saacadadiisa daryeelka ee la bixiyay la yareeyay iyadoo sabab u ah in DSHS y ku summadeysay xaaladda macmiilkaa ee qiimeynata CARE sida “dheefta la wadaago” ee ugu yaraan hal hawl.

Maxkamaddu waxay amartey in ogeysiiskan laguu soo diro iyadoo sabab u ah in aad xaq u leedahay in aad wax ka oggato maslaxada la soo jeediyyay iyo xuquuqahaaga sharci iyo ikhtiyaarada ka hor inta aysan Maxkamaddu go'aamin haddii maslaxada la ansaxinayo iyo haddii kale. Dacwadda waxaa loo yaqaannaa *Liang, et al. v. State of Washington, et al.*, Lr. 20-2-02506-34; waxayna ka socoota Maxkamadda Sare ee Washington ee Degmada Thurston; waxaanna keenay IPs-yada qaar (oo ogeysiiskan loogugu yeerayo “Dacwoodayaal”) oo ka soo horjeeda Gobolka Washington, DSHS, iyo Xoghayaha DSHS (oo ogeysiiskan wadajirkooda loogugu yeerayo “DSHS”).

### **2. Dacwaddan maxay ku saabsan tahay?**

Dacwoodayaasha waxay ku dacwoonayaan in laga bilaabo 7-da Maarsu, 2014, ilaa 28-ka Febraayo, 2021, DSHS in aysan IPs-yada qaar siin dhammaan ujuurooyinkii ay ku lahaayeen. Dacwoodayaashu waxay sheegeen in ay tani dhacdey markii DSHS ay yareysay saacadaha daryeelka lacagta lagu qaato iyadoo sabab u ah in ay oggaatey in IP-ga iyo macmiilkaa, ama macaamiil badan oo isku guri ka tirsan, in ay wadaageen dheefta hawlahaa daryeelka shakhsiyeed qaarkood ee uu qbtey IP-ga, sida cunto karinta, dukaameysiga, shaqada guriga, ama keenista alwaaxa. Dacwaddu waxay raadinaysaa dib u bixinta mushaarka iyo khasaaraha lacageed kale ee waafaqsan qandaraaska dowladda iyo sharciga ujuurooyinka ee shaqada Dacwoodayaasha ay sheeganayaan in IPs-yada ay ka shaqeeyaan mushaarr la'aan.

DSHS waxay diiday in ay ku xadgudubtey wax sharchiyo ah amaba in ay sameysay wax khalad ah.

### **3. Maxay tahay maslaxo dacwadeed uu qofama koox ay maxkamad geeyeen iyagoo ku hadlaya afkooda iyo afka ciddii kale ee ay khuseyso?**

Dacwadda uu qofama koox ay maxkamadda geyso waa nooc ka mid ah dacwadaha taasoo dacwoodayaasha la sheegay ay u dacwoonayaan nafsadooda iyo sidoo kale dadka kale ee ay isku xaaladda ku sugar yihiin. Kiiskan, Dacwoodayaasha waa saddex IPs-yo, Sylvia Liang, Manuel Brito, iyo Shazia Anwar. IPs-yada kale waxaa loo yaqaannaa “xubnaha dacwadda.” Dacwadda, hal maxkamad ayaa xallinaysa arrimaha dhammaan xubnaha dacwadda, marka laga reebo kuwa nafsad ahaantooda iska reeba dacwadda.

Maxkamadda waxay u aqoonsatey kiiskan in uu yahay dacwad loogu talagalay ujeeddooyinka maslaxada la soo jeediyyey. Maxkamaddu ma go'aamin haddii kiiskan ay tahay in loo aqoonsado dacwad loogu talagalay ujeeddooyinka go'aaminta mudhaanaha sheegashooyinka Dacwoodayaasha. Haddii Maxkamaddu aysan oggolaan ansaxinta kama dambeysta ah ee maslaxada sabab kastaba ha noqotee, ma jiri doonno heshiis maslaxo ah oo dhinacyadu waxay dib ugu noqon doonnaan dacweynta ama sii wadista dacwadda kiiska. IPs-yada ay khuseyso maslaxada waxaa loo yaqaannaa “Xubnaha Maslaxada Dacwadda,” marka laga reebo kuwa nafsad ahaantooda iska reeba maslaxada dacwadda.

### **4. Maxay tahay sababta ay maslaxo u jirto?**

Labada dhinacba waxay aaminsan yihiin in ay maxkamadda ku guuleysan doonnaan, laakiin maxkamaddu xukun ma gaarin iyadoo u daneynaysa dhinacyada midkood. Labada dhinacba waxay wada oggolaadeen maslaxo si looga fogaado kharashaadyada, dib-u-dhacyada, halisaha, iyo hubid la'aanta lala xirriinayo qaadista dacwadaha iyo rafcaannada. Waxay sidaa sameeyeen ka-dib baaritaan qoto-dheer iyo macluumaad isdhaafsi. Xubnaha Dacwadda Maslaxada ee xaqa u leh xisaabinta lagu qeexay Qaybta 10aad ee hoose waxay helayaan magdhow.

Dacwoodayaasha iyo qareennadooda (Qareenka Dacwadda) waxay u maleynayaan in maslaxadu ay ku jirto danaha ugu wanaagsan ee dhammaan Xubnaha Maslaxada iyo in shuruudaha maslaxadu ay yihiin kuwo cadaalad ah, macquul ah, oo dad ku filan.

## KUMAA KU JIRAMASLAXADA?

### 5. Kumaa qayb ka ah dacwadda maslaxada?

Dacwadda maslaxada waxaa lagu qeexay sidan: "dhammaan IPs-yada hadda iyo kuwii hore ee qandaraaska la galey DSHS si ay u bixiyaan adeegyada daryeelka shakhsiyed ee macmiilka saacadahiisa daryeelka guriga gudahiisa la yareeyay iyadoo sabab u ah in DSHS, oo wakiiladeeda loo marayo, in ay ugu summadeysay macluumadka qiimeyn ta DARYEELKA in uu leeyahay Xaaladda 'dheefta la wadaago' iyadoo la eegayo hal ama in ka badan oo ah IADLs."

### 6. Miyaan qayb ka ahay dacwadda maslaxada?

Haa, haddii aad iska reebto naftaada adiga oo ka baxaya mooyaane (eeg Qaybaha 15–16). Sababta aad u helaysa ogeysiiskan waa in diiwaannada DSHS ay muujinayaan inaad ugu yaraan u shaqeyssay hal macmiilkaas oo saacadahiisa daryeelka idman la yareeyay intii lagu guda jirey Muddada Dacwadda sababta oo ah DSHS waxay ku summadeysay "xaaladda" macmiilka ee qiimeyn ta DARYEELKA sidda "dheefta la wadaago" ugu yaraan hal hawl oo daryeel shakhsiyed ah.

### 7. Ka waran haddii aanan ogeysiiska si toos ah u helin, laakiins e aan u maleeyo in aan ahay xubin ka tirsan dacwadda maslaxada?

Haddii aadan si toos ah u helin ogeysiiskan laakiinse aad u maleynayso inaad u shaqeyssay macmiilka DSHS kaas oo saacadahiisa daryeelka shakhsiyed ee idman la yareeyay intii lagu guda jirey Muddada Dacwadda iyadoo sabab u ah in DSHS ay ku qiimeysay in macmiilku uu lahaa "dheefta la wadaago", fadlan kala xiriir maamulaha dacwadda 888-964-0102.

## DHEEFAHA MASLAXADA—WAXA AAD HELAYSO

### 8. Maslaxadu maxay bixinaysaa?

DSHS waxay oggolaatey in ay bixiso lacag dhan \$116,068,000, taas oo loo adeegsan doonno in lagu bixiyo lacag-bixinnda la siinayo Xubnaha Dacwadda Maslaxada, DSHS iyo IPs-yada waxay wadaagayaan canshuuraha mushaaraadka, kharashka iyo ujuurrooyinka qareennada Dacwadada, kharashka maamulka maslaxada iyo ogeysiiska, iyo, haddii ay ku habboon tahay, lacagaha khidmadaha ururka shaqaalaha.

### 9. Immisa ayay noqoneysaa lacag-bixinteyda?

Lacag-bixintaada la qiyaasey waa [FILL IN]. Sida dhammaan Xubnaha Dacwadda Maslaxada, lacag-bixintaada gaarka ah waa saamigalka saamiga maslaxada oo ku saleysan tirada saacadaha Dacwoodayaasha ay sheeganayaan inaad mushaar la'aan shaqeyssay inta lagu guda jiro Muddada Dacwadda iyo qiimaha mushaarka ku habboon saacadahaasi.

### 10. Sidee loo xisaabiyye lacag-bixinteyda?

Dhinacyadu waxay ku heshiyeen hab lagu xisaabinayo lacag-bixinnda Xubin kasta oo ka tirsan Dacwadda Maslaxada, shakhsii ahaan, iyadoo lagu saleynayo xogta ku jirta diiwaannada DSHS. Xogtu waxay muujineysaa macaamiisha DSHS qiimeysay in ay leeyihii "dheefta la wadaago," IPs-yada daryeelka u fidiyey macaamiishaasi, inta saacadood ee la oggolaadey ee la yareeyay oo aan lacagtooda la bixin iyadoo sabab u ah summadeysa xaaladda "dheefta la wadaago", adeeg-bixiyeyaasha lacagta la siiyey ee loo qoondeeyay hawlah "dheefta la wadaago", iyo inta Dowladdu siisey adeeg bixiyeyaashaasi.

Saamigaaga la qiyaasey ee maslaxada ayaa waxaa la xisaabiyye iyadoo loo qaybinayo lacagta la qiyaasey in laguu soo celinayo wadarta guud ee lacagaha loo celinayo dhammaan Xubnaha Dacwadda Maslaxada, iyadoo ka-dibna qaddarkaasi lagu dhufanayo \$105 milyan. \$105 milyan waa wadarta guud ee maaliyadda maslaxada oo laga jarey qaddarrada la hayo si loogu bixiyo saamiga DSHS ee canshuuraha msuhaaraadka, kharashka iyo ujuurrooyinka qareenka Dacwadda, maamulka maslaxada iyo kharashka ogeysiiska dacwadda, iyo kharashka

kale. Lacagaha dib loo bixinayo ee loogu talagalay xisaabintan waa tirada saacadaha aan lacagtooda la bixin ee sababta u ah "dheefta la wadaago" marka lagu dhufsto qiiimaha mushaarka lagu dabakhi karo (oo ku jiro waqtiga dheeraadka ah, halka ku habboon), iyadoo aanan la labalaabin khasaaraha ama dulsarka. Haddii adeeg-bixiyeyaaal u khidmeeya isla hal macmiil ay taabato "dheefta la wadaago" isla hal bil, saacadaha aan lacagahooda la bixin ayaa si saamigal ah loogu qaybin doonaa.

Haddii xubnaha kale ee dacwadda aysan lacageysan jeeggagooda ama kharashka kale ee maslaxadu uu ka yar yahay inta la qiyaasey, waxaad heli kartaa ilaa laba lacag-bixinno oo dheeraad ah oo noqon doonnaa saamigaaga saamigalka ah ee inta ka harsan guud ahaan maaliyadda maslaxada, oo lagu darey dulsarka ku soo kordhay maaliyadda.

### **11. Maxay tahay sababta lacag-bixinte yda la qiyaasey ay uga badan tahay ama uga yar tahay lacag-bixinta qof kale?**

Maaliyadda maslaxada ayaa waxaa loo qoondeeyay Xubnaha Dacwadda Maslaxada iyadoo lagu saleynayo saamigalka boqolleyda maaliyadda, iyadoo la tixgelinayo khasaaraha shakhsiyed ee la qiyaasey ee IP kasta sida qayb ka mid ah khasaaraha guud. Qaddarada maslaxada shakhsiga way kala duwanaan doonnaan iyadoo lagu saleynayo arrimaha sida muddada waqtiga IP-ga uu shaqeeeyay inta u dhaxeysa 7-da Maarsa, 2014, iyo 28-ka Febraayo, 2021, tirada saacadaha daryeelka laga soo yareeyay saacadaha la oggolaadey ee sababta u ah "dheefta la wadaago" (taas oo aad u kala duwanaan karta oo ku xiran saacadaha daryeelka guud ee macmiilka iyo inta "dheefta la wadaago" ee ay DSHS go'aamisey in ay jireen), qiiimaha ujuurrada IP, iyo haddii qiiimahaasha waqtiga dheeraadka ah lagu dabakhi karo.

### **12. Maxay tahay sababta looga yaabo in uu eber noqdo saamigeyga la qiyaasey?**

Waxaa laga yaabaa in aad noqoto Xubin Ka Tirsan Dacwadda Maslaxada laakiinse aadan wax lacag ah ku lahayn haddii diiwaannada DSHS ay muujinayaan in adeeg-bixiyeyaaal kale, oo aan adiga ahayn, in loo qoondeeyay hawlah "dheefta la wadaago" ee qorshaha daryeelka macmiilka, haddii DSHS aysan dooran "dheefta la wadaago" sida "xaaladda" macmiilka, ama haddii DSHS ay qiimeysay dheefta la wadaago oo ka baxsan Muddada Dacwadda.

### **13. Waa maxay shuruudaha kale ee muhiimka ah ee maslaxada?**

**Xaqiijin:** Marka aad lacageysato ama banki ku shubato lacag-bixintaada maslaxada, waxaad xaqiijineysaa in:

1. Aad tahay ama ahayd IP-ga macmiil oggolaanshaha adeegyada daryeekiisa shakhsiyeed ee guriga ee bilaha ah la yareeyay iyadoo sabab u ah "dheefaha la wadaago" ee aad bixisay;
2. Waxaad bixisay adeegyada daryeelka shakhsiyeed ee guriga gudahiisa macmiilkaasi oo lagu darey qorshaha daryeelka macmiilka ugu yaraan tirada dheefta la wadaago ee la waafajiyey saacadaha lagu muujiyey xogta DSHS, bil iyo sannad ahaan, ee loo adeegsadey in lagu xisaabiyo saamigaaga maaliyadda maslaxada (saacadahan ayaa lagu qorey bogga 9aad ee ogeysiiskan); iyo
3. Laguma siin lacagaha adeegyadaasi.

**Dib-u-qaybin:** Haddii aadan lacageysan ama bankiga ku shuban lacag-bixinta maslaxada, saamigaaga (iyo dulsaar kasta ee ku soo kordhay) waxaa dib loogu qaybin doonaa Xubnaha Kale ee Dacwadda Maslaxada. Si la mid ah, haddii Xubnaha Kale ee Dacwadda Maslaxada aysan lacageysan jeeggagooda, saamiyadooda waxaa dib loogu qaybin doonaa xubnaha kale ee dacwadda maslaxada (oo aad adiga ka mid tahay, haddii aadan ka bixin). Waxaa jiri doonna laba dib-u-qaybin. Lacag-bixinno kasta ee aanan la lacageysan ka-dib dib-u-qaybinta labaad waxaa dib loogu celin doonaa Dowladda gobolka.

**Canshuuraha Mushaaraadka:** Lacag-bixintaada maslaxada waa mushaaraad ay sheeganayaan shaqaale sidaa daraadeed waxaa ku waajiba canshuuraha mushaaraadka iyo dakhliga ee ku habboon. Maamulaha maslaxada ayaa qaddaradaasi lacagta ah ugu wargelin doonna hay'adda IRS foomka W-2.

**Khidmadaha Ururka Shaqaalaha:** Haddii aad hadda tahay xubin ka tirsan SEIU 775, ama aad ahayd xubin ka tirsan markii ugu dambeysay oo aad mushaar ku qaadatey IP ahaan, maamulaka maslaxada ayaa ka jari doonno 3.2% lacag-bixintaada ee bilaha aad ahayd xubinka ka tirsan ururka SEIU 775 wuxuunna lacagtaasi u diri doonaa ururka shaqaalaha.

**Shuruudaha Maslaxada:** Maslaxadu waxay ugu baahan tahay hay'adda federaalka ee maamusha Medicaid in ay xaqiijiso in ay bixin doonto maaliyadaha federaalka ee waafaqsan dhammaan lacag-bixinnada maslaxada. Waxay xaqiijintaasi bixisay bishii Disembar 2021. Waxay kaloo u baahnayd in Golaha Sharci-dejinta Washington uu si buuxda u maalgeliyo maslaxada. Golaha Sharci-dejinta ayaa sidaa sameeyay bishii Maarso 2022, Guddoomiyaha gobolkana wuxuu miisaaniyadda saxiisay 31-ka Maarso, 2022.

**Ka-bixidyada:** Haddii in ka badan 3% ee xubnaha dacwadda ay go'aasadaan in ay ka baxaan maslaxada, DSHS waxay maslaxada ka dhigi kartaa mid aanan waxba ka jirin.

#### **14. Waa maxay saameynta ay leedahay ku sii jiridda dacwadda maslaxada?**

Haddii aad iska reebo mooyaane (sida lagu sharxay Qaybta 15aad ee hoose), waxaad ku sii jiri doontaa dacwadda maslaxada. Maxkamaddu waxay joojin doontaa kiiska "iyadoo aan mar kale dacwadiisa loo soo gudbin karin" haddii an maslaxadu ansaxiso. Haddii ay sidaa sameyso, sheegashooyin kasta ee laga yaabo ama lagu sheegtay dacwaddan, oo aad adiga ka mid tahay, si joogto ah ayaa loo joojin doonaa.
