## ALTSA: NH Rates #2020-007 RE: JANUARY 1, 2021 ADJUSTED MEDICAID PAYMENT RATE

Dear Nursing Facility Administrator:

The January 1, 2021 Medicaid payment rate for your facility is attached.

The Department calculated your facility's January 1, 2021 adjusted rate using your facility's Medicaid Average Case Mix Index (with defaults) from the 2 Semiannual 2020 Final Case Mix RUG Report (4/1/2020 through 9/30/2020) MDS 3.0 RUG IV Grouper 57.

For your January 1, 2021 rate, the Department used the most recently available four-quarter average CMS quality data, which for this rate setting is Four Quarters of 2019.

An important change to note: The \$7.50 add-on related to COVID-19 is now \$8.30 and has been included in your January 1, 2021 rate.

If you wish to request an administrative review conference in relation to your January 1, 2021 rate or any subsequent adjusted rate, please keep in mind WAC 388-96-904, the regulation that controls such requests. The regulation provides in part:

- (1)...The contractor's request for administrative review shall:
- (a) Be <u>signed</u> by the contractor or by a partner, officer, or authorized employee of the contractor;
- (b) State the particular issues raised; and
- (c) Include all necessary supporting documentation or other information.

(2) After receiving a request for administrative review conference <u>that meets the</u> <u>criteria in subsection (1) of this section</u>, the Department shall schedule an administrative review conference. The conference may be conducted by telephone.

(3) At least fourteen calendar days prior to the scheduled date of the administrative review conference, the contractor must supply any additional or supporting documentation or information upon which the contractor intends to rely in presenting its case. In addition, the Department may request at any time prior to issuing a determination any documentation or information needed to decide the issues raised, and the contractor must comply with such a request within fourteen calendar days after it is received... <u>The Department shall</u> dismiss issues that cannot be decided or resolved due to a contractor's failure to

## provide requested documentation or information within the required period. (Emphasis added)

The Department will enforce this regulation in responding to requests for administrative review. Requests that are not properly signed, that do not state the issues with particularity, or that are not supported by the required documentation or information, will be denied or dismissed. Mail your appeal to the Office of Rates Management at: P.O. Box 45600, Olympia, WA 98504-5600. Do not mail your appeal to our physical address of Blake West 4450 10<sup>th</sup> Ave SE, Lacey, WA 98503. Ground carriers such as UPS and FedEx can deliver to the physical address, but <u>the Post Office will not</u>.

If proof of the date of receipt of the Department's rate notification letter exists, then that date shall be used to determine the timeliness of your request for an administrative review conference. If there is no proof of the date of receipt of the Department's rate notification letter, then you will be deemed to have received notice by January 4, 2021 in accordance with WAC 388-96-904 (1).
