ALTSA: AFH #2020-028 PERSONAL PROTECTIVE EQUIPMENT ORDERING FOR ADULT FAMILY HOMES

Dear Adult Family Home Provider:

This letter is amended in response to questions received following the initial communication and addresses the following issues:

Selecting the proper point of contact was difficult.

The instructions below now have a simpler point-of-contact list with a map to identify the proper Home and Community Services (HCS) regional office to contact. This one-time shipment will be facilitated through regional HCS offices for all adult family homes, even if they do not have a contract with HCS.

Instructions on future procurement of PPE were inaccurate.

Long-term care facilities are instructed to continue to purchase required protective equipment for their residents and staff. If they experience a shortage, they should contact their local <u>emergency management agency</u> or <u>local health jurisdiction</u>. If the local EMA/LHJ is short, facilities may request an emergency 7-day supply of PPE from Long Term Care Incident Command. *PPEWA.com is not supported as a PPE request platform for facilities.*

The Department of Social and Health Services (DSHS) will issue a one-time shipment of personal protective equipment (PPE) to all adult family homes (AFH) who place an order. Adult family homes may place one order for a fixed-quantity set of PPE. To request PPE on behalf of several homes, a corresponding number of unique orders should be placed.

Follow these instructions to place an order:

- 1. Prepare an order request form
- 2. Contact DSHS
 - Contact your HCS Regional Office via this document.
- 3. Submit your answers to the following screening questions
 - Are you caring for a client with a suspected or confirmed infection of COVID-19?
 - Have you placed an order before?
- 4. Submit the order request form to your DSHS contact.

How much PPE will adult family homes receive from this shipment?

DSHS will ship a "set" with an estimated 31-day supply of PPE to each adult family home. There are two "sets": one for facilities with a suspected/confirmed case of COVID-19, and one for facilities without reported infection. Refer to the <u>order request form</u> for the details of each set.

Long-term care facilities are instructed to continue to purchase required protective equipment for their residents and staff.
