**IMPLEMENTATION OF SENATE BILL (SB) 5672: HOME CARE AIDE CERTIFICATION
REQUIREMENTS AND EXTENSION OF DEADLINES**

Dear Administrator/Provider/Superintendent:

This Dear Provider Letter (DPL) supersedes DPLs HCLA AFH: #2025-035, ALF: #2025-033, CCRSS: #2025-018 and ESF: #2025-021.

Residential Care Services (RCS) is notifying you of an emergency rule filed by the Department of Health (DOH) on August 25, 2025, under [WSR 25-18-034 \(CR-103E\)](#), to extend Home Care Aide (HCA) deadlines for certification to 365 days as required by Senate Bill (SB) 5672.

In April 2025, the Washington State Legislature passed [Senate Bill 5672 \(SB5672\)](#). The governor approved this bill, and it became statute on May 17, 2025. The Bill requires that DOH adopt rules to allow long-term care workers additional time to become certified as HCA.

The new certification deadline is 365 days from the date of hire – an extension from the previous 200-day requirement. This emergency rule is also **retroactive** for individuals who are currently pending a HCA certification. The change is intended to provide caregivers and employers with additional flexibility and support during the certification process and aligns with ongoing efforts to reduce barriers in the long-term care workforce.

Starting August 25, 2025, any HCA applicant that applies for Home Care Aide certification or an applicant who has a current “pending application” with DOH and within their original 200 allowed days for certification) will receive 365 days from their “date of hire” to become certified as an HCA. This allowance **expires on December 31, 2027**.

How The Rules Will Be Implemented:

This means that any LTC provider that applied for HCA certification by December 31, 2027 will receive the full 365 days from the date of hire. This also applies to individuals who have had their date of hire reset*.

**Reset means when an individual is “dismissed” by their employer and rehired setting a new timeline. Meaning a hire date was “reset” after the initial 200 days had passed.*

Examples For Clarification:

Applicant is within 200 days of the date of hire and currently pending certification.	The applicant's certification timeline will be re-set to 365-days by DOH.	The applicant and employer need to do nothing. The HCA deadline will be changed to 365 days from Date of Hire.
Applicant is over 365-days since the date of hire, and currently pending certification.	The applicant's certification timeline may be re-set to 365-days if you submit a new Employment Verification Form to the department with valid re-hire date.	<p>The applicant has a PENDING application, and their original Date of Hire is over 365 days:</p> <p>An applicant that has been rehired needs to submit a new Employment Verification Form to the department with valid re-hire date.</p> <p>a) The applicant receives a NEW 365 days from the rehire date.</p> <p>NO NEW HCA APPLICATION IS REQUIRED.</p>
Applicant is no longer able to work because they are over the original 200-day certification timeline and currently pending certification.	The applicant's certification timeline is re-set to 365-days from the date of hire, so they may continue working.	<p>1. An applicant that has a PENDING application with DOH with a date of hire greater than 200 will automatically have their deadline set (by DOH) to 365 days from the original date of hire and can return to work UP TO this new deadline.</p> <p>2. Applicant applies for certification on or before December 31, 2027, with a hire date on or before December 31, 2027.	Your certification timeline will be 365-days from your date of hire.	If the applicant has submitted a Home Care Aide application to DOH on or before December 31, 2027, with a hire date on or before December 31, 2027, the applicant receives 365 days from the Date of Hire to become HCA certified.
Applicant applies for certification after December 31, 2027, regardless of the date of hire.	Your certification timeline will be 200-days from your date of hire.	If the applicant submits an HCA application to DOH AFTER 12/31/2027, they receive 200 days from the Date of Hire regardless of what the Date of Hire may be. ** For example: An applicant that has a date of hire of 12/20/2027, but their HCA application is submitted on 1/2/2028, has 200 days from 12/20/2027 to be HCA certified.

Please note: Providers who are *Limited English Proficient* may request “provisional certification” through DOH. "Limited-English proficient" means that an individual has limited ability to read,


write, or speak English. In any of the above situations LTC providers who are granted Provisional Certification by DOH will receive an additional 60 days (for a total of 425 days from the date of hire) to become certified as an HCA.

This allowance expires December 31, 2027. The statute regarding the timeframe to complete Basic Training has not changed: [RCW 74.39.074](#)
