

## RCS Instructor and Curriculum Alert

The criteria for an instructor or training program to appear on the RCS Alert includes one or more of the following: 1) training program contract terminated for default, 2) instructor issuing certificates without conducting training, 3) instructor issuing certificates for courses not approved to teach, 4) instructor conducting training after contract end date, and 5) by request of DSHS RCS.
