ALTSA: CCRSS #2015-002 CANNABIS GUIDANCE

Dear Certified Community Residential Services and Support Provider:

Many providers have expressed confusion about cannabis, also known as marijuana, because the state and federal laws around its use are conflicting. How these laws affect the individuals you provide care to can be even more confusing. RCS has been asked to provide guidance to service providers and administrators on how the use of cannabis will be regulated in settings regulated by RCS.

The use of medical and recreational cannabis is still illegal under federal regulation. Consequently, federal funds such as Medicaid, cannot be used directly or indirectly for activities or expenses related to the use of cannabis.

Since RCS receives federal funding, we are unable to issue regulatory guidance specific to cannabis use. RCS does, however, recognize that more and more individuals receiving services are accessing cannabis products through dispensaries and are frequently using it to treat the symptoms of disease. The Department of Health provides all state residents guidance around the use of cannabis for both medicinal and recreational purposes.

At this time, RCS will not cite providers for allowing clients to use cannabis as long as care providers are ensuring clients are safe and they have clear policies in place so staff and clients know what is expected.

RCS encourages providers to develop policies on cannabis even if it is not a current issue with the clients they serve. When developing policies and procedures around cannabis use, please consider the following points:

- Individuals who wish to use cannabis in smoked form need to be assessed in a manner similar to tobacco use. Please refer to applicable chapters of WAC regarding client safety and smoking.
- Cannabis, like any other substance that can be harmful, must be kept out of the reach of individuals who might endanger themselves with it. Please refer to the applicable WAC sections that address the storage of medication and chemicals.
- Keep in mind that an individual under the influence of cannabis may require additional supervision.
- If an individual is using cannabis products, the details of how the person receives it, uses it and is supervised, must be documented in their Individual Instruction and Support Plan.

RCS notes that state and federal laws and rules surrounding both medical and recreational cannabis are changing rapidly; therefore, information in this document must be supplemented with consideration of current rule, law, and code. Service providers are responsible for keeping abreast of new developments in this area.
