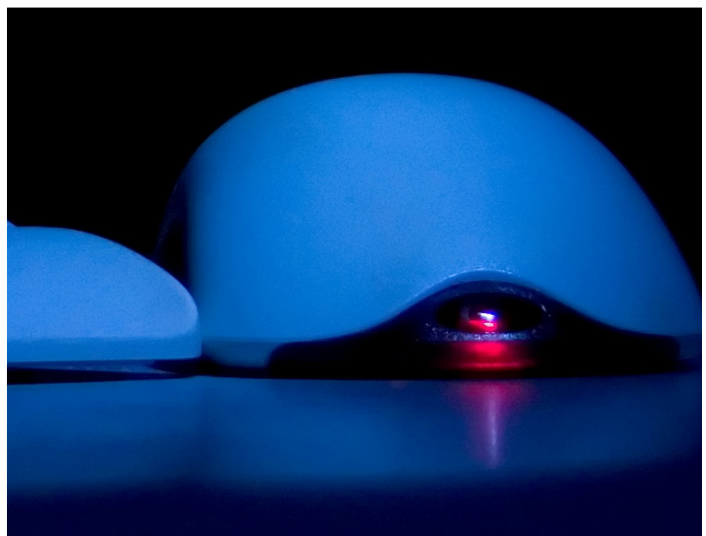
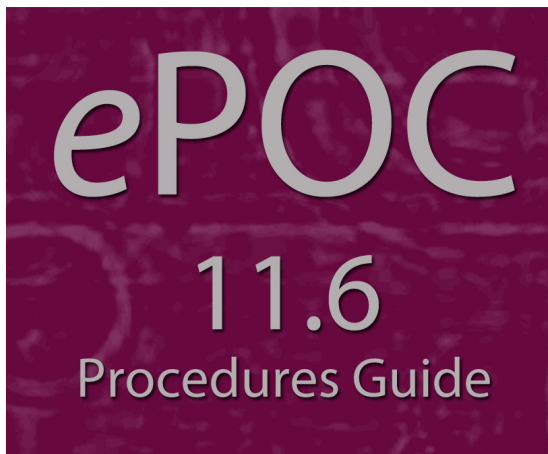

# Introduction

The ASPEN electronic Plan of Correction (ePOC) system provides a convenient, centralized workplace, which enables CMS Central Office (CO), Regional Office (RO), and State Agency (SA) users to electronically manage and track POCs for ePOC-enrolled health care providers under their oversight.

## About this Procedures Guide

The ASPEN *ePOC Procedures Guide* gives CMS Central Office (CO), Regional Office (RO), and State Agency (SA) users the information needed (depending on your user role) to:

- Configure ASPEN for ePOC
- Post the Statement of Deficiencies (SOD) for a survey to a care provider for review and POC submission
- Approve/Reject a submitted POC

Functions specific to ASPEN Regional Office (ARO) and differences between ACO and ARO are identified.

**Note:** This guide assumes that you are familiar with basic Windows operations knowledge and have received ePOC training.

This guide consists of this introduction and the following four chapters:

- ASPEN ePOC Procedures  
Provides task-based procedures to the SA/RO for completing all steps in the ePOC process. If you need more information, links to additional material are included.
- ASPEN ePOC Screens  
Contains pictures and brief descriptions of ePOC-related screens and windows in ASPEN.

- ASPEN ePOC Fields and Buttons  
Presents descriptions of the fields and buttons in the ePOC-related screens and windows in ASPEN.
- Supporting Materials  
Contains supplemental information and reference items.

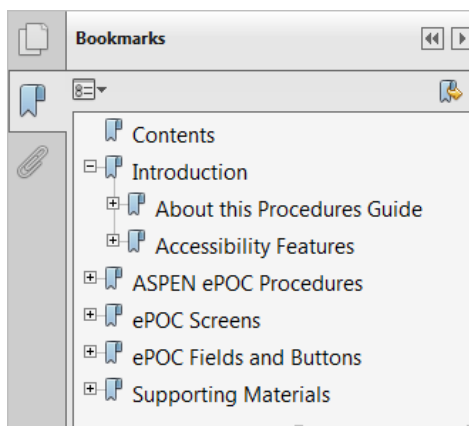


Figure 1: Bookmarks

### In this Guide

This procedures guide incorporates the following 508-compliant accessibility features:

- Alternate text (alt text) is defined for all graphics, which screen readers can read. In the Screens chapter, there are links (cross-references) to the field/column descriptions for the indicated screen or section of screen.

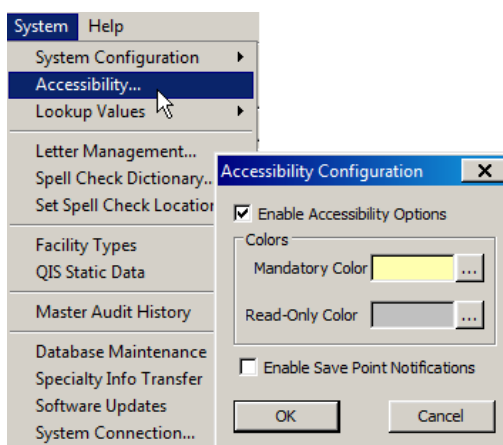


Figure 2: Accessibility

- All graphics have captions.
- Information is not conveyed by means of color alone.
- Reading order is optimized, so content is read correctly by screen readers.

- Tables are generally not used for formatting, so text is accessible to screen readers.
- Windows keyboard shortcuts are included in the Supporting Materials chapter (refer to ["Windows Keyboard Shortcuts" on page 121](#)).

## In ePOC

ePOC application functionality is integrated into ASPEN, and as such, ePOC includes the following 508-compliant accessibility features:

- The Accessibility menu option on the System menu lets you specify field color preferences and enable/disable save point notification, i.e., audible confirmation upon saving.
- All fields are included in the tabbing sequence.
- Keyboard shortcuts exist for all options, so ePOC is completely keyboard-accessible (refer to ["ASPEN Web: ePOC Keyboard Shortcuts" on page 124](#)).
- All error messages are accessible to screen readers.

## Acceptable Date Range in ASPEN

ASPEN does not allow dates outside of the range January 1, 1890 to December 31, 2050. You will be notified of an invalid date that is outside this range when it is entered in a field or grid, or on upload to national. A message will indicate the acceptable date range and you cannot save or upload until a valid date is entered.



# ASPEN ePOC Procedures

The ASPEN electronic Plan of Correction (ePOC) system offers a convenient centralized workplace for completing all steps in POC processing. States and Regional Offices will use ePOC functionality integrated into ACO and ACTS to:

- Post Statements of Deficiencies (SODs), i.e., surveys with deficiencies, to ASPEN Web: ePOC
- Post relevant letters to ASPEN Web: ePOC
- Receive POCs from the provider
- Review and accept or reject submitted POCs
- Track ePOC-related communication
- Receive timely email notification at various process points
- Generate reports to monitor timeliness and track POC history

## ePOC Overview

The Plan of Correction process is the same for all surveys with one or more deficiencies whether certification, investigation, Health, Life Safety Code, Federal Monitoring Survey, or revisit. The ePOC system supports this POC process for surveys on Federal facilities, i.e., those with a CCN number.

To start the process, the SA/RO posts a survey to the ASPEN Web: ePOC website. Facility users review the Statement of Deficiencies and submit plan of correction information. The SA/RO can also post related survey, enforcement, and intake letters to the ePOC website along with the SOD. Providers can attach documentation to support their submitted POC(s); the SA/RO can review the attachments until final approval of the POC(s).

Though ePOC supports display of Past Non-Compliance (PNC) and A-level Scope/Severity tags as well as deficiency-free surveys, POCs are neither required nor permitted. However, facility acknowledgement is required in all these cases. When follow-up surveys are posted to ASPEN Web: ePOC, corrected tags do not display.

To enhance communication and monitor timeliness, automated email notification is provided to specified SA/RO and facility recipients as needed throughout the ePOC life cycle.

## ePOC Configuration

Each state must complete the following configuration tasks in order to use the ePOC system functions.

- Enable ePOC functionality in ASPEN.
- Activate ePOC for facilities so they can use ASPEN Web: ePOC to view deficiencies and respond with their POCs.
- Assign user permissions for ePOC windows and buttons.
- Set up recipients for SA/RO-targeted ePOC emails.

### Enable ePOC in ASPEN

To enable ePOC functionality in ASPEN, you simply select an option in the State Customization window. You can enable ePOC for Health surveys, LSC surveys, both, or neither.

#### ***To enable ePOC in ASPEN:***

- 1 Open **ACO**.
- 2 On the **System** menu, select **System Configuration**, then **State Customization**.
- 3 Enter the **Security Clearance** password if requested.
- 4 In the **ePOC** section, choose the appropriate **Enable POC for** option.
- 5 Click **OK** to save and exit.

### Activate ePOC for Facilities

After you enable ePOC in ASPEN, you can activate ePOC in ACO (or ARO) for qualified facilities, either individually or in group(s). A facility must be a federally certified provider that is open, has a CMS Certification Number (CCN), and has been uploaded to national. For an activated facility, you can view a list of users with access to ASPEN Web: ePOC.

---

**Note:** Currently, only Nursing Home providers can be activated for ePOC.

---

Only surveys with an exit date on or after a facility's ePOC activation date can be posted to ASPEN Web: ePOC.

## Activate a Single Facility

To activate ePOC for an individual facility, you simply set an activation date in Facility Properties. You can change an existing activation date if necessary.

### ***To activate ePOC for a facility:***

- 1 Open **ACO**.
- 2 Locate the facility in the **Tree** view, right-click it, and select **Facility Properties**.
- 3 In the **ePOC information** section (at the bottom of the **Facility Definition** tab), click the **Enable** button and enter the **ePOC Activation Date**.  
The field will be enabled only if ePOC has been activated for the state. When set, the date must be within the last 13 working days.
- 4 Click **OK** to save and close Facility Properties.

---

**Note:** Surveys of the facility with an exit date prior to the ePOC Activation Date cannot be posted to ASPEN Web: ePOC. If you change the date for a facility with survey(s) already posted to ePOC, a message tells you this after you press OK; the survey(s) will continue to be active on the ePOC website and in ASPEN. You *cannot* revert to the original activation date.

## Activate Multiple Facilities

The ePOC Activation Date can be set or changed for multiple facilities as a group based on provider type, team and/or management unit.

### ***To activate ePOC for a group of facilities:***

- 1 Open **ACO**.
- 2 On the **System** menu, select **System Configuration**, then **ePOC Facility Maintenance**.
- 3 Select a **Primary Type** and/or a **Management Unit** and/or a **Team**.

---

**Note:** Currently, Nursing Home is the only primary type supported by the ePOC system.

---

- 4 Select the facilities for which you want to set or change the ePOC activation date. Use **Select All** to select all listed facilities, **Shift+click** to select consecutive facilities, or **Ctrl+click** to select non-consecutive facilities.
- 5 Enter the **New Activation Date** (at the bottom of the window).  
When set, the date must be within the last thirteen working days.

**6 Click **Set for All Selected**.**

The Activation Date column in the grid displays the date for all facilities that did not previously have an ePOC activation date. For facilities with a date entered but without surveys posted to ASPEN Web: ePOC, the existing date is changed.

---

**Note:** You cannot change the ePOC Activation Date here for facilities with surveys posted to ASPEN Web: ePOC. Use Facility Properties instead.

## **View ASPEN Web: ePOC Users**

After a facility has been activated for ePOC, you can view a list of facility users with access to ASPEN Web: ePOC. An option lets you enter an ePOC Web user as the emergency contact for the facility.

***To view ePOC Web users:***

- 1** Open **ACO**.
- 2** Locate the facility in the **Tree** view, right-click it, and select **Facility Properties**.
- 3** In the **ePOC information** section (at the bottom of the **Facility Definition** tab), click the **Web Users** button.

The ePOC Web Users window opens. It lists facility staff members who can access ASPEN Web: ePOC.

***To assign an ePOC Web user as the emergency contact:***

- 1** In the **ePOC Web Users** window, select the user who is to be the contact.
- 2** Click the **Save As Facility Emergency Contact** button.
- 3** Click **Yes** in the confirmation message.
- 4** Click **Close** to close the ePOC Web Users window.

The selected ePOC Web user's information is entered in the Contact Information section on the Facility Definition tab. It overwrites current contact information, if any is entered.

## Configure ePOC Email Recipients

Automatic email notifications are sent at various times during the ePOC process. For an ePOC email to be generated, at least one recipient group must be specified for the email in the SA/RO Email Recipients window.

SA and RO users with appropriate permissions can set up recipient groups and enter email addresses for non-survey specific recipients (e.g. management unit) in each group. Responsible parties and survey team members can be included or excluded as survey-specific recipients. For responsible parties and/or survey team members to be eligible recipients, they must have valid email addresses in their personnel records.

---

**Note:** SA/RO-targeted emails are generated based on attributes of the facility at which a survey was performed, e.g., its assigned management unit. You must consider this when configuring recipient groups.

## Set up a Recipient Group

The recipients in a group can be defined variously as those assigned to:

- A primary facility type
- A primary type + a particular team (work unit)
- A primary type + a particular management unit
- A primary type + a particular management unit + a particular team (work unit).

---

**Note:** A primary facility type must always be specified for a recipient group.

---

### **To configure a recipient group:**

- 1 Open **ACO/ARO**.
- 2 On the **File** menu, select **Email Recipients** to open the **SA/RO Email Recipients** window.

It lists all SA/RO-targeted ePOC emails. Recipient groups are configured by default to include all management units and teams.

- 3 To the right of the **Email Recipient Groups** section, click the **Add** button.
- 4 In the **Add/Modify Email Recipient Group** window, select the appropriate **Email Type** (i.e., POC email type), **Primary Facility Type**, **Management Unit**, and **Team** (i.e., work unit).

Primary Facility Type, Management Unit, and Team apply to the facility where the survey was performed. If, for example, the survey facility is assigned to work unit A, then, for the email to generate, at least one of the recipient groups for the email must have Team/Work Unit set to **A** or to **All**.

---

**Note:** Currently, Nursing Home is the only primary facility type supported by the ePOC system.

---

- 5 If survey team members should not be included in the recipient group, deselect **Notify Survey Team Members** (selected by default).
- 6 If ePOC responsible parties should be included in the recipient group, select **Notify ePOC Responsible Parties** (not selected by default).  
Responsible parties for the survey ePOC process are assigned via POC Properties.
- 7 Click **OK** to close the Add/Modify Email Recipient Group window.  
The new recipient group is displayed in the **Email Recipient Groups** grid.

---

**Note:** You can define multiple recipient groups for a single ePOC email. Staff members included in more than one recipient group for an email will receive multiple copies of the email.

---

***To modify a recipient group:***

- 1 In the **Email Recipient Groups** grid, select the group and click **Modify**.
- 2 In the **Add/Modify Email Recipient Group** window, make your changes and click **OK**.

***To delete a recipient group:***

- 1 In the **Email Recipient Groups** grid, select the group and click **Delete**.
- 2 Click **Yes** in the confirmation message.

## Specify Email Addresses of Non-Survey Specific Recipients

After setting up an email recipient group, you can add email address(es) of non-survey specific recipients in the group, e.g. management unit, whether addresses of the individual recipients or a single group address. Any valid email address is supported; thus, you can enter an externally configured group address for a management unit or team.

You should *not* add email addresses here for survey-specific recipients, i.e., survey team members and responsible parties. If they are designated as recipients, addresses from the applicable personnel records are automatically added to the emails.

---

**Note:** If an address is present, the user receives an ePOC email for any survey that matches the recipient group configuration, whether or not that person is a member of the survey team or assigned as a responsible party.

---

### ***To add email addresses for non-survey specific recipients:***

- 1 Open the **SA/RO Email Recipients** window.
- 2 In the **Email Recipient Groups** grid, select a group.  
 Recipient specifications for the selected group, as defined in the Add/Modify Email Recipient Group window, are indicated in the Recipients for section above the Email Address grid. Observe also that Notify Survey Team Members and Notify ePOC Responsible Parties (to the right of the grid) are selected or not per Add/Modify Email Recipient Group.
- 3 To the right of the **Email Address** grid, click the **Add** button.
- 4 In the **Add Email Recipient** window, enter a valid email address.  
 This could be the address of an individual recipient or a group email address.
- 5 Click **OK**.
- 6 Repeat steps 3-5 to add additional recipient addresses.  
 The address(es) are displayed in the Email Address grid.

### ***To modify an email address for a non-survey specific recipient:***

- 1 In the **Email Address** grid, select the address (individual or group) and click **Modify**.
- 2 In the **Add Email Recipient** window, edit the address and click **OK**.

### ***To delete an email address for a non-survey specific recipient:***

- 1 In the **Email Address** grid, select the address (individual or group) and click **Delete**.
- 2 Click **Yes** in the confirmation message.

## Email Recipient Group Configuration Examples

### Example 1: Survey Results Posted

You want the Survey Results Posted SA/RO email to go to your Quality Control group, ePOC responsible parties, the survey team supervisor, and yourself, but not survey team members. In this scenario, ePOC responsible parties (assigned via POC Properties) should include the supervisor, but not any survey team members.

#### ***Set up the recipient group as follows:***

- 1 Open the **SA/RO Email Recipients** window.
- 2 Under **Email Type**, select **Survey Results Posted - SA/RO** and click **Modify**.
- 3 In the **Add/Modify Email Recipient Group** window, use the default settings for **Primary Facility Type**, **Management Unit**, and **Team/Work Unit** (NH, All, All).
- 4 Deselect **Notify Survey Team Members**.
- 5 Select **Notify ePOC Responsible Parties**.
- 6 Click **OK** to close Add/Modify Email Recipient Group.

#### ***Add email addresses of non-survey specific recipients:***

- 1 In the **SA/RO Email Recipients** window, select the **Survey Results Posted - SA/RO** recipient group you defined (may already be selected).
- 2 To the right of the **Email Address** section, click the **Add** button.
- 3 In the **Add Email Recipient** window, enter a valid email address.  

This could be the address of an individual recipient or a group email address. Here, it could be the group address for the Quality Control group, if one is defined, the address of a Quality Control group member if there is not a group address, or your address.
- 4 Click **OK**.
- 5 Repeat steps 2-4 above to add additional addresses for non-survey specific recipients in the current recipient group.  

In this case, you need to add a Quality Control group address or individual addresses for group members, and your email address.

---

**Note:** You should *not* add email addresses for the designated responsible parties (including the survey team supervisor) as they are survey-specific recipients.

## Example 2: Late POC Review

You want the Late POC Review email to go to the survey team members and to the bureau directors of your state's two management units (East and West). In this scenario, you will need to set up two recipient groups. The bureau directors are non-survey specific recipients. ePOC responsible parties, if any, are irrelevant for the email.

### ***Set up the recipient group for East as follows:***

- 1 Open the **SA/RO Email Recipients** window.
- 2 Under **Email Type**, select **Late POC Review** and click **Modify**.
- 3 In the **Add/Modify Email Recipient Group** window:
  - Leave the default setting for **Primary Facility Type (NH)**.
  - For **Management Unit**, select **East**.
  - Leave the default setting for **Team/Work Unit (All)**.
- 4 Select **Notify Survey Team Members** (selected by default).
- 5 Deselect **Notify ePOC Responsible Parties** (not selected by default).
- 6 Click **OK** to close Add/Modify Email Recipient Group.

### ***Add email address of bureau director for East:***

- 1 In the **SA/RO Email Recipients** window, select the **Late POC Review** recipient group for East that you defined (may already be selected).
- 2 To the right of the **Email Address** section, click the **Add** button.
- 3 In the **Add Email Recipient** window, enter a valid email address for East's bureau director.
- 4 Click **OK**.

---

**Note:** You should *not* add email addresses for survey team members as they are survey-specific recipients.

---

### ***Set up the recipient group for West as follows:***

- 1 Open the **SA/RO Email Recipients** window (may already be open).
- 2 Under **Email Type**, select **Late POC Review** and click **Add**.
- 3 In the **Add/Modify Email Recipient Group** window:
  - Leave the default setting for **Primary Facility Type (NH)**.
  - For **Management Unit**, select **West**.
  - Leave the default setting for **Team/Work Unit (All)**.
- 4 Select **Notify Survey Team Members** (selected by default).
- 5 Deselect **Notify ePOC Responsible Parties** (not selected by default).
- 6 Click **OK** to close Add/Modify Email Recipient Group.

**Add email address of bureau director for West:**

- 1 In the **SA/RO Email Recipients** window, select the **Late POC Review** recipient group for West that you defined (may already be selected).
- 2 To the right of the **Email Address** section, click the **Add** button.
- 3 In the **Add Email Recipient** window, enter a valid email address for West's bureau director.
- 4 Click **OK**.

---

**Note:** You should *not* add email addresses for survey team members as they are survey-specific recipients.

**Example 3: Tardy Survey Posting**

You want the Tardy Survey Posting email to go to the survey team, the survey team's manager, and the director and deputy director of the Nursing Home unit. In this scenario, ePOC responsible parties (assigned via POC Properties) should include the survey team's manager, but not any survey team members. You also do not want to assign the director or deputy as ePOC responsible parties although you want them to get the email.

**Set up the recipient group as follows:**

- 1 Open the **SA/RO Email Recipients** window.
- 2 Under **Email Type**, select **Tardy Survey Posting** and click **Modify**.
- 3 In the **Add/Modify Email Recipient Group** window, use the default settings for **Primary Facility Type**, **Management Unit**, and **Team/Work Unit (NH, All, All)**:
- 4 Select **Notify Survey Team Members** (selected by default).
- 5 Select **Notify ePOC Responsible Parties**.
- 6 Click **OK** to close Add/Modify Email Recipient Group.

**Add email addresses of non-survey specific recipients:**

- 1 In the **SA/RO Email Recipients** window, select the **Tardy Survey Posting** recipient group you defined (may already be selected).
- 2 To the right of the **Email Address** section, click the **Add** button.
- 3 In the **Add Email Recipient** window, enter a valid email address for the director.
- 4 Click **OK**.

- 5 Repeat steps 2-4 above to add an email address for the deputy director.

---

**Note:** You should *not* add email addresses for the survey team members or designated responsible parties (including the survey team manager) as they are survey-specific recipients.

## Core ePOC Process

The ePOC life cycle begins with the State Agency (SA) or Regional Office (RO) creating a survey and adding their findings in ASPEN (ACO/ARO or ACTS/RO). Optionally, the SA/RO can select letters to post to the ePOC website and assign ePOC responsible parties. The SA/RO then posts the survey (SOD) and letter(s) on the ASPEN Web: ePOC website. At this point, ePOC generates an email notification to all ePOC-enrolled users at the facility as well as to SA/RO recipients. The facility reviews the SOD and submits POCs for the deficiencies, which the SA/RO reviews and approves or disapproves.

The steps in the basic ePOC process are outlined below. The procedures that follow provide instructions to CMS users (SA, RO, CO) for completing the relevant steps.

- 1 SA/RO creates a survey in ASPEN (ACO/ARO or ACTS/RO) and adds findings.
- 2 SA/RO assigns ePOC responsible parties, then posts the survey and related letters (optional) to ASPEN Web: ePOC for provider response.
- 3 All ePOC-enrolled users at the facility and the SA/RO receive Survey Posted email with information identifying the survey.
- 4 The facility reviews the survey and submits POCs (with attestation) for deficiencies via ASPEN Web: ePOC.
- 5 SA/RO reviews POCs submitted by the facility in ACO/ACTS and approves or rejects each.
- 6 If SA/RO rejects a POC, facility users receive a Rejected email listing the reasons for rejection. Facility then revises and re-submits the POC.
- 7 Upon SA/RO approval of POCs for all deficiencies on the survey, ASPEN automatically closes the survey and facility users receive the Final Approval email.

## POC Properties

After creating a survey and adding findings, the SA/RO uses the POC Properties window to initiate, manage, and track the ePOC process for the survey.

### POC Properties Functions

From the POC Properties window, you can:

- Post a survey to the ASPEN Web: ePOC
- Remove a posted survey from ASPEN Web: ePOC
- Re-post a survey and indicate the reason for re-posting
- View posting history
- View and change (if necessary) SOD and POC-related dates
- Generate and post survey letters to ASPEN Web: ePOC
- Post enforcement and intake letters created in AEM and ACTS to ASPEN Web: ePOC
- Assign responsible parties for the ePOC process
- View POC status information
- Unlock the survey to permit updates by the SA/RO updates
- Lock an unlocked survey
- Stop a survey
- Open the POC Tracking window
- Open the POC Approval and Rejection window
- View facility-submitted ePOC attachments and add, view, save, or delete your SA/RO ePOC attachments until final POC approval
- Run the POC Audit Trail and Survey POC Information reports

### Open the POC Properties window

You can access POC Properties for an eligible survey from:

- ACO or ACTS Tree view
- Intake to which the survey is linked
- Certification kit to which the survey is linked
- POC Manager



**To open POC Properties from Tree view in ACO:**

- 1 Locate the survey in the **Alpha, Type, Cert/Survey, or Enforcement** tree.
- 2 Right-click the survey and select **ePOC...** to open **POC Properties**.

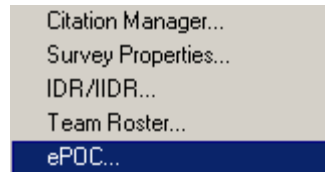


Figure 3: ePOC right-click option in ACO tree

POC Properties opens.

**To open POC Properties from Tree view in ACTS:**

- 1 Locate the survey in the **Investig** tree.
- 2 Right-click the survey and select **ePOC...** to open POC Properties.

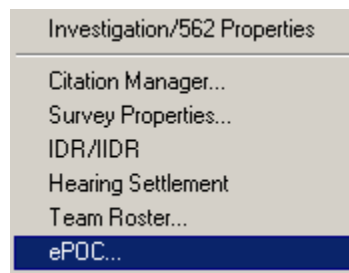


Figure 4: ePOC right-click option in ACTS tree

**To open POC Properties from an intake in ACTS:**

- 1 Locate the intake to which the survey is linked.
- 2 Right-click the intake and select **Modify Intake**.
- 3 Go to the **Investigation** tab.
- 4 In the **Investigation and Survey** grid, click the **POC Track** button for the survey to open **POC Properties**.

- Surveys posted to ASPEN Web: ePOC

- Surveys of ePOC-activated facilities that have not been posted yet but with an exit date after the ePOC activation date

**Note:** POC Tracking opens instead for surveys of facilities not activated for ePOC and surveys of ePOC-activated facilities with an exit date prior to the ePOC activation date.

---

***To open POC Properties from a certification kit in ACO:***

- 1 Locate the certification to which the survey is linked.
- 2 Right-click the kit and select **Certification Kit**.
- 3 In the **Survey List**, click the **POC** button for the survey to open **POC Properties**.

POC Properties opens for:

- Surveys posted to ASPEN Web: ePOC
- Surveys of ePOC-activated facilities that have not been posted yet but with an exit date after the ePOC activation date

---

**Note:** POC Tracking opens instead for surveys of facilities not activated for ePOC and surveys of ePOC-activated facilities with an exit date prior to the ePOC activation date.

---

***To open POC Properties from POC Manager:***

- 1 Open **ACO** or **ACTS**.
- 2 In the toolbar, click the **POC** button to open **POC Manager**.
- 3 Set filters as desired.
- 4 Select the survey in the grid and click the **POC Properties** button at the bottom of the window.

The POC Properties window is displayed.

## POC Manager

The POC Manager, which is available in both ACO and ACTS, displays all surveys that have been posted to ASPEN Web: ePOC. It provides survey and POC information and serves as a central access point for managing and tracking the ePOC process for posted surveys. You can set filters to tailor the survey list to your operational needs.

### POC Manager Functions

For a survey selected in the POC Manager grid, you can:

- Open the POC Approval and Rejection window
- Open POC Properties
- Stop the survey
- View facility-submitted ePOC attachments and add, view, save, or delete your SA/RO ePOC attachments until final POC approval
- Open Citation Manager
- Run the POC Manager Listing, POC Audit Trail, and Survey POC Information reports

### Open and Filter the POC Manager

A button on the ACO and ACTS toolbars provides access to POC Manager. It lists surveys posted to ASPEN Web: ePOC and stopped surveys. The survey list reflects the current user's facility type security settings as well as selection criteria from the active My Selections filter. The default sort order is alphabetical by facility name; you can change the sort order if desired.

By default, the grid displays open surveys posted to ASPEN Web: ePOC within the last six months that have at least one tag with a Citation POC Status of SA/RO Draft or Submitted. You can filter the survey list by any of the following, or a combination:

- Facility Name
- CCN
- Facility ID (state-assigned)
- Survey Event ID
- Survey Exit Date
- Survey POC Status
- Citation POC Status
- Survey Type
- Surveyor

- Responsible Party
- FMS Survey

For example, you could set filters to display surveys with specified POC Status(es) for a specific facility within a particular exit date range. When you have set filters as desired, you refresh the list to display only the surveys meeting your criteria.

***To open POC Manager:***

- 1 Open **ACO** or **ACTS**.
- 2 In the toolbar, click the **POC** button.
- 3 To change the sort order, click the applicable column header.

***To filter the survey list:***

- 1 In the **Filter Criteria** section, set filters as desired.
  - To filter by **Facility Name**, **CCN**, **Facility ID**, or **Survey Event ID**, select the applicable button and enter some or all of the name/number in the **Text** field.
  - For **Exit Date Between**, enter the **Start Date** and **End Date** of the desired survey exit date range.
  - For **Survey POC Status** and/or **Citation POC Status**, select the desired option(s).
  - For **Survey Type** and/or **Surveyor** and/or **Responsible Party**, select the desired option.
  - For **FMS Survey**, select the desired option.
- 2 When you have specified all filtering criteria, click the **Refresh** button.

The grid is refreshed to display all surveys matching the criteria. If any tags on a survey match specified Citation POC Status(es), the survey is included in the list.

## Surveys in ePOC

In order for a survey to qualify for posting to ASPEN Web: ePOC, it must meet the following criteria:

- The facility must be activated for ePOC.
- The facility must have active ePOC-enrolled users.
- The survey exit date must be on or after the facility's ePOC Activation Date and on or before today's date.

- There must be surveyor evidentiary text for all tags on the survey, including initial comments, if present.
- The survey cannot be recycled or deleted.
- At least one tag must be associated with the survey.
- The survey must not be “stopped”.

After a survey is complete and findings are entered, the SA/RO can use the POC Properties window to post the survey to ASPEN Web: ePOC for provider response, optionally create and post survey letters, optionally post enforcement and intake letters created in AEM and ACTS, optionally add POC responsible parties, and print POC reports for the survey (POC Audit Trail, Survey POC Information) as needed.

---

**Note:** No POC is required for a fully corrected revisit. However, you should post it to ePOC to allow the provider to print the CMS-2567B, which is the only way the provider can view corrected deficiencies.

## Create Surveys and Add Findings

## Create Survey Letters

SOD (survey) letters can optionally be created and posted along with their associated survey to ASPEN Web: ePOC; they are not required for posting. You can generate survey letters from POC Properties or elsewhere in ASPEN. Survey letters can be added to an already-posted survey.

---

**Note:** Enforcement and intake letters created in AEM and ACTS respectively are listed in POC Properties and can be posted to ASPEN Web: ePOC. Do **not** generate enforcement or intake letters from POC Properties, as they will not update enforcement/intake files and will not show on reports.

---

**To create an SOD (survey) letter from POC Properties:**

- 1 Open **POC Properties** for the survey.

- 2 In the **Survey Letters for ePOC Display** section, click **New** and generate the letter.

The letter is added to the Survey Letters for ePOC Display grid.

## Add ePOC Responsible Parties

To assign responsible parties for the ePOC process to a survey, you use POC Properties. Responsible parties are not required in order to post a survey to ASPEN Web: ePOC.

You can assign any combination of SA staff, RO staff, team/work unit staff (specified on the Associations tab in Facility Properties), survey team members, and intake responsible parties as ePOC responsible parties. They will receive SA/RO targeted ePOC emails if configured as recipients.

**To add POC responsible parties:**

- 1 Open **POC Properties** for the survey.
- 2 Add responsible parties.
  - To add SA or RO staff members, click **Add S.A.** or **Add R.O.** and select a staff member; repeat to add additional SA or RO staff.  
The staff member(s) are added to the Responsible Parties grid.
  - To add the facility team/work unit or survey team, click **Add Facility Team/Work Unit** or **Add Survey Team**.  
All members of the facility or survey team are added to the Responsible Parties grid.
  - To add responsible parties assigned to intake(s) linked to the survey, click **Add Intake Resp Parties**.  
All responsible parties assigned to intake(s) linked to the survey are added to the Responsible Parties grid. A message appears if no intakes are linked to the survey or no responsible parties are assigned to linked intakes.

***To delete a responsible party:***

- 1 In the **Responsible Parties** grid, select a staff member and click **Delete**.
- 2 Click **Yes** in the confirmation message.

---

**Note:** To delete a facility or survey team, you must delete each member of the team individually.

## **Post Surveys to ASPEN Web: ePOC**

To post a survey to ASPEN Web: ePOC, you simply press a button in POC Properties. All tags on the survey are posted by default for facility response, but you can exclude specific tags if desired. Neither survey letters nor responsible parties are required in order to post a survey. If there are survey letters, you can choose which, if any, to post.

Once a survey is posted to ASPEN Web: ePOC, it is locked to prevent changes to core survey and citation information via ACO/ACTS or imports. However, the Staggered Survey field is enabled, and for Staggered Surveys that are locked due to ePOC posting, the Date and Time fields are also enabled in the certification kit.

---

**Note:** You cannot post surveys for a facility with no ePOC-enrolled users.

---

***To post a survey to ASPEN Web: ePOC:***

- 1 Open **POC Properties** for the survey.
- 2 In the **Citations for ePOC Display** grid, de-select any tags you do not want to post; all tags are selected by default.  
At least one tag must be selected unless all tags are fully corrected.
- 3 If you want to set the **POC Due** date, click **Change** and enter the desired date.  
If you do not enter this date, it is set to the SOD Sent Date plus 10 calendar days as soon as you post the survey.
- 4 In the **Survey Letters for ePOC Display** section, select the letter(s), if any, you want to post.

The list comprises survey letters generated here or elsewhere in ASPEN including any enforcement letters related to the survey and intake letters linked to the survey with the facility as the recipient.

---

**Note:** Enforcement and intake letters are created in AEM and ACTS respectively. Do **not** generate enforcement or intake letters from POC Properties.

---

Once the survey is posted, you can optionally click the Alert Facility button to generate the Letter Notification email.

- 5 Click the **Post on ePOC Website** button.

The posting is halted if there is any error such as facility with no active ePOC users, no tags selected, no citation text for a tag, etc.

- 6 Click **Yes** in the confirmation message.

- 7 When the **Post Complete** message appears, click **OK**.

The survey has been posted to ASPEN Web: ePOC. The SOD Sent Date and Post Date have automatically been entered; the POC Due date is also automatically set if you did not enter it. The survey is now locked.

## Unlock and Re-lock Posted Surveys

If necessary, you can unlock a survey posted to ASPEN Web: ePOC via POC Properties in order to make changes. The survey remains posted on the ePOC website for facility response. Tardiness emails will still be generated for the survey as appropriate, and it will appear on tardiness reports.

Because the posting is not removed, surveys should be unlocked only on a limited basis. You can re-lock the survey at any time. For changes to display on the ePOC website, you must re-post the survey. If a survey is unlocked, you can still import core survey data to ACTS or ACO, even if the survey is still posted to ePOC. For example, if additional tags are added to a survey in ASE-Q, you can unlock the posted survey, and import the updated survey from ASE-Q into ACO/ACTS to include these additional tags in ACO/ACTS.

If you attempt to import a locked survey into ACO/ACTS, a Transfer Error notification appears with the following message:



Core survey data for <Survey ID> will not import since survey is posted to the ePOC website and locked. Survey posting must be removed or survey unlocked to import core survey data. Regardless, if present, QIS data will import.

One appropriate scenario for unlocking a survey would be when there is a tag that requires quick turnaround, e.g., Immediate Jeopardy (IJ) or Sub-standard Quality of Care (SQC). You could post the tag that needs quick facility response to the ePOC website, unlock the survey to add remaining tags while leaving it available to the facility for immediate response to the posted tag, then re-post the survey with the additional tags.

You may occasionally also want to unlock a survey to update the survey or make changes to already posted citations such as changing Scope/Severity or adding surveyor evidence. You can also add new citations and update un-posted citations.

The survey must be re-posted to ASPEN Web: ePOC to display changes and post new tags. When posted citations are modified while a survey is unlocked, the Posted date for the citation in the Citations for ePOC Display grid remains the same and Yes is displayed in the Changed column.

Import of QIS survey data is allowed even when the survey is locked due to ePOC web posting.

---

**Note:** When a survey is changed and re-posted, the facility receives an email notification that identifies new and changed tag(s).

---

***To unlock a posted survey:***

- 1 Open **POC Properties** for the survey.
- 2 In the **Status** section (lower right), click **Unlock Survey for SA/RO Updates**.
- 3 Click **Yes** in the confirmation message.

The survey is now unlocked and you can make changes. The label on the button changes to Lock Survey to Prevent SA/RO Updates.

---

**Note:** If the survey was closed, it is automatically re-opened. A message reminds you to close and lock the survey when finished with changes.

---

***To re-lock an unlocked survey:***

- 1 Open **POC Properties** for the survey.
- 2 In the **Status** section (lower right), click **Lock Survey to Prevent SA/RO Updates**.

- 3 Click **Yes** in the confirmation message.

---

**Note:** If the survey you unlocked was automatically re-opened because it was closed, you should manually re-close the survey when you re-lock it.

## Remove Posted Surveys

It may occasionally be necessary to remove a survey posted on ASPEN Web: ePOC due, for example, to Informal Dispute Resolution or Independent Informal Dispute Resolution (IDR/IIDR) or media attention. You can make changes to an un-posted survey and re-post it as necessary. The un-post/re-post process gives facilities a clean (new) copy of the CMS-2567 form if one or more deficiencies are added, changed, or removed.

When a posted survey is removed from the website, any POC information already entered on the facility ePOC website and in ASPEN is retained. Tardiness emails will still be generated for the survey as appropriate, and the survey will appear on tardiness reports.

***To remove a posted survey:***

- 1 Open **POC Properties** for the survey.
- 2 In the **Reason for Re-posting or Removing Posting** text box (under the grid), enter the reason you are removing the posted survey.
- 3 Click **Remove Posting**.  
You will receive an error message if you have not entered a reason.
- 4 Click **Yes** in the confirmation message.

The survey is removed from ASPEN Web: ePOC and unlocked, allowing changes.

If the survey includes one or more uncorrected IJ tags, the confirmation message specifically mentions it.

---

**Note:** If the survey was closed, it is automatically re-opened. A message reminds you to close and lock the survey when finished with changes.

## Re-post Surveys

After making changes to an unlocked or un-posted survey, you can re-post it so that data on the ePOC website matches the updated data in ACO/ACTS. You can also optionally change the SOD Sent Date and POC Due Date to allow the facility more time to submit POCs for the tags on the survey. The facility will receive an email notification of the re-posting, which identifies changed tag(s).

ePOC will compare the citation information in a re-posted survey (i.e., citation text, S/S, and PNC indicator setting) to the last posted version, if present. If a tag is removed due to IDR/IIDR and/or hearing/settlement, that tag appears with strike-through on the text displays in ACO and ACTS, and a Not Posted status when the survey is re-posted.

Existing POC information for a tag is retained in ASPEN, even if the tag is changed and re-posted. If the POC status of a revised tag is No POC, that tag's status will remain No POC. If the POC status for a revised tag is other than No POC, the tag's POC status is set to Rejected in the re-posted survey, which allows the facility to enter a new POC. The rejection reason associated with the tag is "Revised deficiency information exists"; it is included in the POC Rejected email sent to the provider.

### ***To re-post a survey:***

- 1** Open **POC Properties** for the survey.
- 2** As necessary, change **SOD Sent Date** and/or **POC Due** date; click the **Change** button next to the field(s) and enter the new date(s).
- 3** Enter the **Reason for Re-Posting**.  
This will be included in the Re-post notice sent to the facility.
- 4** Click the **Post on ePOC Website** button.  
If you have not entered a Reason for Re-Posting, you are prompted for it.  
If you are trying to re-post a survey for a facility without active ePOC users, a message appears and the posting is halted.
- 5** Click **Yes** in the confirmation message.

- 6 When the **Post Complete** message appears, click **OK**.

The survey is re-posted to ASPEN Web: ePOC. SOD Sent Date, Post Date, and POC Due date are automatically updated as appropriate in POC Properties and the survey is locked.

---

**Note:** If the survey you removed from posting was closed and therefore automatically re-opened when it was un-posted, you should manually re-close the survey when you re-post it.

## View Posting History

A history of the times a survey was posted to ASPEN Web: ePOC is available from POC Properties.

The ePOC History window opens. It displays the date/time of each posting to ASPEN Web: ePOC along with a reason, if available.

The POC Tracking window opens and displays POC information for the survey.

## POC Approval/Rejection

When the facility submits POC(s) in response to an SOD (survey) posted on ASPEN Web: ePOC, the SA/RO reviews and approves or rejects the POCs. You can enter draft or final approval or rejection for individual tags and finalize all outstanding draft approvals/rejections at one time.

### Review POCs

The starting point for reviewing facility-submitted POCs for a survey is the POC Approval and Rejection window. As you review POCs, you may want to access Citation Manager; print survey forms; view facility-submitted ePOC attachments; or add, view, save, or delete your SA/RO ePOC attachments. From POC Manager, you can open Citation Manager. From POC Approval and Rejection, you can print survey forms. From POC Manager, POC Properties, POC Approval and Rejection, or Citation Manager, you can access ePOC attachments (facility or SA/RO) until final POC approval.

### Open POC Approval and Rejection

The POC Approval and Rejection window, which you can open from the POC Manager or POC Properties, lists all uncorrected deficiencies. For each deficiency, it displays regulation text, surveyor findings, and the facility-submitted POC. From this window, you can:

- Open the POC Approval or POC Rejection window for individual tags, where you can enter and finalize draft POC approval/rejection
- Remove approval for individual tags
- View POC history for individual tags
- Generate survey forms
- Access facility-submitted or your SA/RO ePOC attachments until final POC approval
- Finalize all draft approvals/rejections

You can click a column header to change the sort order if desired.

When posted citations are modified while a survey is unlocked, the Posted date for the citation in the Deficiencies grid remains the same and Yes appears in the Changed column.

Tags that have been removed due to hearing/settlement appear with a strike-through line on the text in a list view. They will not appear on the following survey reports:

- CMS-2567 and CMS-2567B
- Quick Report (draft CMS-2567)
- Severity/Scope Grid
- A-form

If the completion date (X5) for a POC is more than six months after the survey exit date, a warning message is displayed under the Plan of Correction panel.

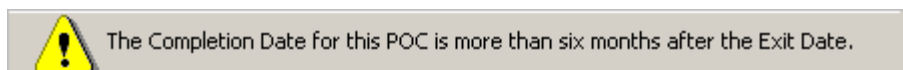


Figure 6: Completion Date warning

## Open Citation Manager

Citation Manager opens for the selected survey.

## Print CMS-2567

The standard CMS-2567 report details the deficiencies found on the survey of the facility; it includes PNC tags and memo/comment tags (0000, 9999). A-level tags print separately on Form A (CMS-2567A).

The CMS 2567 Sent To Facility report (Reports | Scheduling and Tracking Reports | Tracking Reports | CMS 2567 Sent to Facilities) shows how many days after the exit date the CMS-2567 was sent. If desired, you can include surveys for which no CMS-2567 has been sent.

---

**Note:** When a facility generates the CMS-2567 from ASPEN Web: ePOC, surveyor IDs and names do not appear. If you post tag 9999 on ASPEN Web: ePOC, it will appear on the CMS-2567 when the facility prints it.

---

Tags that have been removed due to hearing/settlement will not appear on the following survey reports:

- CMS-2567 and CMS-2567B
- Quick Report (draft CMS-2567)
- Severity/Scope Grid
- A-form

If you generate the CMS-2567 for a survey from the Select Form(s) ... window anywhere in ASPEN (except ASE-Q) during the POC review process, a POC Not Final/Pending Acknowledgement watermark displays if any POCs for tags on the survey have not been approved or acknowledged. Tags that require acknowledgement are tags with Scope/Severity level of A or PNC (Past noncompliance) tags; all other non-comment, non-waiverable tags require a POC Submission. You can choose to exclude the watermark when you print the form.

---

**Note:** A facility cannot choose to exclude the watermark. It will always appear in qualifying circumstances.

---

In ASE-Q, the watermark does not print on the CMS-2567, regardless of the POC status of the survey. The Exclude POC Not Final/Pending Acknowledgement watermark option is therefore not available.

**To print CMS-2567:**

- 1 Open **Select Form(s) ...**
- 2 Select **CMS 2567** (or CMS 2567 B for a revisit) and click **OK**.
- 3 In the **Customize Survey Report Form** window, select the options you want. For example, select **Exclude Watermark (POC Not Final/Pending Acknowledgement)** if you do not want a watermark to print.

Depending on your selections and tags on the screen, several other customization windows may appear.

- 4 Select the desired options in each additional window that appears and click **OK**.

The CMS-2567 form(s) print according to your specifications.

---

**Note:** Tags that have been removed due to hearing/settlement appear with a strike-through line on the text in a list view.

## **Access ePOC Attachments**

Supported document types are .DOC, .DOCX, .XLS, .XLSX, .PDF, .RTF, .JPG, .JPEG, .GIF, .TIFF, .TXT, and .ZIP. File size is limited to 4MB per file. A statement in the Add an Attachment section on the Attachments window emphasizes the need to protect patient confidentiality.



The ePOC Attachments window provides access *until final POC approval* to:

- Files attached by a facility via ASPEN Web: ePOC to support POC(s) for a survey. You can view facility-submitted ePOC attachments.

---

**Note:** Files are checked for viruses and will not be attached to survey if virus-infected.

---

- SA/RO ePOC attachments. You can add, view, save, or delete your SA/RO ePOC attachments.

You can open the ePOC Attachments window from:

- POC Manager
- POC Properties
- POC Approval and Rejection window
- Citation Manager

A warning in the ePOC Attachments window tells you that ePOC attachments will be automatically deleted when the POC is finalized. If you wish to keep a copy of the attachments, you should save them to a local, network, or external drive.

#### ***To access ePOC attachments from POC Manager:***

- 1 Open **POC Manager**.
- 2 Select a survey in the grid and click the **ePOC Attachments** button (bottom of window).

When you select the survey, the ePOC Attachments button indicates the number of ePOC attachments to the survey in parentheses.

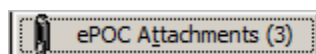


Figure 7: ePOC Attachments button

- 3 In the **ePOC Attachments** window, select the **View** button to open a document.
- 4 When you are finished, close the document and the ePOC Attachments window.

#### ***To access ePOC attachments from Citation Manager:***

- 3 In the **Survey Attachments Documents** window, click the **ePOC Attachments** button.

The number of ePOC attachments to the survey is indicated in parentheses.

- 4 In the **ePOC Attachments** window, select the **View** button for a document to open it.

- 5 When you are finished, close the document, the ePOC Attachments window, and the Survey Attachments Documents window.

***To access ePOC attachments from POC Properties:***

- 1 Open the **POC Properties** window.
- 2 Click the **ePOC Attachments** button (bottom of window).  
The number of ePOC attachments to the survey is indicated in parentheses.
- 3 In the **ePOC Attachments** window, select the **View** button for a document to open it.
- 4 When you are finished, close the document and the ePOC Attachments window.

***To access ePOC attachments from POC Approval and Rejection:***

- 1 Open the **POC Approval and Rejection** window.
- 2 Click the **ePOC Attachments** button (bottom of window).  
The number of ePOC attachments to the survey is indicated in parentheses.
- 3 In the **ePOC Attachments** window, select the **View** button for a document to open it.
- 4 When you are finished, close the document and the ePOC Attachments window.

## Approve a POC

To approve the POC for a tag, the SA/RO opens the POC Approval window for individual tags from the POC Approval and Rejection window. You can issue a draft or final approval of the submitted POC. Draft approval is appropriate, e.g., when a POC approval requires internal review. The facility cannot view draft approvals. After review and any updates to the draft approval of a POC, you can finalize it.

If approving the final POC for a survey (i.e., the POC for the last tag without an approved POC) or finalizing the draft approval for the final POC, you are warned that ePOC attachments will be deleted. If desired, you can save local copies of attachments before final POC approval.

When you give final approval to the POC for a tag, the facility receives a POC Approved email. When the SA/RO has approved the POCs for all deficiencies on the survey, ASPEN automatically closes the survey and the facility receives a Final Approval email.

***To enter draft approval of a POC:***

- 1 Open the **POC Approval and Rejection** window.
- 2 In the **Deficiencies** grid, select a tag.
- 3 In the **Plan of Correction** area, review the facility-submitted POC.
- 4 Click the **Approve** button.  
The POC Approval window is displayed.
- 5 Optionally enter **Comments** about the draft approval.  
The comments are for internal SA/RO users only. The facility will not see them.
- 6 Click the **Save as Draft** button.
- 7 Click **Yes** in the confirmation message.  
In the POC Approval and Rejection window, the tag's POC Status is set to Draft Approval. You can edit text in the Comments section of the POC Approval window as necessary.

***To issue final approval of a POC:***

- 1 Open the **POC Approval** window as above (steps 1-4).
- 2 Optionally enter **Comments** about the approval.  
The comments are for internal SA/RO users only. The facility will not see them.
- 3 Click the **Final Approval** button.  
If you are approving the final POC for a survey, you are warned that ePOC attachments will be deleted. If desired, you can halt the approval and save local copies of the attachments, then start over with the approval.
- 4 Click **Yes** in the confirmation message to proceed with the approval. In the POC Approval and Rejection window, the tag's POC Status is set to Approved and the Approve and Reject buttons are disabled.  
You cannot edit text in the Comments section of the POC Approval window for an approved POC, but you can view the comments in the POC History for Tag window.

---

**Note:** When you approve the final POC for a survey, ASPEN automatically closes the survey and a Final Approval email is sent to the facility. The survey can be re-opened if needed (e.g., for IDR) via Survey Properties.

## Reject a POC

To reject the POC for a tag, the SA/RO opens the POC Rejection window for individual tags from the POC Approval and Rejection window. At least one reason for rejection must be identified. If you select Other as a rejection reason you must enter an explanation; otherwise, an explanation is optional.

The POC Rejection email to the facility includes the selected final rejection reason(s) and any explanations, which the facility can also view in ASPEN Web: ePOC. You can optionally add comments about the rejection, which only internal SA/RO users will see.

You can issue a draft or final rejection of the submitted POC. Draft rejection is appropriate, e.g., when a POC rejection requires internal review. The facility cannot view draft rejections. After review and any updates to the draft rejection of a POC, you can finalize it. When you issue the final rejection of a POC, the facility receives a POC Rejected email and must revise and re-submit the POC.

### ***To enter draft rejection of a POC:***

- 1 Open the **POC Approval and Rejection** window.
- 2 In the **Deficiencies** grid, select a tag.
- 3 In the **Plan of Correction** area, review the facility-submitted POC.
- 4 Click the **Reject** button.  
The POC Rejection window is displayed.
- 5 Select one or more **Reason(s)** for the rejection.  
For Federal surveys, only federally specified reasons are listed. If a state licensure regulation set is assigned to the survey and a state tag is cited, there may be state-specific rejection reasons as well as the Federal reasons.  
When you select a Reason, the Explanation text field is enabled.
- 6 Enter an **Explanation** for the selected **Reason**.  
An explanation is required if Other is the reason; otherwise, it is optional.
- 7 Optionally enter **Comments** about the rejection.  
The comments are for internal SA/RO users only. The facility will not see them.
- 8 Click the **Save as Draft** button.
- 9 Click **Yes** in the confirmation message.  
In the POC Approval and Rejection window, the tag's POC Status is set to Draft Rejection. You can add or delete rejection reasons/explanations in the POC Rejection window as appropriate.

### ***To issue final rejection of a POC:***

- 1 Open the **POC Rejection** window as above (steps 1-4).

- 2 Select one or more reasons for the final rejection.

For Federal and combined surveys, only federally specified reasons are listed. For licensure-only surveys, there may be state-specific rejection reasons as well as the Federal reasons.

When you select a Reason, the Explanation text field is enabled.

- 3 Enter an **Explanation** for the selected **Reason**.

An explanation is required if Other is the reason; otherwise, it is optional.

- 4 Optionally enter **Comments** about the final rejection.

The comments are for internal SA/RO users only. The facility will not see them.

- 5 Click the **Final Rejection** button.

- 6 Click **Yes** in the confirmation message.

In the POC Approval and Rejection window, the tag's POC Status is set to Rejected and the Approve and Reject buttons are disabled. The rejection reasons and explanations are not displayed, but you can view them in the POC History for Tag window.

---

**Note:** The facility can view final rejection reasons and explanations in ASPEN Web: ePOC.

## Finalize Drafts

The Finalize Drafts function lets you finalize at once the approval or rejection of all POCs with a POC Status (respectively) of Draft Approval or Draft Rejection. POC Status changes immediately to Approved or Rejected.

***To finalize all draft POC approvals and rejections:***

- 1 Open the **POC Approval and Rejection** window.
- 2 Click the **Finalize Drafts** button (bottom of screen).

**3** Click **Yes** in the confirmation message.

In the POC Approval and Rejection window, POC Status for tags that were in Draft Approval or Draft Rejection status is updated to Approved or Rejected, and the applicable emails are sent. When rejection reason/explanation text exists, it is saved and included in the POC Rejection email.

## Close Survey

When all citations on a survey have approved POCs, the survey will be automatically closed. Both the POC status and Survey status are set to CLOSED. As a survey is being closed, all ePOC attachments will be removed from the system and the facility will receive a Final Approval email.

A survey will be automatically closed in the following cases:

- SA/RO approves the POC the last unapproved tag on a survey.
- Facility acknowledges an A-level or PNC tag and it is the last unapproved tag on the survey.
- Facility acknowledges a deficiency-free survey.
- SA/RO posts a new survey with only corrected or waived tags.
- SA/RO removes the last unapproved citation from the survey. The tag can be removed due to:
  - Deleting the citation
  - Setting the citation's correction date
  - IDR/IIDR
  - Hearing/settlement

If a closed survey is removed from posting and/or unlocked, it automatically re-opens. You can manually re-close it through Survey Properties when you re-post/re-lock it.

## View POC History

The POC History for Tag window displays POC submission information for a selected tag, staff member who performed each action, POC text, and the approval/rejection history for the POC. Approval Comments, if any, are shown for approved POCs. For rejected POCs, comments, rejection reasons and explanations are listed in the Rejection Detail section.

### ***To view POC history for a tag:***

- 1 Open the **POC Approval and Rejection** window.
- 2 In the **Deficiencies** grid, select a tag (other than 0000 or 9999).
- 3 In the **Plan of Correction** area, select the **History** button.  
The POC History for Tag window opens.

## ePOC Special Cases

The ePOC system is designed to accommodate special POC situations including the following:

- FMS surveys
- Deficiency-free surveys
- A-level and PNC tags
- Removing approvals
- Stopping surveys, i.e., removing surveys from the ePOC system

## FMS Surveys

Though SA/RO users may view any FMS survey (C-Federal Monitoring included as Type of Survey in Survey Properties) and its ePOC activity in ASPEN, only RO users can post standard (i.e., non-revisit) FMS surveys to ASPEN Web: ePOC and approve/reject submitted POCs. For FMS revisit surveys, both RO and SA users can post and approve/reject POCs.

Qualifying FMS revisit surveys can be included in ePOC, regardless of whether or not they are linked to an FMS record. FMS starting surveys can be posted to ePOC if they are associated with an FMS record that is eligible for inclusion in ePOC (e.g. Comparative, Complaint, etc.), or if they are not associated with an FMS record.

- FMS Surveys associated with an FMS record that is ineligible for inclusion in ePOC (e.g. Observational) cannot be posted to ePOC.
- If an FMS survey is not yet assigned to a valid FMS record, it is still eligible for inclusion to ePOC.
- If an RO user attempts to associate an ePOC posted FMS survey with an FMS record that is ineligible for ePOC inclusion (e.g. Observational), a notice appears instructing the user they must remove the survey from the ePOC website before this association can be made.

The ePOC process for FMS surveys is the same as for other surveys except that standard FMS surveys must be posted from, and POCs approved/rejected in, ARO by RO staff. Email recipients for FMS ePOC surveys are not limited to RO staff; recipients for FMS ePOC emails are the same as for ePOC emails (i.e., responsible parties, team members, etc.).

## Deficiency-Free Surveys

A survey is deficiency-free if it has only memo/comment tags (0000, 9999), or it has memo tags and all other tags are fully corrected. The posting process for deficiency-free surveys is the same as for other surveys. The facility must acknowledge the SOD for a deficiency-free survey. The same ePOC emails are generated and they are included in tardiness reports.

When a facility acknowledges a deficiency-free survey on the ePOC website by selecting the Acknowledge SOD button on the Survey Detail page, the POC status of the survey changes to Closed and the POC approval date for the survey is set to the current date. POC status for tags 0000 and 9999 is always N/A.

## A-level and PNC Tags

The posting process for surveys that include A-level Scope/Severity or PNC tags is the same as for other surveys. POCs are neither required nor supported for these tags, but the facility must acknowledge them. Attestation is not required. These tags appear in tardiness reports and emails when appropriate. PNC tags are included on the standard CMS-2567 form; A-level tags print on the separate A-form.



When a facility acknowledges A-level or PNC tags on the ePOC website by selecting the Acknowledge button on the Plan of Correction page, POC status for the tags is set to Approved. If an A or PNC tag is the last tag submitted (by acknowledging it) and the POCs for all other tags are already approved, or if the survey includes only A-level and/or PNC tags, the Final POC Approval email is sent.

---

**Note:** If the last tag a facility submits/acknowledges is A-level or PNC, the survey will automatically be closed and all ePOC attachments will be removed. In this case, the SA/RO will not be warned about the removal of attachments.

## Waived tags

The status of waived tags is automatically set to Approved upon posting to ASPEN Web: ePOC. POCs are not permitted and acknowledgment of the SOD by the facility is not required for these tags. The CMS-2567 report displays waived tags, but they are not included in ePOC tardiness reports and emails.

For tags posted prior to a waiver request, the facility must submit a POC. It can be POC text and/or something like "request waiver" or "request extension of waiver". The SA/RO can choose to accept or reject the POC and/or waiver request. If a newly waived tag is included on a re-posted survey, its status will be set to Approved, regardless of its prior POC text or status.

## Remove Approval

It may occasionally be necessary to undo approval of a POC. When you remove approval, the tag's POC status changes from Approved to Rejected. The facility will receive a POC Rejected email and can then revise the POC on the ePOC website.

***To remove a POC's approval:***

- 1 Open the **POC Approval and Rejection** window.
- 2 In the **Deficiencies** grid, select an approved tag (POC Status = Approved).
- 3 In the **Plan of Correction** area, select the **Remove Approval** button.
- 4 Click **Yes** in the confirmation message.

The message informs you that the tag's POC status will change from Approved to Rejected and its POC will be opened on the ePOC website for the facility to update.

Tags that are Past Non-Compliance, Waived, or have a Scope/Severity of level A, do not require the facility to submit a plan of correction. For these tags, the remove approval process is not available, and the Remove Approval button is disabled on the POC Approval/Rejection screen.

## Stop a Survey

If necessary, you can "stop" a survey in the POC Manager or POC Properties to completely remove it from ASPEN Web: ePOC. When a survey is stopped (in contrast to being "un-posted" or unlocked), tardiness emails are not generated and it does not appear on tardiness reports. You can filter POC Manager to display only stopped surveys, and there is also a Stopped Surveys report. You can "un-stop" a survey to make it available again to the facility on ASPEN Web: ePOC.

**To stop a survey:**

- 1 Open **POC Manager**, select a survey in the grid, and click the **Stop Survey** button (bottom of window).

-or-

Open **POC Properties** for a survey and click the **Un-stop Survey** button (bottom of Status section).

- 2 Click **Yes** in the confirmation message.

The message informs you that the survey will not be displayed on ASPEN Web: ePOC and it will not appear in tardiness emails and reports, but that any ePOC posting and POC information will be retained.

- 3 In **POC Manager** only, click **Yes** in the **Confirm Lock** message to unlock the survey, or **No** to leave it locked.

The SA/RO can modify a stopped survey if it is unlocked.

The Stop Survey button toggles to Un-stop Survey for the stopped survey.

**To un-stop a survey:**

- 1 Open **POC Manager** and filter it to display stopped surveys.
- 2 Select a stopped survey in the grid and click the **Un-stop Survey** button (bottom of window).

-or-

Open **POC Properties** for a stopped survey and click the **Un-stop Survey** button (bottom of Status section).

- 3 Click **Yes** in the confirmation message.

The message informs you that the survey will again be displayed on ASPEN Web: ePOC and appear in tardiness emails and reports.

## ePOC Email History

ePOC generates automatic email notifications at various times during the ePOC process. An email history option lets you view details about the ePOC-related emails that were sent.

**To view ePOC email history:**

- 1 Open **ACO**.
- 2 From the **File** menu, select **Email History**.
- 3 In the **ASPEN Email History** window, specify **Filter Criteria**.
- 4 Click the **Refresh** button to display ePOC emails matching the specified criteria.
- 5 Click the **View** button for an email to open it.

## ePOC Reports

ePOC management reports are available in ACO and ACTS on the Reports menu. You can set filters to narrow the focus of a report to your requirements.

From POC Manager and POC Properties, you can print two POC reports for single surveys. You can also print information in the POC Manager grid as a report.

### Generate ePOC Management Reports

In ACO/ACTS, you can generate the following ePOC reports from the ePOC Management Reports option in the Reports menu:

- Tardy SOD Issuance – Shows all ePOC-eligible surveys (excluding shell-only, and stopped surveys) that have not been posted to the ePOC website within specified time frames.

---

**Note:** This report is available for non-ePOC provider types as well.

---

- Tardy POC Submission from Facility (ACO and ACTS) – Shows all deficiencies for which facilities have not submitted a POC either by the survey POC due date, or within ten days of the most recent posting of the tag, whichever is greater.
- Rejected Tags Requiring Facility Follow-Up – Shows all rejected POCs for which facilities have not re-submitted a POC either by the survey POC due date, or within three days of the most recent POC rejection date, whichever is greater.
- Facilities Pending SA/RO POC Review – Shows all facilities with newly submitted or re-submitted POCs awaiting review.
- SOD Acknowledgement Missing – Shows all deficiency-free surveys for which the facility has not acknowledged review of the SOD when acknowledgement is required.
- Re-post Required Reports:
  - Surveys Changed Since Posting – Lists all surveys containing at least one tag that has been changed since the survey was last posted to the ePOC website. Includes the following information: Facility ID, CCN, Name, Event ID, Exit Date, SOD Sent date, and POC Due date.
  - Deficiencies Not Posted – Shows all deficiencies that have not been posted.
- Plan of Correction Audit Trail – Shows all POC activities (submissions, re-submissions, rejections, approvals, etc.) for a specific facility or group of facilities and identifies staff members who performed each action. Rejection reasons/explanations, approval comments, and rejection comments are included.

---

**Note:** This report can be printed for a selected survey from ePOC Properties and the POC Manager.

---

- Survey POC Information – Displays detailed POC data with Initial Submission, Latest Rejection, Last Approval, and Completion (X5) dates for each tag as well as the following information for the survey: Event ID, SOD sent date, POC Due date, POC Rcvd (Received) date (date of the first POC submission for any tag on the survey), POC Last Submitted (date of the last POC submission for any tag on the survey), POC Last Rejected date (date of the last POC rejection for any tag on the survey), and POC Final Approval date (last approval date for all non-0000 and 9999 tags on the survey).

---

**Note:** This report can be printed for a selected survey from ePOC Properties and the POC Manager.

---

- Deficiency Free Surveys – Shows all deficiency-free surveys.
- Stopped Surveys – Shows all surveys that have been stopped.

- Unlocked Surveys – Shows all surveys that are unlocked. Includes the following information: Facility ID, CCN, Name, Event ID, Exit Date, SOD Sent Date and POC Due Date.
- ePOC Web Users Reports (Filterable by Facilities with CCN, without CCN, or both with and without CCN):
  - Facilities Having ePOC Users – Lists the facilities and the ePOC users at those facilities.
  - Facilities Without ePOC Users – Lists facilities with no active ePOC users.

---

**Note:** With the exception of the SOD Acknowledgment Missing and Deficiency Free Surveys report, deficiency-free surveys (those having tags 0000 and 9999 only) are not included in ePOC reports. Corrected tags and stopped surveys, except for the Stopped Surveys report, are also excluded from ePOC reports.

## Customize ePOC Management Reports

The report customization window, which opens automatically when you select an ePOC management report from the Reports menu, lets you set multiple filters to narrow the focus of the selected report. The name of the report appears in the title bar of the customization window. The generated report will reflect the filter options you choose. Default settings are used if you make no selections.

You can filter ePOC reports by survey status and type, survey date range, management unit, work unit, primary facility type, facility operating status, survey category, survey POC status, and facility ID. The Print Report Definitions option lets you include the specified filtering criteria and a Survey Category Key (i.e., list) in the report.

In ACTS, the Survey Category filtering option defaults to A-Complaint Investigation and 3-Licensure Complaint. In ACO, the default Survey Category filtering option is All.

---

**Note:** The Survey Category Key does not appear in ePOC Web Users Reports.

---

***To customize a report:***

- 1 To set filters in the report customization window according to a saved report specification, select it from the **Recall a Previous Report Specification** list.
- 2 For **ePOC Web Users Reports** only, select a **Sort By** option. To sort the report in descending order, select **Desc**.
- 3 Select **Survey Status** and **Survey Type**.  
These filters do not appear for ePOC Web Users Reports.
- 4 Select **Print Report Definitions** to include filtering criteria and a Survey Category Key (i.e., list) on the last page of the report.  
The Survey Category Key does not appear in ePOC Web Users Reports.
- 5 To specify a date range: select the desired **Base Timeframe On** option and enter **From Date** and **To Date**. If you do not want to set a date range, select **Show All**.

The date range filter does not appear for ePOC Web Users Reports.

---

**Note:** For the Tardy SOD Issuance report only, Calendar/Business Days options appear, but they are disabled unless the Facility Type filter includes any facility types not enabled for ePOC, i.e., any type other than NH.

---

- 6 To set **Management Unit**, **Work Unit**, **Facility Type**, **Operating Status**, and **Survey Category** filters: Click the applicable **Definition** button and, in the window that opens, select the desired items; click **OK** to close.  
 ➡ Use **Select All** or **Deselect All** to select or deselect all items in the selection window.

The selected criteria are listed on the applicable Definition button.

The Survey Category filter does not appear for ePOC Web Users Reports.

- 7 To set the **POC Status** filter: Click the **Definition** button and in the **Citation POC Status Filter** window, select **ePOC Survey Status** and **ePOC Citation Status** option(s). Also choose whether to include **Surveys with at least one citation meeting selected status** or only **Surveys with all citations meeting selected status**.  
The specified criteria are listed on the Definition button.  
This filter doesn't appear for ePOC Web Users Reports.
- 8 To set the **Single Facility ID** filter: Click the **Definition** button and, in the **Find Facility ID** window, search for and select the desired facility.  
The facility ID appears on the Definition button.
- 9 To change the setting for a filter on the **Definition** button back to **All**, click the little red bar in the **Set All** column.  
You may have to scroll right to see the bar.
- 10 To save the criteria you have specified for later use, select the **Save Report Specification** checkbox and enter a **Report Specification Name**.

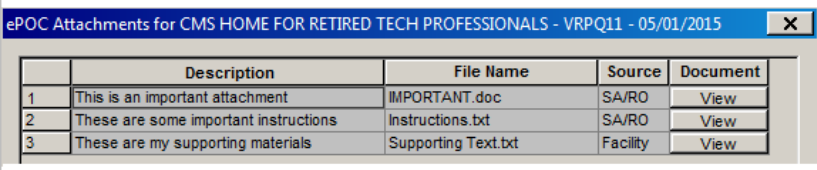

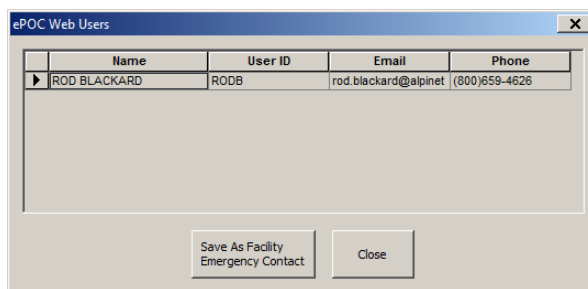


Figure 11: ePOC Web Users window

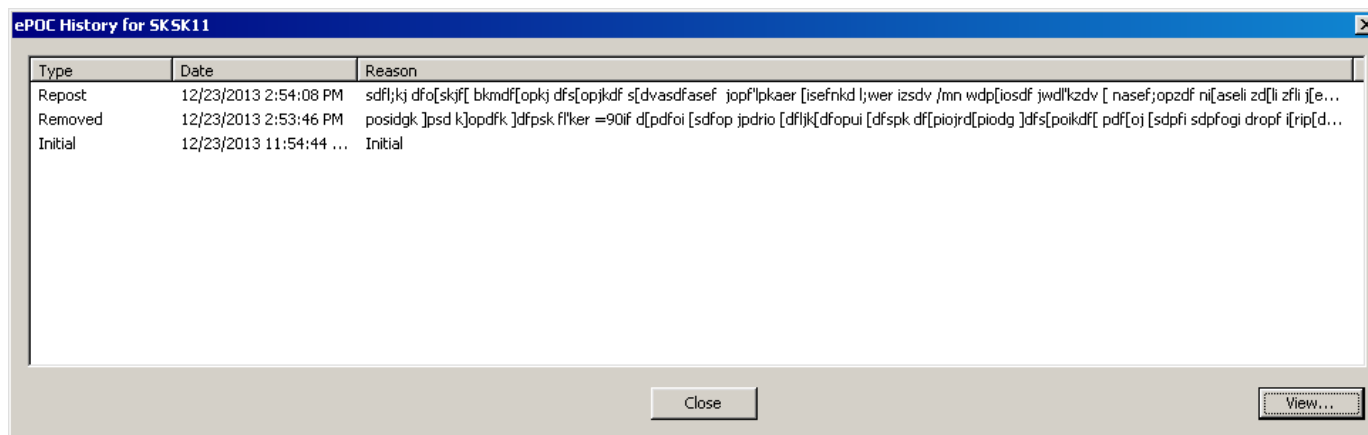

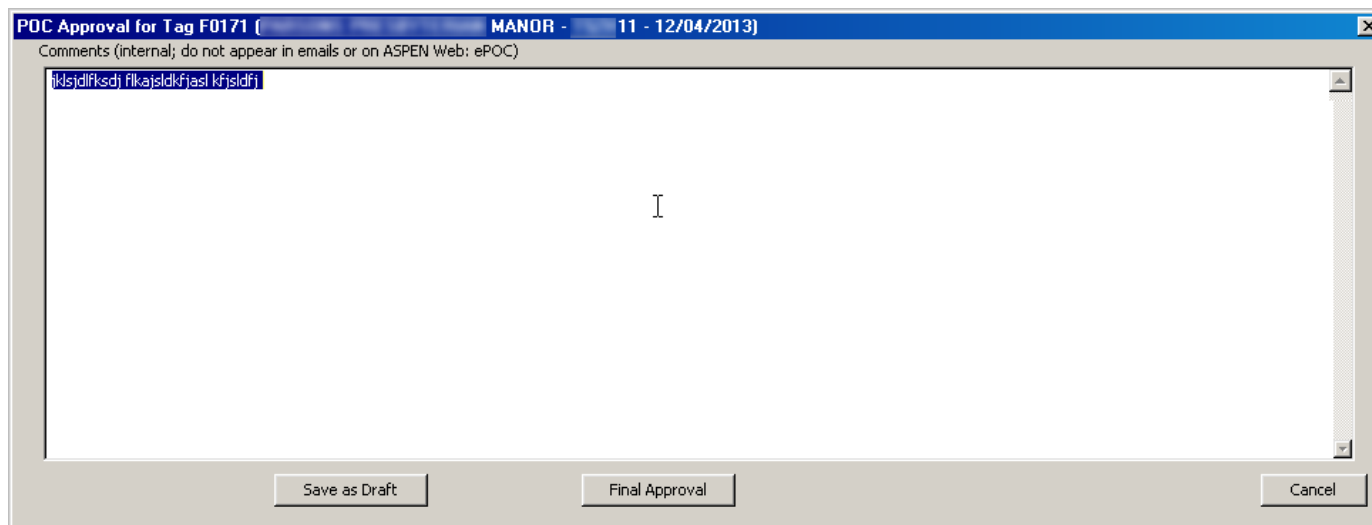


Figure 19: POC Approval window

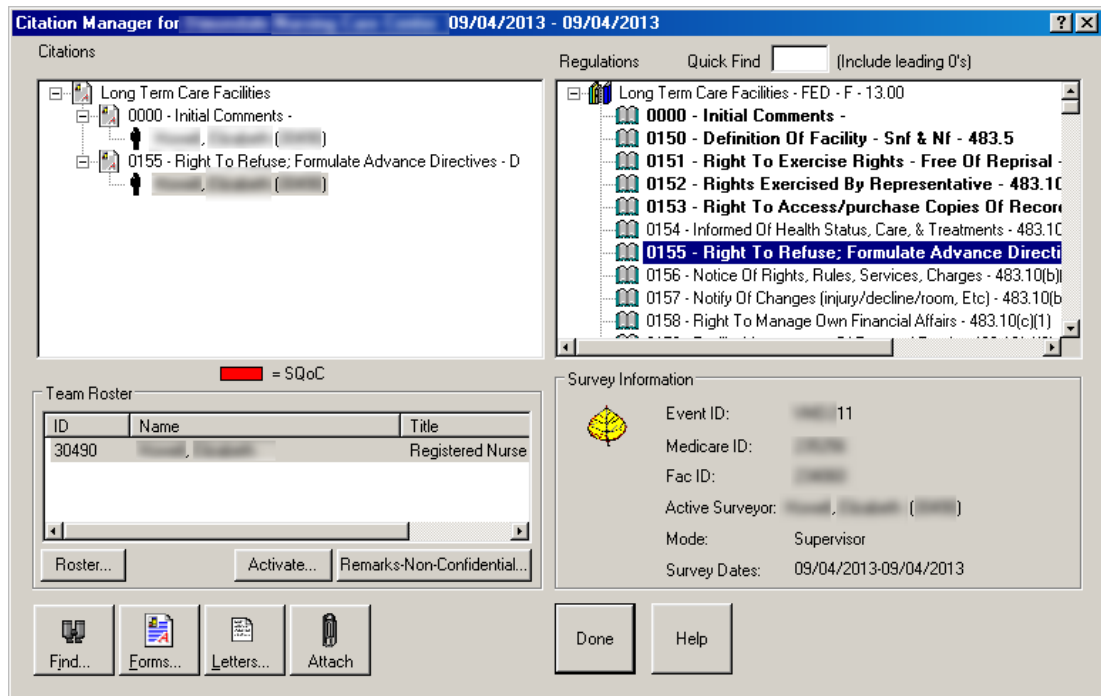


Figure 22: Citation Manager

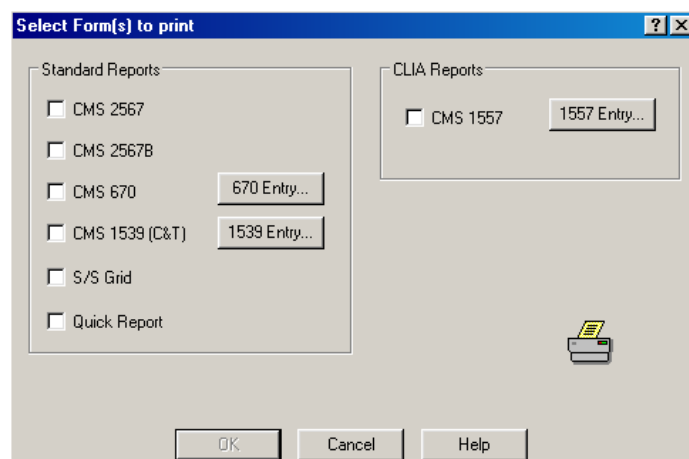


Figure 23: Survey Form(s) to print dialogue

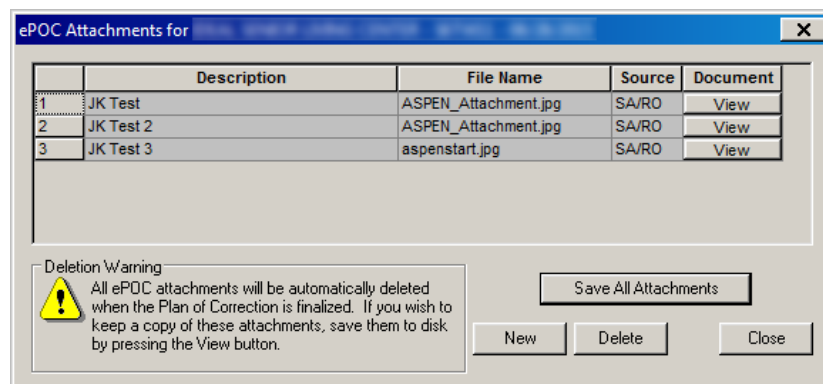


Figure 24: ePOC Attachments window

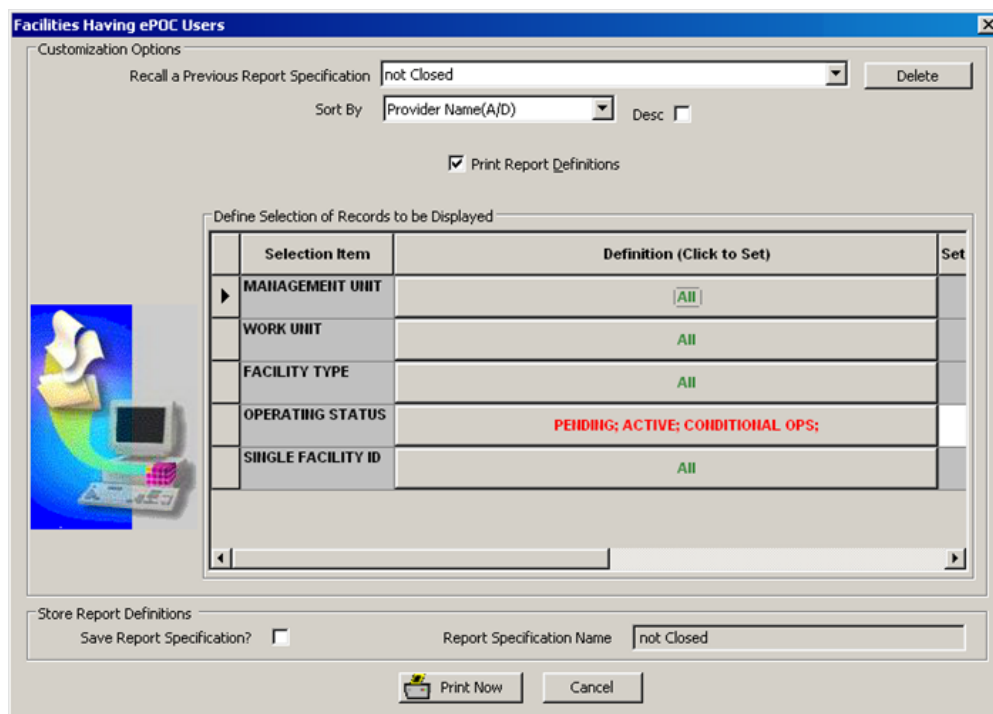

Status of the letter (Batched/Printed).

**Locked**

Locked Status of the letter (Yes/No).

## ***Survey Letters for ePOC Display: Buttons***

### **View/Print**

Opens the selected letter for viewing and printing.

### **New**

Select to create a new survey letter. It will be added to the Survey Letters for ePOC Display list to select for posting. Survey letters can be added for a survey already posted to ASPEN Web: ePOC.

---

**Note:** Enforcement and intake letters are created in AEM and ACTS respectively. Do **not** generate enforcement or intake letters from POC Properties.

---

### **Alert Facility**

Select to generate the Letter Notification email, which informs the provider that a new or revised survey letter has been posted to ASPEN Web: ePOC.

Enabled only for posted surveys.

---

**Note:** The button is enabled for stopped surveys although the email is not sent for stopped surveys.

---

## **Responsible Parties**

### ***Responsible Parties: Grid***

To add a responsible party, click the appropriate button to the right of the Responsible Parties grid, and select an individual or team from the drop-down list. POC Responsible Parties receive SA/RO-targeted emails (if so configured via the SA/RO Email Recipients settings) throughout the POC process. Also, the POC Manager supports filtering to display only surveys solely for which the current user is a responsible party.

### ***Responsible Parties: Buttons***

#### **Add S.A.**

Displays Select SA Member window to allow users to select an SA member to be the responsible SA.

#### **Add R.O.**

Displays Select RO Member window to allow users to select an RO member to be the responsible RO.

#### **Add Facility Team/Work Unit**

Adds all members of the facility Team/Work unit (as selected in Facility Properties) as responsible parties.



### **Add Survey Team**

Adds all members of the survey team (as selected in Survey Properties) as responsible parties.

### **Add Intake Resp Parties**

Adds all responsible parties assigned to intake(s) linked to the survey as POC responsible parties. A message appears if no intakes are linked to the survey or no responsible parties are assigned to linked intakes.

### **Delete**

Deletes the highlighted responsible party.

## **Status**

### **Posted**

POC post date.

### **Provider First View**

Date the provider first viewed the POC.

### **By Web User**

Read-only. Name of the facility web user who first viewed the posted survey on the ePOC website.

### **POC Status**

Current POC status. Options are: Open, Closed, Stopped.

### **Locked**

Locked Status of the POC (Locked/Unlocked).

### **Unlock Survey for SA/RO Updates button**

Unlocks the survey without removing the posting to allow users to update the survey. Button toggles to Lock Survey to Prevent SA/RO Updates when the survey is unlocked.

---

**Note:** If you unlock a closed survey, it is automatically re-opened. A message reminds you to close and lock the survey when finished with changes.

---

### **Stop Survey**

Removes the survey from ASPEN Web: ePOC. Stopping a survey also excludes the survey from ePOC tardiness emails and reports.

Toggles to Un-stop Survey for a stopped survey.

## **Status: Buttons**

These buttons are at the bottom of the POC Properties window.

### **POC Tracking**

Opens the POC Tracking window. Enabled only if POC information was entered before the facility was activated for ePOC.

### **POC Approve/Reject**

Opens the POC Approval and Rejection window.

### **ePOC Attachments**

Opens the ePOC Attachments window to display ePOC-related files the SA/RO attached to the survey and files the facility attached to support the Plan of Correction until final POC approval. If ePOC attachments exist, a number is displayed between parentheses on the button.

### **Report Selection/Report**

Drop-down lists available reports. Click the Report button to print the selected report.

### **Close**

Closes POC Properties window.

## **ePOC History**

### **Type**

Type of posting: Initial, Removed, Repost.

### **Date**

Date and time of posting.

### **Reason**

Reason for posting. "Initial" is automatically entered as the reason for the Initial posting.

### **Close button**

Closes ePOC History window.

### **View button**

Opens Reason Text window with full reason text for selected posting.

## POC Approval and Rejection

### Deficiencies grid

**Tag**

Tag cited for the survey, entered from Citation Manager.

**S/S**

Scope/Severity for the tag, entered from Citation Properties.

**POC Status**

POC Status for the tag.

**POC Date**

Date the POC was submitted by the facility.

**Completion (X5)**

Date by which the provider indicates the deficiency will be corrected.

**Title**

Tag title.

**Posted**

Date the tag was posted to ASPEN Web: ePOC. If no date, the tag has not been posted and has not yet been seen by the facility.

**Changed**

Indicates whether the tag was changed since it was posted to ASPEN Web: ePOC.

**IDR Status**

Displays current IDR status of the tag. Tags that have been removed due to IDR or Hearing/Settlement appear with a strike-through line on the text.

**CFR**

Displays CFR for the tag.

### Deficiency [tag number]: Detail

Read-only text box that displays regulation and deficiency text.

**View Posted button**

A warning message and this button appear if the posted version is different; click button to view the posted version.

## Plan of Correction

Read-only text box that displays the facility's plan of correction text as entered on ASPEN Web: ePOC.

---

**Note:** If the POC completion date (X5) for a POC is more than 6 months after the survey exit date, a warning message is displayed under the Plan of Correction panel.

---

### **POC Buttons**

#### **Approve**

Opens the POC Approval window for draft or final approval of the POC for the selected tag. Enabled if the status of the tag is Submitted, Draft Approval, or Draft Rejection. Disabled for comment/memo tags (0000 and 9999) or if there is no Posted date for the tag.

#### **Reject**

Opens the POC Rejection window for draft or final rejection of the POC for the selected tag. Enabled if the status of the tag is Submitted, Draft Approval, or Draft Rejection. Disabled for comment/memo tags (0000 and 9999), if POC Status is No POC, or if there is no Posted date for the tag.

#### **History**

Opens the POC History for Tag window with submission and approval/rejection history for the POC. Disabled for comment/memo tags (0000 and 9999), if POC Status is No POC, or if there is no Posted date for the tag.

#### **Remove Approval**

Allows a user to remove the approval for the POC. Button is enabled only for tags in Approved status. Removing the approval for a POC instantly rejects the tag, sending a POC Rejection email to the facility.

## **POC Approval and Rejection: Buttons (bottom of screen)**

### **Survey Forms**

Opens the Select Form(s) to print window, from which you can print survey-related forms. You can still access the Select Form(s) to print window if a survey is locked.

### **ePOC Attachments**

Opens the ePOC Attachments window, from which you can view any ePOC-related documents attached to the survey by the SA/RO or facility until final POC approval.

**Finalize Drafts**

Finalizes all tags in Draft Approval or Draft Rejection status and sends the appropriate email to the facility for all tags. When rejection reason/explanation text exists, it is saved and included in the POC Rejection email.

**Close**

Closes the POC Approval and Rejection window.

**POC Approval****Comments**

Allows you to enter free-form text about the approval of the POC. The comments are for internal SA/RO users only and displayed only in the POC History for Tag window. They are not included in emails or displayed in ASPEN Web: ePOC. The facility will not see any comments.

**POC Approval: Buttons****Save as Draft**

Saves preliminary approval information as draft, allowing for final approval at a later time. The status of the POC is set to Draft Approval.

**Final Approval**

Approves the POC for the tag, setting the status of the POC to Approved.

If approving the final POC for a survey (i.e., the POC for the last tag without an approved POC), a warning indicates that ePOC attachments will be deleted. You can stop the approval and save local copies of the ePOC attachments first.

When the SA/RO has approved the POCs for all deficiencies on the survey, ASPEN automatically closes the survey and the facility receives a Final Approval email. The survey can be re-opened if needed (e.g., for IDR) via Survey Properties.

**Cancel**

Deletes any information entered in the Comments field and closes the POC Approval window.

## POC Rejection

### POC Rejection: Grid

#### Selection

Allows the user to select the associated rejection reason. At least one rejection reason must be selected to reject the POC for the tag.

#### Reason

Select one or more reasons (by clicking associated Selection checkboxes) to reject the POC for the tag. Selected reasons are included in the POC Rejected email to the facility and displayed in ASPEN Web: ePOC. When you select a Reason, the corresponding Explanation text field is enabled.

For licensure-only surveys, state-specific rejection reasons may be listed as well as federally specified reasons. They will appear only if a state licensure regulation set is assigned to the survey and a state tag is cited. State-specific rejection reasons are defined in System | Lookup Values | Dictionary | EPOC\_SURVCITE\_RJCT | RJCT\_CD; the displayed Reason text must be entered as Extra Info in the Input Lookup Values window.

#### Explanation

Enter an explanation (up to 200 characters) of why the rejection reason was selected. Required for rejection reason Other; optional otherwise. Included in the POC Rejected email to the facility and displayed in ASPEN Web: ePOC.

---

**Note:** If a reason is deselected, the explanation text is removed.

---

### Comments

Allows you to enter free-form text about a rejection of the POC. The comments are for internal SA/RO users only. The facility will not see any comments. They are not included in emails or displayed in ASPEN Web: ePOC.

### POC Rejection: Buttons

#### Save as Draft

Saves preliminary rejection information as draft, allowing for final rejection at a later time. The status of the POC is set to Draft Rejection.

#### Final Rejection

Rejects the POC for the tag, setting the status of the tag to Rejected.

#### Cancel

Cancels any information entered and closes the POC Rejection window.

### Approval Comments/Rejection Detail

As applicable for the tag selected in the grid, displays approval comments or rejection comments and rejection reasons/explanations entered by the SA/RO. Neither section is displayed if not applicable, e.g., selected action is No POC.

All comments are for internal SA/RO users only; facility users will not see them. Facility users *can* view final rejection reasons/explanations in ASPEN Web: ePOC.

## ePOC Attachments

When the final POC for a survey is approved, all ePOC attachments are deleted. You can stop the approval and save local copies of the attachments first.

### ePOC Attachments: Grid

**Description**

Optional. User-defined description of the ePOC attachment.

**File Name**

File name and extension of the ePOC attachment.

**Source**

Indicates whether the ePOC-related file was attached by the SA/RO or Facility.

**Document: View**

Button opens an existing facility or SA/RO ePOC attachment. Some attachment types open minimized, so check your Task bar if you do not see the attachment item.

### ePOC Attachments: Buttons

**Save All Attachments**

Button allows you to save all the ePOC attachments to a local or network drive location, in a .zip file format. The default file name is the survey eventID.zip. If you are saving the ePOC attachments to the same location where a previous version of the saved attachments file already exists, the previous file version is overwritten unless the .zip file is given a unique name.

**New**

Button opens the Add ePOC Attachment window, where you can enter the optional Description and locate the file to attach.

**Delete**

Button deletes the selected ePOC attachment. You are asked to confirm the deletion.

**Close**

Closes the ePOC Attachments window and returns you to the Attachment Documents/Survey Attachment Documents window.



## Report Customization

#### Survey Type

Choose desired option: Both, Health, or LSC.

Not available for ePOC Web Users Reports.

#### Print Report Definitions

Select this checkbox to print specified filter criteria and a Survey Category Key (i.e., list) on the last page of the report.

**Note:** The Survey Category Key does not appear in ePOC Web Users Reports.

---

#### Calendar Days/Business Days

These radio buttons appear only for the Tardy SOD Issuance report, but they are disabled unless the Facility Type filter (below) includes any facility types not enabled for ePOC, i.e. any type other than NH. When enabled, use to specify which 10-day time period to use for non-ePOC surveys to include on the report.

**Single Facility ID**

Set All is grayed out when Definition = All.

## Updated POC-related Fields in ASPEN

The electronic POC process automatically updates several tag level and survey level POC-related fields in ASPEN.

### ASPEN Tag Level POC Fields

ePOC updates the following ASPEN tag level POC fields when a POC is submitted. These fields are updated only upon submission of a tag. The fields are not updated when a user saves the POC as a draft. When a Revisit is created, these fields do not carry forward from the prior survey.

#### **POC Text (SurvCite.POC)**

Set to the POC text submitted by the facility.

#### **POC Submitted Date (SurvCite.POCDate)**

Set to the first date the provider submits the POC for the tag. If a tag is rejected and POC resubmitted, the POC Date is not updated.

#### **POC Approval Date (SurvCite.POCAppr)**

Set to the date the final POC for the tag is approved.

#### **POC Complete Date (X5) (SurvCite.CompleteDt)**

Set to the date the facility indicates the POC will be completed for the tag.

## ASPEN Survey Level POC-related Fields

ePOC updates the following ASPEN survey level POC-related fields as indicated:

**Sent Date (Survey.POCSent)**

Set to the current date as soon as the SA/RO posts (releases) the survey to the ePOC facility web site.

**POC Due date (Survey.POC\_Due\_dt)**

Date the POC for all tags on the survey is due. Set to the Sent Date plus 10 calendar days when the survey is posted to ASPEN Web: ePOC *unless* SA/RO sets this date *before* posting the survey. Not reset on re-posting.

**2567/B Entry Complete (SURVEY.CMPLT\_2567\_SW)**

Indicates all 2567 or 2567B data entry in ASPEN is complete. Checkbox selected when the survey is posted to ASPEN Web: ePOC if it is not already selected.

**POC Received Date (Survey.POCRecvd)**

Set to the date when the facility has submitted a Plan of Correction for all deficiencies on a survey that require a POC.

**Survey's POC Approval date (Survey.POCAppr)**

Set to the date the final POC for the last tag is approved.

**Survey's Admin Signoff (X6) date (Survey.Admsignoff)**

Set to the date when the facility has submitted a Plan of Correction for all deficiencies on a survey that require a POC.

**Note:** Certification kits and investigations including ePOC surveys without federal tags (deficiency-free or only state and/or EP tags cited), which therefore do not require a POC, will successfully upload even if a Signoff date exists.
