
Rate setting board

Rate setting board (RCW 74.39A.530)

RSB established and on the Governor's website

- 14 members (4 voting)
- Rate identified July 1st of even-numbered years
- Submitted to OFM by October 1st
- Legislature will approve/reject
- Implements on July 1st of odd-numbered years



CDE outreach

IP baseline readiness assessment – high level results

- 4,545 respondents
 - 44,728 IPs w/current contracts and recent claims
 - 10.16% response rate
 - 99% confidence within margin of error of 2%
 - 2,158 shared ideas on how to inform clients and IPs
 - 993 expressed interest in participating in the pilot
 - 574 responded with their contact info


IP baseline readiness assessment – next steps



IP baseline readiness assessment – Communication discussion


How receives info


