My Care My Right - Did You Know?

People from around the world have been impacted by a life-limiting illness – either personally or by supporting a loved one. World Hospice Day for 2019 will be on Saturday, October 12. World Hospice and Palliative Care Day takes place on the second Saturday of October every year and Voices for Hospices takes place on the same date every two years.

Local Leaders, Volunteers, Advocates, and Clinicians will be volunteering their time to provide individual care and rights information. This year's theme will be: "It's "My Care, My Right." The goal of My Care, My Right is to communicate that palliative care can be demanded by the

public - and that together every person, impacted by a life limiting illness, can influence their policy makers to prioritize palliative care financing under Universal Health Coverage.

The sub-theme of My Care, My Right will address the importance of mobilizing communities, particularly volunteers to ensure a patient's right to care is supported.

We asked Health Home Leads and trainers for recommendations of what Care Coordinators should bring to their initial home visit. Some agencies even make their own Home Visit Checklist. Here are their combined responses!

- Create a folder to take with you that includes everything you will need for the client
- Client phone number and current address. directions or specific instructions on parking
- HH Participation Authorization and **Information Sharing** Consent form
- ROI for SUD
- HH Adolescent **Information Sharing** Consent (if necessary)
- PAM/PPAM/CAM
- KATZ
- ❖ PHQ-9/PSC-17

- BMI
- All optional assessments (Pain, Falls, DAST, AUDIT, and GAD-7)
- Advanced directive literature
- Paper HAP
- Goal Planning worksheet
- Crisis number and nonemergency police number
- Other numbers for common resources/referrals
- List of numbers for local community resources (food bank, DME lending programs, etc.)
- List of DSHS workers (APS, case manager, financial workers)

- HH brochure

I diagnosed "abdominal pain" when the real problem was hunger, I confused social issues with medical problems in other patients, too. I mislabeled the hopelessness of long-term unemployment as depression and the poverty that causes patients to miss pills or appointments as noncompliance. In one older patient, I mistook the inability to read for dementia. My medical training had not prepared me for this ambush of social circumstance. Real-life obstacles had an enormous impact on my patients' lives, but because I had neither the skills nor the resources for treating them, I ignored the social context of disease altogether.
