# Mental Health Counseling

Licensed Mental Health Counselors apply principles of mental health counseling theory and methods, use specialized knowledge gained from experience in forensic mental health settings, conduct assessments, and provide case management, advocacy, and counseling. Mental Health Counselors working in forensic behavioral health also have knowledge of the criminal court system and issues which exist where behavioral health and the law intersect

## **Forensic Behavioral Health**

Forensic behavioral health is the intersection of behavioral health and the law. The system itself involves various entities that have a touchpoint to people who are involved with the criminal court system and may have a behavioral health condition.

Choosing a career as a practitioner in this human services field offers many diverse work environments. Examples include, working with law enforcement in co-responder roles or in a corrections setting; in inpatient settings such as state psychiatric facilities and residential treatment facilities; and in community settings such as outpatient competency restoration programs, or community behavioral health agencies. Service providers in this field often interact with legal partners such as lawyers and judges, corrections officers, and first responders.




## Pathway to Forensic Behavioral Health Mental Health Counselor

## **Examples of Work Environments**

Typical work environments for Mental Health Counselors include community settings as Forensic Navigators, Mental Health Counselors in state facilities or private behavioral health hospitals, discharge planners in correctional settings, crisis outreach or diversion specialists as part of a co-responder team with law enforcement, designated crisis responders, or recovery liaisons/discharge coordinators with community behavioral health organizations.
