<p>Review of Committee Leadership/Reporting Structure Kathy Smith-DiJulio</p>	<p>The committee purpose and goals were reviewed in light of changes that have occurred to the Quality Improvement infrastructure since this group was formed as well as the fact that most measures are now defined and in place for ongoing monitoring. Committee attendance has been falling for several months. Conversation is good but action is limited, occurring largely in other forums, DBHR QIC and statewide FYSPRTs, for example. A request was made to have members of this team present WISE Annual Report data to the statewide FYSPRT taking 1-2 hours to have a meaningful discussion.</p>	<p>It was decided to meet to review "dashboards", e.g., foster care and WISE, and other times as needed. Committee members can propose agenda items at any time and call a meeting. A doodle poll will be sent out to agree on a meeting time (since a particular time will not be held on calendars). It was decided that the meeting should have co-chairs, Kathy will continue from DBHR and partner with Lin Payton from HCA (in preparation for statewide fully integrated managed care in 2020). Kathy will take the statewide FYSPRT agenda request to the System of Care Implementation Team to schedule.</p>
<p>Foster care dashboard Barb Lucenko</p>	<p>The foster care dashboard was reviewed with suggestions made for the next update. It is anticipated that this will be an annual report.</p>	<p>Barb Lucenko will take suggestions back to RDA to include in the next update cycle.</p>
<p>WISE annual report 4th quarter BHAS reports</p>	<p>The Quarterly data review cycle of BHAS reports is going well. RCR continues to make software changes which impacts reports. RSN reviews of 4th Quarter</p>	<p>Continue quarterly review cycles with reports reviewed by the Children's Team, DBHR QIC and each RSN.</p>
