

## Overview of Publicly Funded Services Substance Use Prevention, Treatment and Recovery

### Introduction

This overview provides information about funding, types of services, eligibility, and numbers of people served through publicly-funded alcohol and drug use services.

### Funding and Numbers Served

Total funding for the 2011-13 Biennium is \$365,043,000. The funding sources are:

- General Fund –State: \$144,960,000
- General Fund –Federal: \$184,401,000 (Medicaid, Federal Grants)
- Other State: \$22,196,000 (Criminal Justice Treatment Account, Problem Gambling)
- Local: \$13,486,000

The total number of clients served in FY 2012 was 63,518.

### How Services Are Delivered

Funding is provided in the following manner:

- Counties – Counties subcontract with local providers to deliver outpatient and support services to clients in need of services.
- Tribes – Tribes deliver prevention and treatment services to Tribal members.
- Residential – DBHR directly contracts with providers to deliver residential treatment services.
- Pregnant and Parenting Women (PPW) – DBHR directly contracts with providers for support services for women who need treatment, or are recovering.
- Prevention – DBHR contracts the Office of the Superintendent of Public Instruction (OSPI) and with counties, who subcontract with local providers to prevent children and teens from using alcohol, tobacco and other drugs.

### Types of Services Available

- Assessments for Drug Dependency
- Detoxification
- Outpatient and Residential Services for Adults, PPW and Youth
- Involuntary Treatment
- Opiate Substitution Treatment
- Case Management
- Outreach
- Fetal Alcohol Syndrome Diagnostic and Prevention Network
- Parent Child Assistance Programs
- Safe Babies, Safe Moms
- Therapeutic Childcare

## **Eligibility Requirements**

DBHR funds substance use services for people with substance use disorders who are Medicaid eligible and low-income. Priority for treatment is given to pregnant women, injecting drug users, youth, and parenting adults.

## **Availability of Services**

Prevention and outpatient treatment services are available in each county and most Tribes.

### Adult Residential Beds Statewide

- Intensive Inpatient 485 beds
- Long Term Residential 65 beds
- Recovery House 30 beds

### Youth Residential Beds Statewide

- Level I Inpatient 39 beds
- Level II Inpatient 100 beds
- Recovery House 36 beds

### PPW Residential Beds Statewide

- Women with Children 146 beds
- Women without Children 7 beds
- Therapeutic Childcare 130 slots

## **Other Services**

The following special projects are funded by federal demonstration grants:

- Washington Screening, Brief Intervention, and Referral to Treatment (WASBIRT)
- Access to Recovery (ATR)
- Reducing Underage Drinking
- Washington Court and Recovery Enhancement System (WACARES)
- Adolescent Treatment Enhancement and Dissemination

Administrative and technical support for all programs is provided through state and federal funding (SAPT Block Grant, GF –State, Medicaid) including:

- Policy Development
- Fiscal and Program Planning
- Training/Workforce Development
- Agency Certification
- Information Services
- Legislative and Regional Coordination
