The Art of Stepping Back (2CEUs)

This class explores the importance of listening in all aspects of life focusing on developing strategies for being a better listener, establishing trust with the individual you are communicating with, developing a listening attitude, using "listening" behaviors, and being an active listener. There is group work and video scenarios on active listening including ways to open the door to communication and keeping the door open, asking questions and proper paraphrasing.

Participants will: Learn the benefits of humor in the home workplace and community. Learn to identify positive humor and destructive humor. Learn exercises to activate or reactivate your humor. Practical applications for teaching humor to the individuals we support.
