Supporting individuals with Neurodevelopmental Disorders and/or mental health issues can require unique and individualized supports. This two-day information session will focus on how functional assessments (FA) and positive behavior support plans (PBSP's) can help individuals live successfully in the community. Training topics include:

- The regulatory framework guiding FA/PBSP's
- Person-centered planning
- Gathering history and conducting a functional assessment
- Turning the functional assessment into a plan
- Replacement behaviors
- Data collection and analysis And much more!

Participants will be introduced to DDA's recently revised preferred structure of a functional assessment and positive behavior support plan and will leave with a foundation in how to write person-centered, able-to-be implemented plans and methods to measure their effectiveness.
