### **Chapter 13: Tribal Enforcement**

Section 13.078: Central Council Tlingit & Haida Indian Tribes of Alaska (CCTHITA) Federal Offset Agreement NEW SECTION

This Section describes how to recognize a CCTHITA Federal Offset Case and identifies which DCS office manges these cases.

The Division of Child Support (DCS) performs federal offset services for the Central Council Tlingit & Haida Indian Tribes of Alaska (CCTHITA) tribal IV-D program on cases with CCTHITA Tribal Court Orders.

CCTHITA reimburses DCS for administrative costs.

Policy:

DCS must disburse IRS funds within two (2) days of receipt **except** for injured spouse allocation request, which DCS can hold up to six (6) months.

DCS holds potentially suspicious intercept payments until those payments have been verified as belonging to the NCP.

The CCTHITA IV-D completes a **Child Support Enforcement Transmittal #1** DSHS 18-570 and submits it to the Everett field office for federal offset only case set up along with relevant CCTHITA court orders and a debt calculation.

Staff set up cases referred to DCS by the CCTHITA tribal IV-D program for federal offset certification only like regular IV-D cases, rather than like in-rem cases.

**Procedure:** 

Notify the CCTHITA tribal IV-D program when you receive a complaint

from the noncustodial parent (NCP) about Internal Revenue Service (IRS) certification that results in a request for an administrative review or conference board.

Close a case opened as a result of a referral from the CCTHITA tribal IV-D program for federal offset certification action only when DCS receives a case closure request from the tribe.

### **Procedures**

# A. What is the purpose of the CCTHITA Federal Offset agreement?

- Currently, tribal IV-D programs do not have the means to interface directly with the Treasury Department for federal offset services. A tribe with an approved tribal IV-D plan may enter into a cooperative agreement with a state IV-D agency for intercept of federal offset funds for child support.
- 2. The Central Council Tlingit & Haida Indian Tribes of Alaska Federal Offset Agreement authorizes DCS to certify tribal IV-D cases for the CCTHITA Tribal Child Support Program.

## B. What are the requirements for DCS to certify IV-D federal offset cases for the CCTHITA Tribal Child Support Program?

- The Tribe:
  - a. Must ensure that the debt is based on an established Central Council Tlingit & Haida Tribal court child support order, and that the case meets the federal requirements listed in 45 CFR 303.72 (a), or successor or replacement statutes and regulations.
  - b. Requests federal offset services by sending an intergovernmental transmittal directly to the Everett field office for each NCP case they want certified. The referral must include a copy of the CCTHITA Tribal Court child support order and certification of the case debt. Open cases must be updated monthly.
  - c. Agrees to reimburse DCS for administrative service fees charged to DCS by the Treasury Department.
- C. Who handles federal offset requests from the CCTHITA Tribal Child Support Program?

The Everett Tribal Team manages these cases.
