In 2012 Bruce shared that Gene Hughes is now on Council & Chief Judge Gloria Ochoa will take lead on Start-up Appln. 2011 – Council approved Court to submit Start-up Appl'n. Port Gamble S' Klallam Tribe	Jan 2012 – First Tribe in the Nation to receive federal approval to operate a Tribal IV-E program.

TRIBE	STATUS
SPIPA (Nisqually and Squaxin Island)	Jan 2014 – Received federal approval, but SPIPA Board not yet decided about IVE. Will make decision by Sept.
Lummi Nation	2013 – Lummi Nation submitted IV-E Application Oct 2010- Tribe awarded IV-E Development Grant.
Colville Tribes	9/30/2013 – Colville Tribe awarded a IV-E Development Grant.
Muckleshoot Tribe	Hired Betsy Tulee as Title IV-E Project Coordinator, to write IV-E Development Grant. Jan 2014 call with Betsy to discuss CS connections. DCS met with Tribe on 5/28 to discuss Tribal IVD and IVE connections.
