- Pre-screening by Resettlement Support Center (RSC) staff
- On-site interview by CIS Refugee Corps (Circuit Rides)
- Security clearance & fingerprinting

State Department: Bureau for Population, Refugees & Migration

PLACEMENT



- Placement allocations through 9 national Voluntary Agencies
- Cultural orientation & departure processing
- Initial Reception & Placement: 30-90 days in U.S.

Department of Health & Human Services: Office of Refugee Resettlement

TRANSITION



- Interim cash & medical assistance
- Employment services, ESL, medical screening, recertification
- Specialized programs: Micro-Enterprise Development, IDA, Survivors of Torture...

National Context on Refugee Resettlement



Lawrence Bartlett Director, Office of Refugee Admissions Bureau of Population, Refugees, and Migration U.S. Department of State



Kenneth Tota Deputy Director, Office of Refugee Resettlement U.S. Department of Health and Human Services

Mr. Bartlett is a career member of the Senior Executive Service and has served since 2010 as Director of the Refugee Admissions Office of the U.S. Department of State's Bureau of Population, Refugees and Migration (PRM).

During his tenure the program has led the international community by resettling over 700,000 refugees for permanent resettlement to the United States.

Prior to joining the State Department Mr. Bartlett served as U.S. Peace Corps Country Director in Jordan and Bulgaria. He served as a Peace Corps Volunteer in Yemen helping implement the first national immunization program.

He is the recipient of the Warren Christopher Award for Outstanding Achievement in Global Affairs and the Presidential Rank Award in the Senior Executive Service. Ken Tota has served as the Deputy Director of ORR since 2008 and has served as the Acting ORR Director during several administration transitions.

Prior to ORR, he served as Senior Program Specialist at the Immigration and Naturalization Service where he provided oversight to the Cuban Haitian Entrant Program and Unaccompanied Children's Program (UC), and played a critical role in the transfer of the UC program to ORR in 2003.

Before entering civil service, Ken was the Cuban Haitian Program Coordinator for the United States Conference of Catholic Bishops (USCCB) in Washington, DC and Miami, FL.

Ken has a Master's Degree in Public Administration from the American University in Washington, DC.





How many people do we reach in Washington?


10,849 people received services through ORIA funded programs in 2020

- ✓ 538 Refugee Students served
- 2,152 ESL Programs Participants
- ✓ 3,838 State-funded Naturalization Services
- 7,011 Refugee Resettlement Services
- 1,768 new arrivals through the U.S. Refugee
 Admissions Program
 - o 1,114 newly arrived refugees
 - o 654 newly arrived SIVS




