

# Refugee Cash Assistance and Refugee Medical Assistance

Washington State Department of Social and Health Services

The Department of Social and Health Services' Economic Services Administration's **Refugee Cash Assistance** program is a federally funded program that provides up to 12 months of cash assistance to single and married adults with an eligible immigration status who do not have dependents.

**Refugee Medical Assistance** is a federally funded medical assistance program available to refugees and eligible immigrants for up to 12 months for those who are ineligible for Washington Apple Health. Since the expansion of Medicaid, less than 1% of all refugee and humanitarian immigrant individuals and families are ineligible for Washington Apple Health. In an average year, fewer than 50 arrivals a year receive RMA.

## DSHS seeks to improve the lives of clients receiving RCA by:

Ensuring all participants receive consistent referrals to employment, education and social service providers to support them in enhancing their English skills, finding and maintaining employment and moving towards independence.

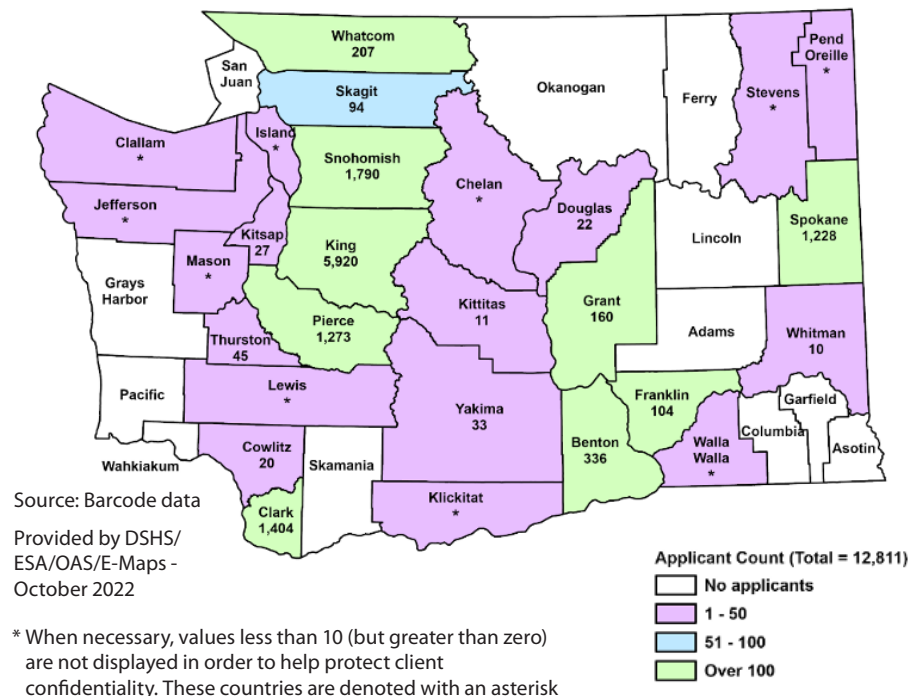
## Who is eligible for RCA?

- Refugees
- People granted asylum ("asylees")
- Certified Victims of Human Trafficking
- Citizens and nationals of Afghanistan paroled into the U.S. between July 31, 2021 and Sept. 30, 2023.
- Citizens and nationals of Ukraine paroled into the U.S. between Feb. 24, 2022 and Sept. 30, 2023.
- Amerasians.
- Cuban-Haitian Entrants.
- Special Immigrant Visa holders from Iraq and Afghanistan.

## Who are refugees?

Refugees are people who are unable to return to their country of origin due to a well-founded fear of persecution based on their race, religion, nationality, political opinion or membership in a particular social group.

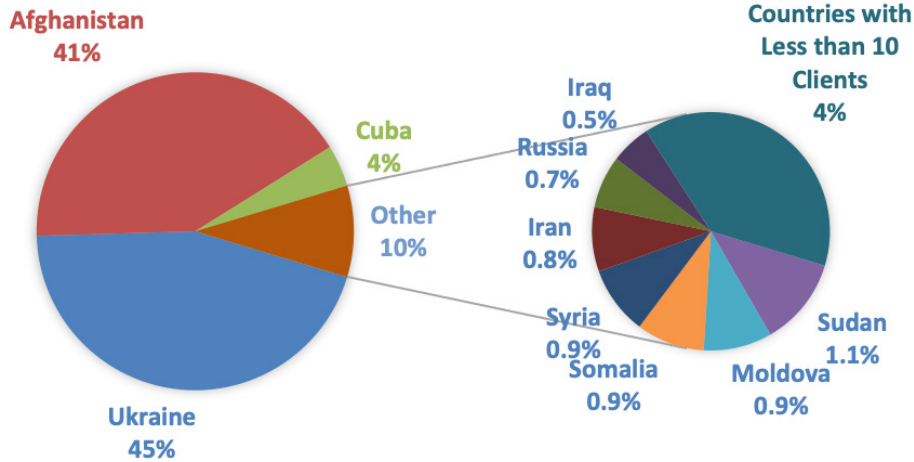
