- **Ekoch poraus mei awora ngeni ewe Department of Social and Health Services** a tongeni attaieno omw fich ne angei ika nounou insurans weiweita ika health care, fan ewe Health Care Authority me ewe Health Benefit Exchange.

- **Aipwe mina** weiweita ika awora ngonuk omw aninisin mwongo non 7 ran ika omw famini mei osupwang me ika en mei tufich ne angei "expedited service" ika aninisin atapwanapwan.
- **Aipwe ngonuk ew resiit** ika kekan tungorem.
- **Aipwe toruk ewe mwuchunon finata** me non taropwe esap mang seni 30 ran.
- **Ika kose mwochen kapas fengen me emon "Fraud Early Detection (FRED) investigator"** (weiweita ika emon chon choosa) seni ewe Ofesin Fraud and Accountability, ka tongeni erenii pwe "apw". Ewe chon choosa esap tongeni tonong non imwom ika pwe kose chok mwochen mwut ngenii. Ka tongeni tungoren an epwene niwin sefanito inet chok epwe tawe ngonuk. Met Kopwe Sinei faniten Noum We EBT Card

- **Tanon Annukun Omw Pekin Aninis:** Nupwen kopwe nounou noum we EBT card ren mwongo ika moni, ekkewe risit repwe affata ngeni DHS met ke nounou ngeni. Ewe departmen epwe nenengeni omw kewe risit, iwe epwe sinei ika ka amömöno omw kewe food stamp ika benefit.
- **Siwinin noum EBT card:** Ika pwe e poutuno noum we card iwe kopwe moni niwinin ach sipwe föri echö siwinin. Pi kopwe tumwunu fichi noum we EBT card pwan omw na nampan PIN (personal identification number).
- **"High Balance" EBT Card:** Ika kose chok aia noum we card non chomong maram, ina omw we balance epwene fen watteno. Iwe aipwe makkei ngonuk ika kokkoruk pwe aipwe tongeni refiuwini omw we account.

Met Kopwe Sinei (Basic Food)

- **Aipwe angei me aia** fengeni porausen ekkewe chon tungoren Basic Food me pwan ekoch agency pwe sipwe cheki pwungun ar tichikin poraus. Ika ka mwakken won noum kewe taropwe, ka tongeni kouno seni Basic Food. Mei wor tipis ika ka attaieno ekkewe onnukun Basic Food. Ka tongeni kouno seni ei prokram me pakking, me pwan tongeni kanopus ika pwe ke attai onnukun Basic Food.
- **Ika ka amömö, satuni ne amömö, siwini ika fangano omw kewe aninis** ren moni (cash), safei mei afeiengaw (drugs), pisekin fiu, ika pwan ekoch metoch, ina kopwe attai omw fich ne angei aninisin mwongo non ew ier, feita. Omw pakking/penalty epwe chiwen sopolosopo, ina mwo ika ka towu seni Washington ika kosap.
- **Ika Basic Food e era pwe kopwe angang**, nge kose chok fori met rekan erenuk kopwe fori, ka tongeni kouno seni ewe prokram non ew (1) maram me tori omw kopwe awesi omw we angang; iwe epwe non unungat (3) maram ren ewe orruan tanon onnuk; me epwe non wonu (6) maram ren ewe unungatin tanon onnuk, ika pwan ekkoch.
- **Ka tongeni kouno seni Basic Food** ika ke attai ekkei onnukun Basic Food, usun met mei affat non ewe tettenin pakkingen Basic Food.
- **Repotenong omw moni touu (met moni ke nounou ne kamo me iteiten maram) ika ka mwochen ewe departmen epwe onomu ekei niwin non met ke angang seni omw Basic Food.** Ika kose repotenong ekewe metoch (asan), aipwe sinei nge kose mwochen am aipwe aia porausom ne finata ika en mei tufich ne angei pwan ekkoch aninisin Basic Food.

Met Kopwe Sinei (Moni ika Cash)

- **Ika ka angei aninis seni ewe prokramen Temporary Assistance for Needy Families (TANF)** iwe en mei mutauu omw kewe pwuung ngeni ewe Division of Child Support. Wewen nge ika ka angei child support nge kose fen repotenong met kekan angei, iwe DCS e tongeni eimwunauu ika emwochu met kekan fen resiif seniir. **Mei auchea kopwe mwitir repotei ngeni DCS ika ka resiif monien child support** ika pwan ekoch pekin aninis non fansoun omw nonom won TANF.
- **Ika kose chiwen resiif TANF**, mei chiwen namwot omw kopwe repotei ngeni DCS ika a wor akesiwinin nonomwum, weiweita ika noum we semirit ekan mwokut ika siwini an address ika pwan ekoch.
- **Ika ka resiif TANF, ka tongeni tungoren pwan ekoch moni** non fansoun atapwanapwan ren “temporary emergency housing”.
