

Public Safety Review Panel

Minutes for the November 19, 2015 Meeting Conducted via Conference Call

1. Call to Order:

The meeting convened at approximately 10:05 a.m. with a quorum of members present: John Chiles, David Hackett, Kari Reardon and Donta Harper. And non-voting Lori Melchiori.

Not Present: Tony Hernandez and Terri Mayer
The Clinical Psychologist membership is vacant.

2. Business Meeting: 10:00 – 10:55

A. The Clinical Psychologist membership on the Panel remains vacant. Lori will again contact the Governor's Office of Boards and Commissions to inquire about the status of recruitment and emphasize the Panel's desire for a Clinical Psychologist appointee to join the PSRP as soon as possible.

B. BHSIA Updates:

- a. Tim Hunter, State Hospital Forensic Policy and Legislative Administrator provided updates on various activities and efforts underway related to both hospitals; and he conveyed a communication concern of ESH.
- b. Holly Borso, Behavioral Health Program Manager, and the members discussed 1114 Program patients' commitment status and referral to the PSRP.

C. PSRP Position Effective October 2015:

- a. The PSRP has determined it has jurisdiction under RCW 10.77.270(1) to only accept for review a referral involving a hospital patient who is currently civilly committed under the provisions of HB 1114 through an initial 180 day commitment under RCW 71.05.280(3)(b) or a renewed 180 day commitment under HB 1114 [the 280(3)(b) provisions of RCW 71.05.320(3)(c)];
- b. The PSRP will decline to review a referral if the grounds for a patient's commitment was converted from HB 1114 to a standard RCW 71.05 commitment with the "gravely disabled" provisions as the sole basis for current commitment; and
- c. Consistent with the jurisdiction of the PSRP as delineated in RCW 10.77.270(1), the Panel will review the referral that is required from the hospital under RCW 10.77.270(1) anytime there is a recommendation "for a change in commitment status" as when the hospital is proposing to convert a commitment from HB 1114 criteria to gravely disabled grounds.
