Child Support NonWage Enforcement Program (NWEPE)

Information for dealers and lenders about the Division of Child Support's personal property liens



DCS Division of Child Support

This brochure is for you if:

- You are a dealer or lender involved in the sale of automobiles, motorcycles, vessels, trailers, RV's, or motor homes, and
- You record transactions through the Department of Licensing.

What is the NonWage Enforcement Program (NWEP)?

The Department of Social and Health Services (DSHS), Division of Child Support (DCS) files NonWage Enforcement Program (NWEP) liens, with the Department of Licensing (DOL), on personal property to collect delinquent child support. We file liens on:

- Cars
- Trucks
- Motorcycles
- Vessels
- Trailers
- RV's and mobile homes.

How could a DCS lien affect me?

When you buy, sell, or trade a vehicle, our liens allow us to collect money toward a delinquent child support debt. DCS liens affect you if you are a:

- Vehicle dealer
- Vessel dealer and lender
- Auctioneer
- Towing company
- Insurance company
- Mechanic
- Landlord
- Property manager
- Private Citizen

Should I report buying or selling assets?

We encourage dealers to do a DOL title search to avoid problems when buying or selling an asset. Problems occur when dealers do not file a DOL *Dealer Notice of Purchase or Sellers Report*.

What happens when DCS files a lien?

When DCS files liens with DOL Vehicle Services Division, Title and Registration Services, DOL creates a new registration and Certificate of Title. The legal owner section of the title shows who the lien holders are. For example:

1. DCS as the only lien holder:

DSHS/Division of Child Support
Central Operations – NWEP
PO Box 9008
Olympia, WA 98507-9008

2. DCS and a primary lender:

DSHS/DCS/NWEP – Lien 2
Primary Lien Holder name – Lien 1
Primary Lien Holders mailing address

Who is notified when DOL records the lien?

- DOL sends a *Notice of Cancellation* to the registered owner and to any primary lien holder.
- DOL sends a confirmation to DCS.
- DCS sends a *Notice of Intent to Seize Property* to the registered owner.
- DCS sends a *Notice of Secondary Lien* to the primary lien holder.

Are DCS liens honored in other States?

Yes. The following states recognize and honor our liens: Idaho, Illinois, Montana, New Mexico, Oregon, and Tennessee.

What happens when DCS files a lien?

If the registered or legal owners address changes, contact DOL. Many owners do not receive important titles and notices because of bad addresses.

Who is notified when DOL records the lien?

Some dealers ask customers to declare liens filed on their vehicle. It is a “**false**” sale, if people with child support debts do not declare DCS liens when trading or selling an asset.
