What is the Turnaround Time?

The turnaround time of a background check depends on:

- ❖ The volume of checks received.
- ❖ The amount of research required for that inquiry.
- ❖ The number of staff available to process.

If the applicant has an out of state crime, BCCU requests a review to determine if the out of state crime is equivalent to a Washington State crime and verifies if that crime is on the [Disqualifying List of Crimes and Negative Actions](#). The amount of research involved, number of equivalencies, and staff available will determine how quickly an equivalency can be completed.

For background checks in **"Pending FP Results"** status, BCCU is waiting on WSP or the FBI to process the fingerprints and provide a result. BCCU does not have control over these turnaround times. Their turnaround times vary due to the volume of fingerprints being processed. Please do not submit multiple background checks as this will not speed up this process.

Please refer to our [Turnaround Times](#) link in BCS to get an estimate of when you will receive background check results for anything in **"Pending"** status. Turnaround times are updated daily.

✓ On average, more than 80% of background checks go through the Background Check System Quick Return process with little or no BCCU staff intervention giving requesting entities background check results same day. The other 20% of background checks require a manual review by BCCU staff.

Fingerprint Sharing

Some accounts were included in groups that were allowed to use previous fingerprint results if they were conducted for the same reason/purpose and were within the last three (3) years. Moving forward, BCS will no longer present this option as this will no longer be permitted. Please reach out to your Program Policy Contact with any questions.

3. All cancelations, no shows and scheduled appointments moving forward will also include the fingerprint site address details.

- ❖ In addition, customers will no longer have to wait to schedule an appointment once the entity elects to proceed with the fingerprint. Customers should be able to schedule as soon as the continue decision is made in BCS. Our [BCS Entity User Guide](#) has been updated with these changes.



Did you Know?

Private Home Care Agencies only allow for one fingerprint background check per employee, per account number. Any subsequent checks that are submitted will not be processed by BCCU and will show up as "withdrawn" on the entity side.
