BCCU Quick Reference Guide

New WSP RAPsheet Coming June 3, 2021

What’s Changing?

The new RAPsheet will have a more logical flow of information along with other language updates etc.

Interruption to Service?

BCCU customers should expect background check delays during this transition between 5PM on Tuesday, June 1st through early morning Thursday, June 3rd.

What’s New:

- 1 Linear flow of **Disposition Information**. Arrest information may display if arrest is within the last year and is pending disposition
- 2 *Renamed field: Subsequent Activity* is where related court orders are located (previously called Subsequent Disposition)
- 3 **DOC event** shows movement within Dept. of Corrections
- 4 **Sex/Kidnapping Offender Registration** displays where they registered, where the original charge was made (county) and charge
- 5 **Other Offender Registrations**: formerly Monitored Populations Tracking Information
- 6 **Applicant Information: New Fingerprinting Type** for Compromised Identity

New Dispositions	Defined
Continued	<p>When “Continued” is listed as the disposition, this means the subject has entered into a deferral. “Continued” will remain until a final disposition is entered and/or conditions are met.</p> <p>If a Dismissed disposition is received from the court, the court researches:</p> <ol style="list-style-type: none">If there is <u>no plea of guilt</u>, Continued is replaced with “DISMISSED.”<ul style="list-style-type: none">This is Not Adverse to the person and will no longer appear on the conviction RAPsheet.If there is a <u>plea of guilt</u>, the Continued is replaced with “OTHER DEFERRAL” and the dismissed information is entered into the Subsequent Disposition field.<ul style="list-style-type: none">This is Adverse to the person (meaning not favorable) and will appear on the conviction RAPsheet.
Pending	<p>When “Pending” is listed as the disposition, this means the outcome has yet to be determined.</p> <p>“Pending” arrests will appear on a conviction RAPsheet up to 1 year. After 1 year, these will drop off the RAPsheet unless a disposition status is reached that does not result in non-conviction.</p> <p>When a final disposition is entered by the court, the disposition of pending is replaced by the final disposition.</p>
