



DSHS HIPAA Covered Programs

As a covered entity, DSHS must notify affected clients of Health Information Portability and Accountability Act (HIPAA) [privacy rights](#). (45 CFR 164.520). As of May 3, 2013, DSHS is declared to be a “hybrid covered entity,” meaning not all DSHS client programs are covered by HIPAA. Only the client programs listed as Health Care Components (HCC) below are covered by HIPAA. Programs listed as Non Health Care Components (Non HCC) are not covered by HIPAA but are still subject to applicable state and federal confidentiality requirements.
