DSHS Notice of Privacy Practices for Client Medical Information Muhtwacwacack ke November 1, 2025

DSHS enenuh in fwak nuh sum kacł HIPAA (Health Insurance Portability and Accountability Act, [Masap in Karihngihn ac Sefiyac Insurance ke Mas]) ac luhan kuht nuh ke ohiyacn karihngihn mwe aketeyae. (45 CFR §164.520). DSHS pa sie "u su kuhpahsryang." Tiac mwe akwuck nuh kwewa lun DSHS pa oasr ke HIPAA, prokracm mukwena su akwucklac oacna [Health Care Components fin website](#) lun DSHS pa oasr ke HIPAA. Mwe fwak se inge nuh ke mwet eis mwe kasru mukwena su oasr ke prokracm ingacn. Mwe fwak se inge ac fah tiac oruh kuhtuh nuh ke kuht lom in eis mwe kasru lun DSHS.

Mwe fwak se inge ahkkahlwemye ohiyac mwe aketeyae ke mas lom fah orekmakihnyuck ac akacsruhyuck ac ohiyac kom kuh in eis mwe aketeyae se inge. Nunak munas liye wo ma se inge.

- Meac pa PHI?** PHI (Protected Health Information) (Mwe Aketeyae ke Mas su Karihngihnyuck) pa mwe aketeyae ke mas lun mwet eis mwe kasru su oasr ye kolyuck lun HIPAA ke DSHS. PHI pa mwe aketeyae ke mas su kuhpahsryang nuh sum kacł luhan mas lom, mwe kasru ke mas kom eis, kuh mwe mahlwen nuh ke mwe kasru lom ke mas. DSHS enenuh in karihngihn PHI lom ke masap.
- Meac mwe aketeyae PHI lun DSHS oasr kaci?** In kasru kuht in kasru kom, kom ac enenuh in use mwe aketeyae ke mas kuh mwe aketeyae ke mahollom weacng acn kom muhta we, mwe aketeyae ke mani kuh mwe sihm ke mas. Kuht kuh pac in eis PHI kacłom sin acn sahyac su enenyuck in kasru kom kuh mahlwen nuh ke karinginyen mas lom.
- Suc liye PHI luhk?** Kuht orekmakihn luhan PHI srisrik na su kuht enenuh in oruh orekma lasr. Kuht kuh in akacsruhyuck PHI nuh sin prokracm sahyac kuh mwet fwın masap insese kac kuh fwın kom insese kac. Oacna sie mwe lolo, PHI lom kuh in ituckyang nuh sin ac orekmakihnyuck sin Health Care Authority ac mwet sahyac su lale mas in ahkkweyelah ac mahlwen nuh ke karinginyen mas lom. Kuht kuh in akacsruhyuck PHI ke pacl met, pacl se inge, kuh pacl mweven.
- Meac PHI su DSHS akacsruhyuck kac?** Kuht akacsruhyuck PHI lom mukwena su mwet sahyac enenuh in oruh orekma nuh selos, ac oacna luhan su masap insese kac. Kom kuh in siyuck nuh ke sie sruhu mwet suc DSHS el akacsruhyuck PHI lom nuh sel nuh ke kuhtuh mwe enenuh ke lofon onkoh loeslac.
- Ngac DSHS el akacsruhyuck PHI?** Kuht akacsruhyuck PHI ke ohiyacn "enenuh in etu" in ahkkweyelah mwe kasru ac nuh ke karingin mas, mahlwen, ac orekma ke karinginyen mas. Oacna sie mwe lolo, kuht kuh in akacsruhyuck mwe aketeyae:
- Nuh sin mwet lale mas in use karingin mas ac luhan karihngihn mwet mas.
 - Nuh sin u su kolyuck mahlwen nuh ke mwe kasru ke mas in ahkkweyelah mwe mahlwen.
 - In nuhnkuh fwın kom kuht in eis mwe kasru ke prokracm lun DSHS.
 - In kasru orekma lasr, oacna in nuhnkuh fwın karingin mas kom eis sin mwet lale mas sun luhan luhngse lun masap. Orekma inge kuh in weacng pihlaclyen mwe aketeyae, orekma in karihngihn sensen, ac orekma in nuhn.

Ngac DSHS el kuh in akacsruhyuck PHI luhk fwin nga tiacne insese kac?

Sahyacn akacsruhyuck nuh ke karingin mas, mahlwen, ac orekma ke karinginyen mas, DSHS kuh in akacsruhyuck PHI fwin kom tiacne insese kac nuh ke kuhtuh sripen sahyac. Ke masap, kuht enenuh kuh inseseyuck in akacsruhyuck PHI lom. Kuhtuh mwe lolo weacng enenuh in:

- Akacsruhyuck mwe aketeyae ke mas kac lom nuh sin sie kawuck kuh mwet in suhsu lom su weacng karingin mas lom. Oasr kuht lom in tiac insese nuh ke akacsruhyuck se inge. Fwin kom tiac insese, kuht ac fah tiac akacsruhyuck nuh sin mwet in suhsu kuh kawuck sacn.

Kuht ac fah tiac akacsruhyuck mwe sihm ke karinginyen SUD (Substance Use Disorder, [Mas ke Orekmakihn Mwe Sruhi) fwin kom tiacne insese kac, kuh fwin masap 42 C. F. R. Part 2 (Part 2.) insese kac. Fwin kuht eis mwe sihm Part 2 lom sin mwet sahyac, oacna mwet lale mas SUD lom, kuht kuh in akacsruhyuck mwe sihm inge fwin HIPAA insese kac. Tuhlac, kuht ac fah tiac akacsruhyuck mwe sihm SUD nuh ke nuhnuh ke civil, criminal, administrative, ac legislative lain kom, fwin kom tiacne insese ke mwe sihm, kuh nuh ke sie mwe lolo sin court.

Fwin nga lungse mwet sahyac in eis PHI luhk?

Kuhtuh akacsruhyuck su tiac sruhmuhnyuck ke mwe fwak se inge enenuh insese lom. Kuht ac fah tiac orekmakihn PHI lom nuh ke marketing kuh amoli PHI lom fwin kom tiacne insese ke mwe sihm. Kom ac fah ituck nuh sum in saenlac pweuh in insese in akacsruhyuck PHI lom fwin:

- Kuht enenuh insese lom in use mwe kasru kuh karingin mas;
- Kuht enenuh insese lom in akacsruhyuck mwe sihm ke psychotherapy;
- Kom lungse kuht in supala PHI lom nuh sin u sahyac kuh mwet lale mas nuh ke sripen sahyac su masap tiac insese kac fwin kom tiacne insese; kuh
- Kom lungse supala PHI nuh sin mwet sahyac, oacna attorney lom, mwet in suhsu lom, kuh mwet kolyuck sahyac.

Insese lom in akacsruhyuck PHI lom ac fah wo nuh ke lwen kom simlac fin pweuh sacn. Kuht kuh in akacsruhyuck PHI su kom sruhmuhn mukwena. Kom kuh in tui kuh ekuhllah insese se inge ke mwe sihm nuh sin DSHS.

Nga kuh in liye PHI luhk?

Kom kuh in liye PHI lom, fin sra kuh ke ohiyacn electronic. Fwin kom siyuck, kom ac fah eis sie kapi ke PHI lom. Fwin kom siyuck, kom ac fah eis sie kapi ke PHI lom.
