MWE AKKILENYUCK:

- Ofuhs kuh mwet ma muhta ahol records: Pepuh se ma nwekyucklac inge lelah: (1) in orekmakinyuck ac kithakatelihk mwe ahkkahlwemyeyuck DSHS ac ofuhs sahyac ma tahklac ten inge, ac (2) kitakatiyacn mwe ahkkahlwemyeyuk inge nuhsin DSHS ke ofuhs kuh mwet sahyac tahklac ten inge. Kom kuh pac in sumuhslah ofuhs sahyac ma kom lelah in kihtakatelihk mwe ahkkahlwemyeyuck inge, suc mwet se suc suk kahsruh inge enenuh in sain in lelah.

Kom kuh in sang in ahtlah sie list in records ma mwet se suc enenuh kahsruh ngacn in sainiyac in lelah in kihtakat. Fin oasr record ma oasr mwe ahkkahlwemyeyuck ke ihp luhn mental health (RCW 71.05.620), HIV/AIDS kuh STD testing kuh onweyac (RCW 70.02.220), kuh mwe kahsruh ke drug ac meah nimnim (42 CFR 2.31(a)(5)), mwet se suc suk kahsruh ingacn enenuh in mahkiyac ma inge fin el lelah in kihtakatelihk records nge. Pepuh se inge tena putatyang nuhke records ke psychotherapy 45 CFR 164.508(b)(3)(ii); pepuh se sahyac enenuh in nwekyucklac in eis kain in record se inge.
- Puhlan Pacl: Sang sie len in sahflah luhn pepuh in lelah se inge, fin sienna lihki yac se. Pepuh in lelah se inge e expire tukkun yac se (1) fin kom tena akkilen in ekklac liki yac se (1).

ACN IN SAIN:

Mwet se suc enenuh kahsruh inge kuh in ahollah mahk se ke pohk se inge fin kom witnisi.
- Witnis kuh Notary: Mwet in witnis se kuh notary e kuh in eneneyuck in akkilen mwet se suc enenuh kahsruh fin mwet se ingacn tena sang pepuh in lelah se lal ngan sifacna kuh fin purokwracm se enenuh in akkilenyuck mwet se suc enenuh kahsruh ingacn. Fin mwet se suc enenuh kahsruh ingacn akkilenyuck ye masap tuh koflah in sifacna nuhnak ac mukiki lal, mwet in topang ah lal in sain fin el sang sie copy ke order of appointment lal an. Fin mwet se sain luhn kuhtena mwet (oacna sie mwet ma oasr power of attorney la kuh mwet ahol mwet sahyac), enenuh in mahkiyucki "Kuuhuh ma Sahyac" ac sang sie copy ke legal authority to act lom an.
