Ren omw ka sainnei ei taropwe, ka pwarata pwe ke tipeew me mutata an DSHS me ewe/ekkewe agency me aramas mi affatatiw repwe aea me aea ngeni ekkoch masowen porausom. DSHS esapw tongeni pinei senuk omw kewe aninis pokiten/anonganong won omw kosapw sainnei ei taropwe, tiwan chok ika e need omw mwumwuta an epwe katon ika determine omw tufich (eligibility) ne angei aninis. Ika kosapw sainnei ei taropwe, DSHS epwe chiwen tongeni aea fengen porausom ngeni ekkoch mei mwumwu seni annuk. Esinesin ngeni ekkewe Chon Nounou faniten Poraus: **Ika ekkei rekot mei kawor/pachanong porausan HIV, STDs, ika AIDS, kosapw tongeni pwarata ika aea fengen ena/ekkana poraus ngeni ekkoch tiwan chok ika ewe client epwe wisen watiw an mwumwuta.** Ika a fen toruk porausan ewe client faniten **drugs ika osukosukan sakaw (alcohol abuse)**, kopwe pwan apachanong ewe kapasen poraus me fan ika kopwe pwan aea fengen ngeni ekkoch usun mei affat non annuk 42 CFR 2.32:

Ei poraus a toruk seni ekkewe rekot mi nomw fan pwungun annukun monomon ika Federal confidentiality rules (42 CFR masowen 2). Ekkewe annukun Federal kena ra kan pineiuk seni foforan ekkena pwarano seni ei poraus nge ika chok pwe napenon pwarano a kan aporausa mumutan seni ewe maaken amumuta seni ewe aramas ekkei poraus ra kan ngeni ika a kan mumuta seni 42 CFR part 2. Ew unusenapen amumuta ren ewe katowowun ren porausen safei ika pwan ekkoch poraus ESE KAn naf ren ei popun eaean. Ewe Federal rules e appeti/aukano an emon epwe aea/aea fengen an emon poraus mei tichik ren och angangen choosa ika tipengaw (kopwung) faniten emon peichen/chon semwen (alcohol ika drug abuse patient).

Aea: Ke tongeni aea ei taropwe nupwen omw kopwe angei an emon DSHS client mwumwuta ne aea ika aea fengen poraus mei tichik ika ren omw kopwe aea fengen ena/ekkana poraus ngeni ekkoch agency ar repwe fori ar angang, momo ika pwan ekkoch mwokutukut/popun fan pwungun annuk.

Masowen non ei Taropwe:

AIITITIN:

- Iten: Awora ewe it ren chok emon aramas won echo me echo taropwe. Apachanong ekkena iten me mwan ina ena aramas a kan eaea nupwen an angei aninis kena.
- Ranin Uputiwom: Mei auchea ach sipwe affata pwun en ewe wesewesen chon mwumwuta ren ei taropwe.
- Nampan Aiititin: Awora ew nampan aiititin emon aramas ika pwan ekkoch sakkun aiititin usun chok ew nampan social security (ese nomot kaworen) ren aninisin non aiititin rekoto kena me pwan tapweiin wuruwon me pwan aninis kena ra angei.
- Pwan ekkoch: Mi pachenong non ei bwor ekkena apachenongan poraus ina epwene aninis non kuuten rekoto kena, usun chok DSHS ra fitinong fiti aninis kena, iten chon non family kena, ika pwan ekkoch poraus kena ra nomot.

MUMUTA (AMUMUTAN):

- Popun ren Apwarano: Ei poraus epwene kawor me mwan DSHS epwene tongeni eaeafengen rekoton safeingaw me sakau ika semwinin non mekur kena. Ika pwe en kose kan amasowanong ei taropwew, DSHS epwene maakei ewe popun ren pwarano pwe a kan seni eom tungor.
- Iten ewe/ekkewe agency ika aramas repwe aea-fengeni poraus/rekot: Ei taropwe e mwumwuta/mwutata: (1) aean ekkewe poraus mei tichik ren DSHS ika ekkewe agency/aramas e chok pachanong iter fan; me (2) aea fengen ekkewe poraus mei tichik ngeni DSHS ren pwan ew agency ika aramas e chok pachanong iter fan. Ke pwan tongeni apachanong iten ekkewe agency/aramas ir mei tongeni aea fengeni poraus mei tichik, iwe ewe client epwe pwan sainnei.
- Poraus mi pachenong: Aramas kena repwe kan asisinata rekoto kena ra kan pwonupwon seni ewe amumuta. Aramas kena repwene fori pwe meinisin rekoto kena repwene kawor ika repwene awukuku ekkewe rekoto repwe pachenong seni ranin, sakkun ika ia rekoto a etto me ia. Ika emon client esapw sainnei eche taropwen mwumwuta/tipeew are ika ese affata ika menni poraus/rekot e kan mwumwuta ngeni, ina epwe chiwen mwumwuta an ewe poraus epwe no ngeni ekkoch mei mwumwuta seni annuk. Ke pwan tongeni apachanong menni poraus/rekot mi tongeni aea fengeni ika no ngeni ekkoch iwe ewe client epwe pwan sainnei. Ika e wor ekkoch porausan/rekoten mental health (semwinin non mekur/ekiek) (RCW 71.05.620), checkin/testin ika treatment ren HIV/AIDS ika STD (RCW 70.02.220), ika aninis ren osukosukan sakaw/drugs (42 CFR 2.31(a)(5)), a men auchea an ewe client epwe wisen watiw an mwumwuta fanitan. Ei taropwen mwumwuta esapw pachanong ngeni pekin ika aninisin psychotherapy fan annuk 45 CFR 164.508(b)(3)(ii); kopwe fori/amasowa pwan eche taropwe faniten ena/ekkana sakkun poraus.
- Ukukun taman: Apachanong ewe ranin expire (inet epwe kauno), ika pwe e sokkono seni ew ier. Ei mwumwuta epwe expire (kauno) mwurin ew ier, tiwan chok ika ke affatatiw pwan ew ran/pwinin maram.
- Aweweti: Tumunu pwew ewe aramas a weweiti met mumuta a kan kaworono me pwan ifa usun me pwan pwata poraus repwene eaeafengen. Ika mei namot, kopwe fori an ei taropwe epwe chiakuni (translated) ika aea aninisin emon chon chiaku ne anea ei taropwe. Ika ewe client a mochen angei sopwosopwun poraus, kopwe ngenii eche kapin ewe DSHS Notice of Privacy Practices (Esinesinen Annukun Monomon), ika ereni ewe client an epwe fos ngeni ewe chon aninis (public disclosure officer) me non omw unit.

SAININ KENA:

- Aramas: Angei emon aramas ika emon semirit a nap ierin ren amumuta (13 ren semwinin non mokur me pwan aninisin safeingaw me pwan sakaw kena; 14 ren HIV/AIDS me pwan ekkoch STD kena; ese nifinifin ierir ren safean pinepinen popo me pwan abortion kena; 18 rentumunun safei me pwan ekkoch rekoto kena) saini ei bwor me pwan uwanong ewe ranin ewe sainin. Ewe aramas a tongeni asiwini ew maak non ei bwor ina en ka emon chon pwarata ngeni.
- Chon pwarata ika Notary: Emon chon pwarata ika notary epwene mochen ren an epwe afatano aiititin ewe aramas ika pwe ewe aramas ese kan uwanong ei taropwe non aramas are ika pwe ew program a kan tungor afatenon. Ewe aramas epwe wisen sainnei me makkei itan (non peres) on ei taropwe.
- Sam me In ika Pwan Ekkoch Chon Tipweni: Ika pwe ewe aramas a kan emon semirit kukun seni ierin amumuta, iwe emon sam me in ika chon tumun epwe kan sain. Ika ewe semirit ese tori ewe kaukun ika "ierin mwumwuta" ren meinisin an kewe poraus mei tichik, iwe ewe semirit pwan iinan/saman repwe sainnei. Ika ewe client ese tongeni epwe pwusin fori ika finata mettoch on inisin/ekiek, ewe court epwe appoint emon chon tumwun epwe wisen sainnei ei taropwe iwe kopwe pwan ngenii eche kapin ewe order ika taropwen kopwung. Ika e wor pwan emon aramas epwe wisen sainnei ei taropwen mwumwuta pokiten pwan ew sakkun niknik (pachanong emon chon nemenem ika estate representative), iwe epwe checki "ekkoch" (other) iwe epwe pwan pwarata "proof" ika taropwen affat faniten an mwumwuta ika authority ne sainnei ei taropwe.
