Uwa weweiti:

- Ngang uwa apesi ai upwe angang, kut ai angang, ika moneta ai upwe angang.
- Upwe pwan pachenong non ekkewe fofor mi nomot ren ei. Ika pwe use, iwe upwene angai ew tipis nge ika pwe uk an awora pwaratan pwe mi wor ew ai popun mi eoch. lei met ra aita ngeni nonom non an WorkFirst fofor kena ra apungu.
  - Ika pwe ngang mi apung, wewen ei:
    - Nei we monien aninis epwene akisino ren 40% ika wisen emon, epwe ena chok mi nap seni, IKA:
    - Usapw chuen no tongeni angei foforan aninis, nge ika pwe uwa pwan tonong sefan non WorkFirst.
  - Ika pwe nei we monien aninis a kan akisino pokiten apung seni WorkFirst:
    - Iwe meni upwene kan fiti nei we IRP ren ruwanu wik iteitano ren ai upwe asopwano ewe apung.
    - Nupwen ai uwa fofori met upwe fofori ren ruwanu wik iteitan, ai we tipisin apung a sopono epwe poputa ewe aewin maram murin ai we ruwanu wiken ai pachenong.
    - Ai we case epwene kapunguno ika pwe uwa nom non apung ren engon meram non iteitan.
  - Ika pwe ai we case a kapunguno pokiten ren apung seni WorkFirst:
    - Upwene kan aeoeo sefan me pwan kan pachenong ren ruwanu wik iteitan chok me mwan ai upwe tongeni angei moni.

- Use tongeni kuna ew nenien tumunun semerit uwa tongeni moni, mi eoch ngeni nei kei semerit mi kis seni 13 ierir;
- Mi wor ai ei osupwang ren annuk iei attun;
- Mi wor ai ei osupwang ren mokutukut ika ekkoch sakkun me pwan ei a petiniei ai upwe tongei fofori met kewe mi nomot reni ei program; ika
- Ngang emon aramas nap fiti fakkun ngawen me osupwangen mokutukut iteitan;
- Ngang uwa kan momocheniei me non imwei ren tumunu emon semerit mi kan wor aninisit iteitan ika pwan emon aramas nap mi kan osupwang ren mokutukutun;
- Ngang mi 55 ieri ika nap seni me pwan tumunu emon semerit nge ngang usapw semen ika inen ewe semerit; ika
