- Allukun muun (sopwun RCW 41.05A me 43.20B) mei mumuta ngeni omw ewe estate epwe meeni sefani ngeni ewe Pwutain Tumwunun Aramas (Department of Social and Health Services, DSHS) me ewe Pwutain ren Nemenemen Tumwunun Manaw (Health Care Authority, HCA) ren monien ekkoch angangen safei me angangen aninis me aninis non fansoun nangatam (LTSS) ka angei.

Met weween eú estate?

- Meinisin pisek me pwan ekkoch pisek mei wor reomw ika mei wor mumuta ren annuk non ewe fansoun omw mano mei pass ren ika ese wor ew will. Iei a pachenong pisek me pisekin angang usun:
 - Imw, fonu;
 - Bank accounts;
 - Sitok me bonds;
 - Pisekin aramas; me
 - Pisek ese wor probate, ekkewe estate minen manau.

 - Ekkewe monien tumun mi mumuta me ren ewe Pwutai,
 - Ekkewe angangen prokramen tumunun chon fori tipis ren ar repwe niwinsefan,
 - Ekkewe angangen chon tupw ar aninis, me

- Angangen Tumwunun aramas me Prokramen Anisi ika Epeti (Conservatorship Assistance Program).

- Ekkewe kost HCA a moni fan ew Prokramen Tumunun Moni seni ewe muun.
- Koukun monien safei HCA epwe moni ika pwe kese pwan angei LTSS.

- DSHS epwe atoura ewe lien ika pwe ka niwin ngeni imwomw.
