### **Hab-Socodka Cabashada Macmiilka DDA**

- A. In kasta oo uu Xeerka WAC 388-02 u idin siinayo, adiga, macmiilka iyo wakiilka macmiilka, xuquuq ay ku weydiisan karaan Dhageysi Maamuleed, laakiin ma jiro xuquuq rafcaan laga qaadan kaaro **Diiditaanka Hore** ee Ka-Duwanaan Xeer (ETR) sida ku qoran qodobka WAC 388-825-120(3)(d).
- B. Haddii aadan raali ku ahayn go'aanka ETR, waxaad wici kartaa maamulaha keyskaaga/kheyraadkaaga si aad ugu sheegi waxa aad ka welweleyso.
- C. Waxaad sidoo kale adigu xaq u leedahay inaad cabashdaada oo qoraal ah aad u so gudbiso maamulaha keyskaaga/kheyraadkaaga kor-meerahiisa/eeda.
  - Cinwaan uga dhig cabashadaada "DDA Supervisor of (Magaca Maamulaha Keyska (CRM) )", ama
  - Weeydii maamulaha DDA ee keyskaada/kheyraadka magaca kor-meerahooda.
- D. Marka uu helo cabashadaada oo qoraal ah, kor-meeraha DDA ayaa dib u eegi doona go'aankii ETR ee cabashdaada iyo kuu soo wargalin doona go'aankiisa/eeda oo qoraal ah toban (10 ) maalmood gudahood.
- E. Haddii aadan ku qanacsanayn go'aanka kor-meeraha, waxaa xaq u leedahay inaad u dirto cabashadaada oo qoran Maamule Degmeedka DDA ee degmadaada.
- F. Maamule Degmeedka DDA ama wakiilkiisa ayaa dib u eegi doona cabashadaada qoran oo kuugu soo diri doona ogeysiin qoran oo go'aankiisa/eeda gudahooda toban (10) maalmo shaqo laga bilaabo helitaanka cabashada. Ogeysiiskan ayaa soo gabagabeynaya qaabsocodka cabashadan.

### **Kelmadaha Kala Soocid La'aanta**

Takoorigu waa ka reebban tahay dhammaan barnaamijyada iyo hawlaha qabashadooda: qofna laguma takoori doono sabab sinji, midab, diin,caqiido, asal waddan, lab iyo dheddig, cimri, xaalad guur, sooyaal naafoo ah ama xaalad sooyaal askartii Fiyetnaam, ama naafo ahaanba.

### **Instructions for Notice of ETR Decision**

1. Follow notification requirements per Policy 5.02.
2. Enter the date of the ETR decision at the top of the form.
3. Enter the relevant WAC citation for the requested exception along with a brief description of the request.
4. Check the box that is appropriate for the disposition of the request.
5. If an ETR is not initiated or denied then check the appropriate reason.
6. If the ETR is approved, document the **service type** and **amount** in the space provided next to the approved box.
7. Enter any relevant text from the WAC that supports denial because the request contradicts federal law or state statute.

Example: WAC 388-825-375(b): The department will deny payment of services to the natural/step/adoptive parent of a minor client age seventeen or younger.
