

**Pworausen Apechokunan Ekkewe Aninnis (Nonassistance Support Enforcement Information)**  
(Sopwun 26.18, 26.23, 34.05, 74.20, me 74.20A RCW)

**Annomwu ei taropwe; mi wor auchean pworausen omw we keisin aninisisin semiriit.**

**Ekkewe pekin ngeni omw we orterin aninnis**

Ekkei ruu pekin ngeni omw we orterin aninnis ir ewe saam/iin ese wiseni tumwun me ewe saam/iin a wiseni tumwun ika ewe a wiseni anomwu (ekkewe semiriit). Ewe saam/iin ese wisseni tumwun ii ewe epwe meeni ewe aninnis. Ewe saam/iin a wiseni tumwun ika annomwu (ekkewe semiriit) ii ewe ekkewe semiriit ra kan nomw ren. Me ruomwon ekkewe saam/iin ese wiseni tumwun me ewe a wiiseni tumwun repwe awor insuransin safei ika aninnisin safei fan itan ekkewe semiriit.

- Aninnis in safei a pachenong meenifengeni ekkewe niwinin safei me ekkewe premium (met wisan won niwinin ewe insurans safei mwirin nenien an angang a meenatiw wisan) ika pwe mi pwal annukutiw me non ewe orter fansoun ese kawor insurans.

**Pekin Aninnisin Semiriit**

Pekin Aninnisin Semiriit (The Division of Child Support (DCS)) a wor an ofes a nomwefetan non won ei sopw (state). DCS a kan mesemes won me apechokuna ekkei keisin aninnis ngeni semiriit. An DCS epwe apechokuna omw ewe orterin aninnis, ew me nein ekkewe pekin ngeni ei orter repwe tungor aninnis in apechokun non taropwe (repwe mak ngeni).

Ika omw we orterin aninnis a kan no ngeni ewe Washington State Support Registry (katon ena kinikin mwirin ei) nge ese wor tungor aninnis ngeni DCS, DCS epwene suku ew keisin an epwe chok angei kametiwan (Payment Services Only (PSO)). DCS a awora an epwe chok angei ekkewe mwoni epwe kametiwan me makker fan itan ekkewe keis PSO.

**An Mwuun Washingtgn We Makken Aninnis (Washington State Support Registry)**

An Mwuun Washington We Makken Aninnis (Washington State Support Registry (WSSR)) ii pwan chon kinikin DCS ewe a kan anomwun makken me atou ekkewe mwonien aninnis a kametiwan. DCS epwene wanong omw we orterin aninnis no WSSR fansoun ew me nein ekkei a fis.

1. Ew me nein ekkewe pekin ngeni ewe orterin aninnis epwe tungorei DCS epwe apechokun ekkewe aninnis.
2. Omw we orterin aninnis a annuk an ewe saam/iin ese wiseni tumwun epwe meeni ewe aninnis (child support) ngeni WSSR.

**Met Kopwe Feeri**

Fansoun chok ka eisini DCS an epwe apechokuna ewe aninnis, kopwe:

1. Tini ngeni DCS meinisin mwoni epwe kameetiwan ka angei seni ewe saam/iinn ese wiseni tumwun. DCS epwe wor rer taropwen meinisin kameetiwan mwoni ar repwe tongeni angang won omw we keis. Ika kopwe angei ekkei mwonien aninnis epwe kametiwan mwen omw tungor aninnis seni DCS, kopwe ngeni DCS ew taropwen anetata tetenin mwon minne mei kameetiwan. Fansoun ka tini ngeni DCS ekkewe mwoni a kametiwan ka angei seni ewe saam/iin ese wiseni tumwun, DCS epwene amasowanong non noumw we DCS debit card ika wanong ewe aukukun non omw we akoun sia chok awenanong (direct deposit) non.
2. Ereni DCS ika kopwe siwini neniomw (address) ika nampaan noum tenefon. DCS a mochen ekkewe pworaus epwe anisi ne kekkeruk/toruk ren fan itan omw ei keis. DCS epwe tongeni atoura ngonuk ekkewe taropwen esinesin (legal notices) non posto (first class mail).
3. Ereni mwittiri DCS ika ouwa chufengen sefan me ewe saam/iin ese wiseni tumwun ika fen ekkewe semiriit ra no nomw ekis. Kopwe awora ngeni DCS pwan ekkewe ekkooch pworaus ika repwe eis.
4. Ereni DCS ika ka angei emon noumw souannuk ika ew neeni esapw an mwuun pwun epwene wisen angei omw kewe aninnis. Kopwe ngeni DCS itan me ar ewe souannuk address (nenian) ika ewe neeni esapw an mwuun. Kopwe ereni DCS met ewe souannuk me ewe neeni esapw an mwuun epwe angang won.
  - a. DCS ina esapw tufichin epwe ange omw kewe aninnis fansoun ewe sou annuk ika neeni esapw an mwuun mi anganga ar repwe angei.
  - b. Ika kopwe angei emon noumw souannuk an epwe siwini omw we orterin aninnis, en ika noumw we souannuk oupwe atoura esinesinen ngeni ewe saam/iin ese wiseni tumwun me DCS.
5. Ngeni DCS ika anisi DCS an epwe angei kapin meinisin orterin aninnis mi makkenong non omw we keis.

## **Annuk ren Kopwe Angei Aninnisin Apechokuna Ekkei Aninnis (Requirement for Receiving Nonassistance Support Enforcement Services)**

Ika pwe ese pwung me non annuk omw kopwe tumwunu ekkewe semiriit ka tungor aninnisin apechokunan aninnis, ka tongeni kopwe affata pwe kose amwochu ekkewe semiriit seni ewe a pwung me non annuk an epwe tumwunur/anomwur.

DCS epwe angei \$35 fee (niwin) iteitan ier (federal fiscal year) DCS a tiningonuk \$550 non aninnis ika kose **mwo piin angei** Aninnisin Mwoni Non Mochomochun Fansoun Ngeni Ekkewe Famini Ir Mi Osupwang (Temporary Assistance to Needy Families (TANF), Aninnisin TANF ngeni ekkewe re Indian, ika Aninnis Ngeni Ekkewe Famin Fan Itan Semiriit (Aid to Families with Dependent Children (AFDC)) fan itan semiriit. Ew fiscal year epwe pwopwuta October 1<sup>st</sup> me epwe much September 30<sup>th</sup> ew me ew ier. DCS a angei me isoni ewe \$35 seni ewe aninnis a angei mwirin DCS a tini ngonuk ewe ewin DCS \$550. Ika epwe nap seni ew omw keis pwokiten noumw kewe a sokofesen semer, ka tongeni kopwe meeni nap seni ewe niwin(fee) a kan tetiw non ew me ew ier. Ika Kopwe angei TANF, TANF seni Re Indian, ika AFDC seni pwan ew sopw, kopwe pwan tinato pisekin pwarata, ika eche taropwe mi apwong sen ew ofesin aninnisin mwuun seni ewe ew sopwe ika eche kapin taropwen aninnis mi impang, ngeni DCS. DCS epwe siwini ewe fee tori sia angei ekkei pisekin pwarata. Ika kopwe meeni ewe \$35 fee epwe weires ngeni omw famini, ka tongeni tungorei DCS an epwe wor ew mwiich ngeni ewe Board.

### **Aninnisin Apechokuna Ewe Aninnis**

Ika mei wor omw orterin aninnis ewe a aukano ukukun ewe aninnis, DCS epwene achocho ngeni an epwe angei ena ukuukun. DCS ese kan apacha me angei manawan mwoni a kapach non omw we orter. Non ekkoch keis, DCS epwe atoura ew esinesin ngeni me ruu ekkewe pekin ngeni ewe orterin aninnis me mwan an epwe pwopwuta ne angei (collect).

Ika ese wor omw orterin aninnis ika omw we orterin aninnis ese affata aninnisin semiriit me aninnisin safei, DCS epwene atoura ewe esinesin ngeni me ruu ekkewe pekin won ei orterin aninnis.

1. Non ei esinesin, DCS epwene auku ewe aninnisin semiriit me ainnisin safei. DCS epwene anonga ewe aukukun aninnisin semiriit won kapachanapen an me ruemon saam/iin me fitemon ekkewe semiriit.
2. Omw we orter a annuku pwe emon me emon ekkewe saam/iin repwe awora insuransin safei fansoun ese wor seni an ewe saa ik ainn seni ar angang ika union ren ukukun esapw napesei 25 presentin met ewe saam/iin epwe meeni non aninnis.
3. Ei orter a tongeni pachenong aninnisin safei me wisomw won ewe premium a kametiw seni ew me nein en ika ewe state ika ewe insuransin safei ese kawor me ren ewe saam/iin ita epwe wiseni meeni.

Ika omwwe orterin aninnis ese aukano ew aukunun aninnis nge era ew anen sipwe sine ew aukuk, DCS epwene atoura ew **Noesinesinen Fite Aninnis Epwe Kametiw Esan Mwo Kametiw** ngeni me ruomon ekkewe won epwe orterin aninnis.

1. Non ei esinesin, DCS epewne aukn ukukun ewe aninnis. Ew me nein ekkewe pekin ngeni ei orterin aninnis a tongeni tungor ew arongorong won tipeceseng won ewe aukukun aninnis DCS a aukano.
2. DCS a tongeni achocho ngeni epwe apwungano ew ukukun aninnis fengen me ekkewe ruu pekin won omw we orterin aninnis.

Fansoun ewe aukukun aninnis a pwunguno me ika DCS a sinei an ewe saam/iin ese wiseni tumwun we nenien angang, DCS epwene tinano ew **Income Withholding for Support (Katetiwen Ewe aninnis me non omw mwoni tonong)** esinesin ngeni ewe nenien angang. Ei esinesin a annuku an ewe nenien angang epwene etiatiw ewe ukukun aninnis sen niwinin ewe saam/iin ese wiseni tumwun. Ika DCS ese sine an ewe saam/iin ese wiseni tumwun we nenien angang, DCS epwene achocho ngeni ne kutta an mwoni tonong a etto me ia me achocho ngeni epwe angei ei aninnis.

Ika omw we orterin aninnis a wor pekin ren aninnisin safei ngeni ekkewe semiriit, DCS epwene pwan achocho ngeni epwe apechokuna ei. Ei mwokutukut DCS epwe feeri a anonganong won ei kinikinin omw we orter.

1. Ika mi wor omw orter ewe a anuku ika affata pwe ewe saam/iin ese wiseni tumwun epwe awora ewe insuransin safei, meeni och ekkewe niwinin safei ese wor me non insurans, met epwe ketiwi me non niwinumw (deductibles), me copayment (wisomw kopwe menatiw mwirin a kametiw met ewe insurans epwe meeni), ika pwan ekkooch mwoni me nukun fansoun ewe saam/iin ese wiseni tumwun ese wor noun insuransin safei, DCS epwe apechokun ew me nein ekkei annukun aninnisin safei.
2. Ika mi wor omw orterin aninnis ewe ese affata pwun ewe saam/iin ese wiseni tumwun epwe awora insuransin safei ren ekkewe semiriit, DCS epwene achocho ngeni siwini ei orter.
3. Ika epwe wor omw orterin aninnis ewe a annuku me affata pwe insuransin safei epwe pwan kawor, meeni och ekkewin niwinin safei ese wor me non insurans, copayment (wisomw kopwe menatiw mwirin a kametiw met ewe insurans epwe meeni), me deductibles (met epwe ketiwi me non niwinumw, ika meeni wisomw ren ekkewe ekkooch an saam/iin niwinin ren health insurance premium (niwin an epwe wor noumw insurans) ika pwe ese wor pwisim noumw insurans, DCS a tongeni apechokuna ekkei annuk ika pwe ewe saam/iin ese wiseni tumwun epwe tungor aninnisin apechokunan ekkei aninnis.

Ika pwe mei wor noumw insuransin safei ir ekkewe semiriit ir mi nounou, kopwe awora ngeni DCS pisekin pwarata pwe ir mi kafer ika nounou. Ka tongeni awesano me eniwinato ei taropwe mi kapachenong **taropwen pworausn insuransin safei noun ewe saam/iin a wiseni tumwun (Custodial Parent Health Insurance Information)** taropwen pwe ina omw pisekin pwarata.

Ika mei wor noumw insuransin safei me kose mochen DCS epwe apechokuna ewe aninnisin safei me non omw we orterin aninnis, kopwe awora ngeni DCS isekin parata pwe mei wor me ereni DCS non taropwe pwe kose mochen epwe apechokuna ewe kinikinin aninnisin safei.

Ika ew inenap ika samanap rese pwupwunu, me:

1. Emon ika fen ir me ruomon rese saini ewe **Anetatan Io Seman (Paternity Acknowledgement)**, ew kapwung an sopw (state) ika kewe an re Indian (tribal) epwe apwungano io we seman me non annuk. DCS epwene tinano omw eis keis ngeni emon souannuk ewe a kan wiseni atipisi, kapwung an re Indian, ika Ofesin Ewe SouAnnuk Mi Nap (Attorney General) epwe angang won.
2. Ir me ruomon ra saini eché **Anetatan Io Seman (Paternity Acknowledgement)**, DCS epwene pwopwuta ew orterin aninnis nge esapw seni kapwung.

Ika ewe ew pekin won omw we orterin aninnis a tungorei DCS pwun epwe feeri, DCS epwene awora apecokunan ekkei aninis ika mwo pwe kosapw mochen.

Ika ese wor me nein ekkei pekin won omw we orterin aninnis ra nomw non Washington, DCS epwe awora apecokunan ekkei aninnis ika pwe ekkei me tettenitiw mei pwung.

1. Ese wor me nein ekkei pekin won omw we orterin aninnis a angei aninnisin apecokun seni ew sopw (state)
2. Ewe saam/iin ese wiseni tumwun a kekkeri/mmak ngeni ewe sopw, Washington State. Kekke/mmak a pachengang angangen me kame seni ika fen feeri an pisinis non Washington, wor pisekum auchea/tufichumw non Washington, me ekkooch. Ekkewe saam/iin rese wiseni tumwun epwe wor naaf an nomw/feer mettooch me Washington State an DCS epwe tongeni angei ekkei aninnis.

Ika ewe saam/iin ese wiseni tumwun a nomw won pwan ew sopw me ese wor an nomw/feer mettooch fengen me Washington State, me en ka nomw non Washington State, DCS a tongeni feeri ekkei mi tettenitiw.

1. Sotuni/achocco ngeni pwopwueta nemenemem me pechokun won ei keis me angei ekkewe aninnis non pechokunan annukun Washington state.
2. Tungorei ewe sopw ewe saam/iin ese wiseni tumwun a nomw ie pwe repwe wisen angei ewe aninnis. Ewe ekkooch sopwe epwe mwokut fan nurun ekkei annuk.

DCS epwe akkota fengeni me ewe saam/iin rese wiseni tumwun ren ekkewe mwoni epwe kametiw non ekkewe maram a mmang. DCS a anonga ekkei mwoni epwe kametiw won ekkewe annukun ewe orterin aninnis me unusan ewe aukukun a aninnis a mmang ren ei keis.

Ika mi wor orterin aninnis ewe a mwut ngeni DCS an epwe atoura ew **Katetiwen ewe aninnis seni omw mwoni tonong (Income Withholding for Support)**, DCS epwene atoura ew esinesin ngeni an ewe saam/iin ese wiseni tumwun we nenien angang (ika mi sinei).

Ika mi wor omw orterin aninnis ewe ese mwut ngeni DCS an epwe atoura ew **Katetiwen ewe aninnis seni omw mwoni tonong (Income Withholding for Support)**, DCS epwene atoura **Esinesinen Niwinimangan Ekkei aninnis me epwe era kopwe meeni (Notice of Support Debt and Demand for Payment)** ngeni ewe saam/iin ese wiseni tumwun. Ewe **Esinesinen Niwinimangan Ekkei aninnis me epwe era kopwe meeni (Notice of Support Debt and Demand for Payment)** a affata fita ewe aninnis me ngeni DCS pechokunen an epwe atoura ew **Katetiwen ewe aninnis seni omw mwoni tonong (Income Withholding for Support)**.

1. Ika kopwe angei eché kapii me kose tipeew ngeni ewe ukukun aninnis a affat non ei esinesin, ka tongeni tungor ew arongorong. Ika kopwe angei eché kapi nge kose tipeew ngeni ewe ukukun aninnis a affat me non ei esinesin, ka tongeni tungor ew arongorong.
2. Ewe saam/iin rese wiseni tumwun a tongeni tungor ewe mwiich ngeni ewe board (iei ew arongorong) an epwe apwungu kinikinin non ewe esinesin a affata ewe ukukun aninnis. Ka tongeni fiti ei arongorong mwen ewe board (Conference Board).
3. Ika ke tungor ew arongorong me ewe saam/iin rese wiseni tumwun a tungor ew arongorong mwen ewe board (Conference Board), ka tongeni finata ika kopwe ani ewe arongorong ika ewe arongorong mwen ewe board (Conference Board).

Ren ew kapwung an epwe pwopwuta, apecokun ika siwini ewe orterin aninnis, DCS epwene atoura ewe esinesin non taropwe ngeni ekkewe ruu pekin ren ei orter epwe tini non posto (first class mail). DCS epwe tongei atoura ekkei esinesin ngeni ew saigonon address (neni) an ekkewe pekin me ruu. Ika DCS epwe atoura ei esinesin ngonuk, epwene iei saigonon orter me esapw chiwen wor pwal ekkoch esinesin ngonuk. Ew kapwung ika Soukapwung (Administrative Law Judge (ALJ)) a tongeni epwene apwungano ekkesiwin ewe orterin aninnis ika pwe ew ekkei pekin ese war no ewe kapwungun ekkesiwin. Ei a apecokun ika mwo pwe DCS ese tongeni pwarata pwe ewe pekin ese war mi angei ei esinesinen arongorong a titino non posto (first class mail) ngeni ewe saigonon address kich mei sinei pwe an ewe pekin.

DCS ese tongeni pwopwuta ika apecokuna ekkewe annukun tumwun ika churi ekkewe semiriit.

### **Representation (Kapas Fan Itan)**

DCS me meinisin ekkewe ofesin Attorney General me ofesin Ekkewe Souannuk ra wiseni atipisi (Prosecuting Attorney) ir mi angang fengen me DCS fan itan ar repwe pworaus fan itan ewe Pwutain Aninnisin me Safei. Ekkei ofes rese angang ngeni ika pworai fan itan ew me nein ekkei pekin ngeni omw we orterin aninnis.

### **Arongorong**

Sopwun 34.05 RCW a mwout ngeni ekkewe ruu pekin won omw we orterin aninnis an epwe fiti ei arongorong fan itan omw we orterin aninnis. Ew me nein ekkewe ruu pekin ra tongei fiti ei arongorong ar repwe chuto ika won tenefon. Arongorong a tongeni siwini ika affectini ukukun ewe aninnis. Ika kose fiti ew arongorong, emon soukapwung (ALJ) a tongeni atiwa me apwungano ewe tungor seni DCS ika ewe ew pekin ngeni omw we orterin aninnis me esapw chiwen wor pwan esinesin ngonuk mwirin. En mi tongeni angei emon souannuk epwe pworaus fan itomw non ei arongorong.

## **Angangen akukunano**

Ika pwe ewe sam ika inn ese anomwu ngeni ekewe semirit a nomona ika ra ureni pwe epwene kanupwus non ukukun esap kukun seni onou maram mom imwen kanupwus, DCS ika emon me nein ewe sam ika in mi tongeni tungor ren epwe mwo kukukuno, ika keuno, toun aninis ren ekewe semirit. Ei mwokutukut a itemi angangen akukunano. En, ewe sam me inn ese wor omw pechokun won ewe semirit, ika DCS mi tongeni epwe awora ewe an tungor ren ewe angangen akukunano. Ika pwe akisilon mi fich ngeni eom we case, kopwene kan angai ew arongrong seni DCS aweweni porausen ewe akisino me an emon me enom pung ren ar repwe eis ren ew arongrong ika pwe rese tipeew ngeni.

### **Anininisin Angei (Collection Services)**

DCS epwene achocho ngeni:

1. Angei mwonien aninnisin iei me ekewe a mmang (ika mi wor).
  - Mi chok aukuuk fansoun, DCS a tongeni epwe ationonga ew atipeew non chok ew mochomochon fansoun ewe epwe mwutata ewe saam/iin ese wiseni tumwun epwe meeni epwe kukkun seni ewe aninns minen iei a totiwan maram a affat non ewe orterin aninns. Ekkei mwoni epwe kametiwi a tongeni napono mwach kan an epwe mwout ngeni DCS an epwe angei unusean aninnsin iei me met a mmang.
2. Angei manawan ekewe aninns a mmang ne kametiwi. DCS epwene feeri ei ika chok mi wor omw orterin aninns ika ew apwung seni kapwung an state me ekewe an re Indian (tribal) ewe a affata unusean manawan.
3. Angei niwinin tumwunun semiriit ika pwe epwe annukutiwi me affat non omw we orterin aninns.
4. Angei aninnsin pwunuwomw we (a pwan itemi alimony) ika mi annuk me affat non ewe orterin aninns. DCS ese auku ewe aninns ngeni pwunuwomw we (spousal support).
5. Apechokunan aninnsin safei mi annuk me affat. DCS a tongeni epwe achocho ngeni ne angei niwinsefanin met ka meeni ngeni safei (ren copayment, deductible me ekewe premium) fan itan ekewe semiriit ir mei nomw won ei orter epwe eaea met mi tufichin eaea fan nurun ewe annuk Sopwun 74.20 me RCW 74.20A RCW. WAC 388-14A-1020 a awewei met a nomw non tikkin uninsured medical expense (mwoni ren ekewe ese wor neur insurans). **Ewe DCS epwene awora ew taropwen aninnsin safei ren unusean fonu (National Medical Support Notice)** ren an epwe apechakuna ekewe mettoch mi awuchea ren insurens ren safei ika apechakuna ew tipwen moni esap nap seni ewe awukukun sam me in repwene kan moni ren ar niwinimang, awukuk ngeni 25 persentin an sam me in kewe repwene moni ren aninnsin semerit.
6. Apechokuna aninnsin pekin sukuun ren an ekewe semiriit repwe sopweino ar sukuun mwirin ar awesi aiskun (high school). Ekkewe chok imwan kapwung an state me tribal (chon Indian) ra tongeni atou ei sokkun aninns. DCS ese tongeni pwopwueta ei sokkun aninns.

Kosapw pwan eisini DCS an epwe angang won ekkei mettoch mei tettenitiw non ei kinikin. DCS epwe angang won met epwe anganga fan itan omw ei keis. Nge ka tongeni kuna ekkooch minafeen pworaus epwe tongeni anisi DCS ne angei omw kewe aninns. Ika kopwe feeri, kopwe ereni DCS. Apachanong ekkei pworaus non omw pworaus ngeni DCS.

1. Itomw, omw address (neniomw), nampan noumw tenefon, me nampan omw we keis.
2. Itan ewe saam/iin ese wiseni tumwun me nampan noun soson/social secuity (ika en mi sinei).

### **Aukano Aninnsin DCS**

Ika kopwe mochen DCS epwene kauno an aninnsin angei (ekkei aninns), kopwe tungorei DCS epwe nomw non taropwe. Ika pwe mi wor omw orterin aninns ewe a affata pwun ewe saam/iin ese wiseni tumwun epwe meenatiw ekewe aninns ngeni WSSR, DCS epwene kauno ne awora aninnsin angei ekkei aninns, siwini omw we keis ngeni PSO, me ereni ekewe saam/iin rese wiiseni tumwun. Ika pwe omw we orterin aninns ese annuku me affata pwe epwe kameetiwi ngeni WSSR, DCS epwene apwungano(close) omw we keis.  
Ika en ika noumw kewe semiriit ra chusefan me ewe saam/iin ese wiiseni tumwun, DCS epwene kauno ne angei ekewe aninns minen iei. DCS a erenuk usun ekkei ekkesiwin ngeni ekewe sokkun aninns ka angei.

### **Mwonien Takisesin Omw Mwoni tonong epwe meeni ewe niwinimang ese tetiw (Federal Income Tax Refund Offset), Amwochu Mwoni Ren Met en mi niwinimang ngeni mwuun (Administrative Offset), me esapw ngonuk noumw we passport (Passport Denial).**

DCS epwe ereni ewe Nenien angei Takises (Internal Revenue Service (IRS)) fansoun ewe saam/iin ese wiiseni tumwun a mmang ne menatiw ewe aninns ika pwe omw we keis:

1. DCS a sinei nampan ewe soson noun ewe saam/iin ese wiiseni tumwun.
2. Ewe niwinimangan aninns seni ewe orterin aninns.
