Advance directives a tongeni pwarata meefiom me met ka mochen faniten omw pekin safei me/ika aninis ren mental health (semwinin non mekur/ekiek) pachanong omw pwung ne etiwā ika u ngeni och safei, aninis ren mental health (semwinin non mekur/ekiek), ika reirei, nupwen kose tongeni chiwin finata sakkun tumwun me aninis epwe fis ngonuk. Ka tongeni siwini ika attaieno omw na advance directives inet chok ka mochen.

Ren omw kopwe uttut ika kosapw uttut esapw pwan aukano ei aninis ika ukukun tufich ei agency epwe ngonuk. Ika ka mochen emon epwe anisuk ne amasowa ewe taropwen register ren omw kopwe uttut, iwe sipwe fakkun anisuk.
