

Jiṃwe ko am āinwōt juon client ilo Developmental Disabilities Administration

Your rights as a client of the Developmental Disabilities Administration

Jiṃwe ko kar kwaḷoktulaṛejjiṃwe ko ilo dik naaj leḷok ṅanaolepān ro client ilo administration, imejjeḷokanunṅankōdikḷok jiṃwe kokar kwaḷokilo jet kien in bukwōn ak laḷ inko maroṅ kobajiṃwe koḷok.

(1) Administration eo ej aikuj kōjjeḷā juon eo im ri jojomar eo an armej eoak otkak eo juonḷapḷokkar aikujkōn jiṃwe ko kar kwaḷok ilo jepta 71A. RCW, kien eo 2020 ilo ankōjijet bwe juon eoej juon armej eo an maroṅ bōk. Kōjjeḷā eo an bwe administration eleḷok ej aikuj pād ilo jekjekinjeje. Administrationeo ej aikujkwaḷok bweraan eo an kōjjeḷā eo kar aikujilomōttan in emōj anleḷok.

(2) Administration eo ej aikuj kōjjeḷā juon eoimri jojomareo an armej eoak otkak eo juon ḷapḷokkar aikujkōn jiṃwe ko kar kwaḷok ilo jepta 71A. RCW, kien eo 2020 ilo ankōmṃane juon laajrakin aikuj an client eo. Kōjjeḷā eo an bwe administration eleḷok ej aikuj pād ilo jekjekinjeje. Administrationeo ej aikujkwaḷok bweraan eo an kōjjeḷā eo kar aikujilomōttan in emōj anleḷok.

(3) Ewor an clientjiṃweeoṅanbōk anemkwōjṅankālōteoktakjānkōṅaan an ri leḷok. Ej kobajiṃwe koan client ṅan:

- (a) Jab bōk jorrāānin lijjukul, ānbwin, imḷomṃak, ṃaneak ḷaire, ak kalbuujilo ṃweo eo jab kōṅaan;
- (b) Jab bōkan kōjdat kōn an menmen bwij, kil, laḷ, jikiṃḷotak, tōmak, ne kōrā ak emṃaan, ded, jorrāān, ṅe aṃ ṃare imeōr nejim,
- (c) Kōmṃane kālōt ko konṃōṅā rōt emaroṅbōkilo an karōk im men ko an client;
- (d) Loḷokri loḷokilo ṃwin client imbwebwenatoippānarmej ro client ekōṅaanimpādilojoṅanekkar ṅanro rej jokwe ippānclient eo;
- (e) Kōjparok iien eo an clientimkālōtṃakūtūt ko, iien ko, imkōjparokājmourbwe emṃan kōn aikuj ko an client;
- (f) Meḷeḷekōnkaṃadṃōd eokar jitoṅkōnri kōjparokājmour eo anclientimkarōk weweinkamṃadṃōd eo enaaj kōmṃane;
- (g) Jab bōkwūno eokwōjab aikuj, mō, im bōbrae;
- (h) Bout, bebe ilo kien in laḷ, imjibaṅarmejiilo ankōkāleliloopeij;
- (i) Kōjparok jāān eo anclientakjitoṅjuon armejṅanjibaṅ;
- (j) Maroṅ juon iaanjukjukin pād;
- (k) Kōmṃane kālōt kōnmour eo an client;
- (l) Kālōt ta ko kōṅaki im wewein kōmṃane bōranclient eo;
- (m) Kālōtimilikūt men ko ilo ruuṃ eo an clientkōnkōṅaane eo anclientak kālet im likūt men koilo ṃweoclientkōnkōṅaan eo an clientekkarṅanbujenro ṃōttanclientrej jokwe ilo ṃweo;
- (n) Bōke jermal eo kōḷḷāike;
- (o) Bōk jibaṅ kobwe client erreṅan bōke;
- (p) Kālōt ṅe ak jabṅanwanṃaanḷok ilokatak ālikin emōj an kōmeḷeḷekatak eoṅanclient eo, imālikinclient eo ak ri jojomaran clienterreilo jejekōn client eo ṅanpādiloankatak eo; im
- (q) Jab bōkkajje kōn jāān.

(4) Ewōrjiṃwe eoanclientṅanjibaṅilo ankarōk i kōn jibaṅ eo an administration. Ej kobajiṃwe koan client ṅan :

- (a) Pādwōt imleḷokam bakōn karōk eo an client ṅan bōk jibaṅke kar jeiippān administration imri leḷok;
- (b) Bōk iien koreṃṃanṅantōlwewein karōk;
- (c) Keememejkōṅaan ko an clientkōnjuon mour eoemṃanim tōpar ko an clientkōnjikuul, jermal, jikin ṃweo, peḷaakin ro jet, im ikkure kar koba ilo weweinkarōk;
- (d) Kālōt juon ri iuiunṅankōjparokko weweinkarōk ippānclient eo; im
- (e) Maroṅ ṅanbōk meḷeḷe eojiṃweim ilo tōreinkōn ikkure, jikuul, imjerbalemaroṅ kōmṃaneilo jukjukin pād client.

(5) Ewōrjimwe eoanclientñanbōk meļeļekōn jibañ ko imkōjparokājmour. Ejkoba jimwe ko an client ñan:

(a) Lale jeje kōn aolepān karōk in jibañ ko an client;

(b) Bōk tarlep in jeje kōn karōk kiiō kōn jibañ ko an client;

(c) Lalejeje kōn kien ko im wewein ko an jabdewōt jibañ eoclient ej bōke, ilo jabdewōt iien. E kobakien koim wewein kokōneļōmanclienteoemaroñ kōmñmaneabñōññan ri leļok ro imdoululeo;

(d) Allōkwaļok koanjoñak eo kǎāltatajān doululak etale kar kōmñmanejān ri joñak ilo bukwōn ak ri lale, kwaļok kōn bōd, im karōkkōn kajimweik ilokōmñmankōnkautiejñanri leļokeo an clientim jikinclient. Ri leļokjibañeo anclientej aikuj jibañclienteoilo an pukotim bōkmeļeļeinñeewōr kajjitōk an client; im

(e) Bōkkōjjeļā ilo jeje kōnkajejetmakūtūt ko kar bōke jān doulul eo mae ri leļokclient eo. Keij menijaeo an administrationak juon ekar jītōñej aikuj leļokkōjjeļā ñanclienteo imri jojomar eo an clientak oktak eo juon lapļok kar aikuj ñan kwaļok kōn kweiloan roñoul raan, jab kobajemļokin wiik imholidays, jān raan eo ankajijjet. Kōn un insubsection, juon "ri leļok" emeļeļeinjuon eo keej leļok jibañ ko ilo jikin pādīm kar bōkejān juon client eoekar kōjparok ak pādiumwinadministrationeo. Juon makūtūtñan kajijjet keeaikujkōjjeļāinekoba:

(i) Maroñ ko kar likūt ion ri leļokkōn kein kaṃool ak liijen;

(ii) Bōjrak ak jidik bōjraikin kein jilkinļokak kein deloñ;

(iii) Aikuj inkein kaṃool ilo bukwōn akjoļok kein kaṃool; ak

(iv) Abwin bōk, bōjrak, ak joļokeo an juon liijen ak pepa.

(6) Ewōrjimwe eoanclientñanabñōñim waļok in bōd, imñankajjitōkkōn bar kōmñmane. Ejkoba jimwe ko an client ñan:

(a) Abñōñō jabdewōtbebe jān doulul eobweemṃo, kōdikļok, ak kōjemļokmaroñ eo an client, jibañ ko, akkālōt eo an ri leļokāinwōtkar bailokien Medicaid federalimkien kobukwōnilo jibañ eokōn aolep;

(b) Jilkinļokwaļok in bōdñan ri leļok an clientkōnjibañ koan clientak jet inepata. Ekoba, akejabdik wōt, inepata kōn ṃwilim makūtūt koan jet armejilomour eo an client. Ri leļok ej aikujkōjparokjuon kien ilo jeje kōnweweinabñōñō im ekobatimelines immenin kajimweikemaroñ. Ñejuonwaļok in bōdejab kajimweik, ri leļok ej aikuj leļok kōmeļeļe ñan client eo kōn weweinjilkinlokabñōññandoulul eo;

(c) Kōmñmane abñōñō imkwaļok kōn bōd, im kajjitōkejeļok kajjeakbōdippāndoulul akro ri leļok; im

(d) Bōk meļeļe kōn eļomānanbōk oktakkōnjorrāān eo ilo wewein abñōñō.

(7) Ewōrjimwe eoanclientñanpād make im kōjparok an lōmñak make. Ej koba jimwe ko an client ñan:

(a) Kōjparok meļeļeim jeje ko bwe en pād ippānclient eo client eo emake;

(b) Bwebwenato ejab ṃaan ro jet, ekobajimweeoñanjilkinļokimbōkletaimemail, imjimweeoñankōjberbaljuon telepoon ilo juon jikineo emaroñ kōnono im ro jet ejabroñ; im

(c) loon doonimbwebwenatoippānro ṃōttan im baamleeo an client make.

(8) Ewōrjimwe eoan clientilo andiwōj, oktak, imkōjjeļok eo anjibañ koāinwōtepādṃaanļokilosubsection in.

(a) Client ro rejjokwe ilo juon jikin kōjparok ilo long-termbweekar lijeniumwinjepta [18.20](#), [72.36](#), ak [70.128](#) RCW ewōr anjimwe ko epād ṃaanļok ilo [RCW 70.129.110](#).

(b) Client ro rej bōkjibañ ko kein kaṃoolilo jukjukin pādewōranjimweñan:

(i) Pād ippān ri leļok eo an client. Jibañ ko eban jemļokijellōkin wōtri leļokej lōmakeimkwaļokke:

(A) Ri leļokeoejab kōjparok aikuj koan client;

(B) Aenōmñan client ak aenōmñan an ro jetarmejilo jikin kōjparok akjikin jokweekar kauwōtata;

(C) Ājmour eoan client ak ājmour eo an jet roarmejilo jikin kōjparok ak jikin jokweenaajkar kauwōtata; ak

(D) Ri leļokeo ej bōjrakimkilōk.

(ii) Bōk kōjjeļā ilo jeje jān rileļokkōn jabdewōteo emaroñ kōjemļokjibañ koilo dik anjilñoulraanmōktajabdewōtjemļokin, ijellōkinñeewōr juon kōmadmōdin idiñ kōnājmourimaenōmmanbweeaikuj jemļokinjibañ, ilo iien inkōjjeļā enaaj leļokilo dik an jimjuoñoul ruo awamōktaraan in jemļokin. Kōjjeļā eoej aikuj leļok ñan client eoimri jojomar eo anarmeļ eoaok otkak eoļapļok kar aikujkōn am kōñaan. Kōjjeļā eoeaikuj koba:

(A) Un injemļokjibañ ko; im

(B) Raan eo jemļok eo anjibañ ko enaaj jinoin.

(iii) Bōk juon karōk kōn otkak ilo dik an ruo raanmōktaraan eoekittieran jemļok in jibañ ko, ak ne jemļok eo ekkarkōn ājmourimkōmadmōdinidiñbōkjuon karōk kōn otkak ilon ruo raan jānkōjjeļā eo an administration bōke kōnjemļokinkōmadmōdin idin. Administration eo ej aikuj kōjjeļā juon eo im ri jojomar eo an armeļ eoaok otkak eo juon ļapļokkar aikujkōn jimwe ko ilo karōk eo. Karōk eoeaikuj koba:

(A) Ia eoclient eo enaaj mačkūtķūtñane;

(B) Weweinito-itakñanjikinekāāl; im

(C) Etan, atreej, imtelepoçonnōmbaeo an developmental disabilities ombuds.

(c) Juonri leļokbwe ej leļokjibañ koñanclient ro rej jokweiloṃweo mōn ri leļokej aikujkōmataolepwewejemļokinjibañ koṃoktaanjinoejabdewōtmačkūtķūt in bōjraķjekkar kieniuṃwin [RCW 59.12.030](#).

(9) Ewōrjimwe eoanclientñanbōk ro rej iuiiun. Ewōrjimwe eoanclientñanbōk meļeļe jāndoulul ilo an jeral ñaniuiunekon client eo, immaroñbōkiiēñankōnono ippāndoulul kein. Ri leļokenjab juṃaemaroñ eo an clientñan bōkjabdewōtmen koitulaj:

(a) Jabdewōtri jojomarilo bukwōn eo;

(b) Taktō eo an armeļeo;

(c) Developmental disabilities eoombuds; ak

(d) Jabdewōtri jojomareo an doululkar jitōññan kōmmanebūrookraaṃeo ankōjparokim kajjitōkkōn [RCW 71A.10.080](#) eo.
