Apw. Kose mochen kopwe kokori ei mwen om kopwe sotuni ne angeisefani ew meme e mwan ne titiu seni met pekin aninis epwe tou mwach kan.

DCS epwe fori ewe chok ukukun an waten angangen apechekuna meinisin inamo ika u cheki ewe pwor mi mak "Apw". DCS mi tongeni eaea ekoch pekin ren anepwe angei sefani moni mi mwan an titiu, mi pachenong ren an epwe angei niwinum me ekoch fofor mi mumuta fan RCW 74.20A.270.

Ngang u mochen DCS epwe anisi ei me nei semirit ren pekin aninis in apechekuna aninis ren semirit. Ngang u mochen DCS epwe apechekuna me etiwa me sokun anin meme ren aninis semerit (chek, money order, electronic transfers ika moni echok titi non computer, me pwan ekoch) epwe angei ren fan itei.

Ika iei uwa angei memen aninis semirit seni an state me tribal (an ekewe mwichen aramas is wesan chon winiposen Merika) imwen kepung ika an state ika tribal pekin tutumunun aninis semirit, u mochen pwe ewe imwen kepung ika pekin tumunun aninis semirit epwe tinano meinisin memen aninis ngeni DCS.

1. DCS e charchini ei \$35 chena ren meen non ew ier ika pwe use akangei ewe pekin aninis ren Temporary Assistance to Needy Families (TANF), Tribal TANF, ika Assistance to Families with Dependent Children (AFDC) ika aninis ngeni ekewe famine mi worn our semirit ren semiritin mi nom non imwei. DCS epwene iseni ei momo (nefinen Oktoper 1^{ran} me Septemper 30^{ran}) seni aninis semerit mi angai murin DCS a kan monsefani \$550 non momon aninis semerit ngenie non ew case non ew an mun nap fisical ier. Ika pwe mi wor nap seni ew ai keis, ngang mi tongeni ai upwe meni ewe meme ren ew me ewe keis ia \$550 mi kametiw ngenie **Ika pwe ngang mi angei TANF, Tribal TANF, ika AFDC seni pwan ew state Ngang upwe awora pisekin pwarata, ikei met upwe awora kapas enlet seni ewe public assistance agency ika ew certified kapi ren ai kewe taropwen pwarata ren aninis, ngeni DCS. DCS ra tongeni menatiw men tori ai upwe awora ai pisekin pwarata** Ika pwe memen ewe \$35 epwe afisata osupwang non ai family, upwe tungor angangen mwumwuta ren ai upwe tongeni churi chon ewe Board
2. Ika pwe DCS repwe tinano ai ei keis ngeni pwan ew state ren ar repwe apechekuna, ewe ew state epwe uwau men ren ar repwe fori ewe angang. Ekewe ekoch state ra angei met meme ren ar isoni ekis seni met re angei seni aninis semirit
3. DCS epwe uwou itei me iten nei kewe ngeni ewe sam me in ekewe semirit rese nom rer.
4. Mi eoch upwe ngeni DCS nampan nei social security nampa. DCS epwe eaea ewe nampa ren apechekunen mokutukutun aninis fan iten semirit usun mi afat non Title IV-D ren ewe Social Security Act.
5. DCS ese tongeni angei niwinimang ren aninis semirit mine ese mumuta me non annuk.
6. DCS ese tongeni ne apechekuna an ekewe mwichen Indian, met pekin pisnis an ekewe mwichen Indian, ika an ekewe mwichen Indian pisnis e nom on pwisn fonuer kewe mi afat non annuk (reservation) ren ar repwe angei aninis semirit seni an ewe sam ika in rese anomu ekewe semirit moni tonong. Ika pwe ewe mwichen Indian (tribe) me wor ar etipeu ren ar repwe fori, DCS epwe tungorei chon ewe tribe ika mwich ren ar repwe apechekuna ei kapas anukunuk fan iten aninis ekewe semirit.
7. Fori memen aninis epwe kame ngeni Washington State Support Registry (WSSR)
8. Ika pwe mi wor ew orter seni kort epwe wor an ekewe sam me inn ar repwe meni aninis semirit me ren WSSR, ai we keis epwe chok nomwetiw non ewe WSSR tori an epwe kapwunguno me ren kort ar repwe uwau ai we orter
9. DCS epwe uwau aninis semirit ren ai we keis ren met mi kawor me ren anukun federal me state DCS epwe:
 - a. Epwe fori ewe aninis semirit ren iei ngeni ewe maram non met mi angei
 - b. Tinato ren ewe minafon aninis semirit (Ika pwe ewe sam ika inn ese anomu ekewe semirit ngeni mi wor nap seni ewe aninis semirit mine epwe fori iwe pekin aninis angei moni ese aunusa meinisin met kei aninis moni epwe fori, DCS epwe kinitiwi nenenon monii mine epwe kametiw won ekei keis.
 - c. Amochu \$35 iteiten ier ren memen kametiwi, (nefinen Oktoper 1^{ran} me Septemper 30^{ran}), ika pwe use kan angei moni seni AFDC, TANG, ika Tribal TANF, ren ai tumunun kukunun semirit, murin \$550 aninis semirit mi tou ngenie ren ewe keis non ew ier
 - d. Loien moni mi kapachenong e watte seni fite aninis semirit mi kan tou non ew maram ngeni met aninis semirit ese mwo kametiwi (ika mi wor)
 - e. Ika ngang mi angei TANF me AFDC me nomw, DCS epwe inetau met aninis semirit ese kametiwi (chinon chok meme seni Internal Revenue Service (IRS)) ikei mi afat fan:
 - (1) Aewin, ekewe mi nuseni atun an epwe kametiwi aninis mi niwinimang ngenie nge ese mwo asain ngeni ewe state.
 - (2) Oruan, ngeni ekewe mi nuseni atun an epwe kametiwi mine mi wesewesen asain ngeni ewe state.
 - (3) aunungatin, ngeni ekewe mi nuseni atun an epwe kametiwi me niwinimang ngenie ren an nei we semirit aninis pekin pioin.
 - (4) Eruanun, ngeni ekewe aninis mi nuseni atun an epwe kametiwi mine pwe wesewesen asain ngeni ewe state me ren ewe public assistance assignment.
 - (5) Fifth, ngeni ekewe ekoch aninis ren pekin pioin mi asain ngeni ewe state.

10. Moni mi tori IRS ra iteiten nge awenewen ngeni aninis mi nuseni atun an epwe kametiw Meme ngeni IRS ra katou non kei sokun teten:
 - a. Aewin, epwe wesewesin asain ngeni ew pekin aninis ren moni mi nuseni atun an epwe kametiw
 - b. Oruan, epwe wesewesin asain ngeni ew pekin aninis ren moni mi nuseni atun an epwe kametiw
 - c. Aunungatin, epwe wesewesin asain fochofoch ngeni ewe aninis ren pekin pioin mi nuseni atun an epwe kametiw.
 - d. Eruanun, ngeni ew ekkewe aninnis a mmang ngonuk ewe ese awiis me ren ewe sopw (state).
11. WAC-388-14A-2037 aweweni ia a finata nomwofochona ia. WAC 388-14A-2038 aweweni ia a finata ren nonomw non ekis chok fansoun
12. Upwe chok meni sefani ngeni DCS ewe moni a meni ngeniei:
 - a. DCS ra titito moni rei nge ar mwan.
 - b. Angei moni mi watte seni mine ekewe sam me in rese tumunu ewe semirit ra ani niwinimang (apwan tongeni iteni niwin mi somwono).
13. DCS epwene kan angai sefani ewe napenon momo me/ika momowow mi mwanino seni amwochu sefani seni aninisin semerit ra angai rei me mwach kan, nge resapw pwan aronga ngeniei. Iei ei a iteni "ekiekoch" mi mwumwuta me ren RCW 26.23.035(3). Ngang mi tonguei ai upwe uwanong ai tungor non taropwe non peich ew non ewe taropwen amasou ngeni pwe DCS a kokoriei me mwen an epwe kuta memen me ren an ekeieki. DCS epwe kokoriei non ewe fansoun ren an epwe tungor ren mwumwutan ika ren an epwe esinesin ngeniei non taropwe pwe DCS a akota pwe epwe apechekuna ew memetiw me ren chinon chok ika pwe ua penuweni. Nupwen DCS awor pwung ren an epwe pechekun ne ekiekoch, ikei met afis:
 - a. DCS a amochu feita won 10 persen ren ai aninisin niwin nesor me penon.
 - b. DCS a amwochu seni won 100 persen ren ai meme nesor me penon mine anuseni atun an epwe kametiw.
14. DCS mi tongeni an epwe angei ekewe ekoch angangen ioioi ren an epwe mwumwuta me ren by RCW 74.20A.270 ren an epwe awesi niwin mi somwono me/ika niwin mi toriei nge mi mwan esap ururun epwe toriei. Ei mi weneitie ina mwo ika a murin ai koukuno ne angei monien aninisin semirit me ren DCS. DCS a finata ei sokun, DCS epwe ngeniei ew esinesin. Ika pwe ese wor taropwen en mi angei ren faniten ese tipeew ngeni, DCS a mwumwuta an epwe
 - a. Tiningeni ai we angang ika ekoch aramas ika organization mine mi iseis mettoch mi namwot fanitei **Income Withholding ren aninis**. Ei akuno / asinesin a mochen pwe ai we nenien angang ika ekoch aramas ika organization epwe angei ewe ukukun mi mwan ese pwung me/ika niwin mi somwono seni mine mi angei, moni tonong, me mine mi namot.
 - b. Epwe faen faniten an epwe uu ngeni met mine osen piseki.
 - c. Eaea sokkopaen napanapen an DCS epwe angei en mwoni mi mwumwuta me non Wekisin (Chapters) 26.09, 26.18, 26.23, me 74.20 RCW.
15. RCW 26.23.110 mwut ngeni DCS epwe ioni monien memen pekin safei mine ese menisefani(pachenong mine kopwe meni, moni mi kaimwu, me moni mi awewe non WAC 388-14A-1020) ese pwung ren faniten ekewe semirit seniei non sokopeten mwokutukut. DCS mi tonguei fori ren:
 - a. Akukunano ewe niwinimang ngeniei.
 - b. Akukunano ekewe aninis mi niwinimang ngeniei mine esap nap seni 50 persen ew me ew maram ren ew ier ika kukun seni.
 - c. Suki ew minafon keis ren an epwe uu ngeniei me pwan aa sokopaten safei mi ioni chinon chok ika pwe license mi saspen.
16. Ika ai we orter ren aninis epwe fori pwe upwe awora aninisin health insurance, DCS mi tongeni an epwe apechekuna ewe fofor ika pwe ekewe sam me inn rese tumunun ewe semirit re uwanong tungoren. Angangen apechekuna mi pachenong foforan moni ren osukosukan pekin pioin ren memen non maram, esap nuseni 25 persen ren ai we aninisin semirit mi pwata non ekewe taropwen angang ren ai we aninisin akuno.
17. DCS ese tupwunie ika ewe pwan ew pekin ngeni ai we aninisin semirit-akuno. Upwe achocho ngeni ne fiti meinisin arongorong ika mwukutukutun court faniten ai we akuno ren aninisin semirit. Ika pwe use fiti me pwan fofori non ei arongorong, emon Soukapung seni ewe ofes epwene mut ngeni ewe DCS met ra eis ika pwan ekewe ekoch chon aninisi nei we semerit order nge resapw mo aronga ngeni ei.
18. DCS mi tongeni uwanong men aninisi non ai bank akoun ren Electronic Funds Transfer (EFT). **Ika use mwutata epwe pwisin chok tonong non ai nenien nei moni non bank, DCS epwe chok pusin tinato rei non mail ew Visa debit card ika carten bank mi wor ekukunon fitu moni non, a iteni DCS debit card.** Ika DCS e atonongan non ewe DCS debit card program, iwe DCS epwe uwanong men aninisi non ewe card, nge esap non nenien nei moni non bank. Fan ekoch, memen aninisi a moneta ren ai upwe nounou seni bank ika nei we card seni DCS non unungat ranin angang ika murin an DCS a fori ekei ngeni ai we keis. Ewe DCS debit card a tongeni nounou ia a mwumwuta VISA ie ika ren ekewe mwesinen ATM. 19. Non meinisin kapwungun pwopwueta, apechekuna ika siwini omw we orterin aninnis, DCS a tongeni epwe atoura ekkei taropwen esinesin fan itemw non posto (first class mail). DCS epwe ngeni uwau ekei taropwen esinesin ngeni ekewe pekin ren ar kewe saingon address.

Ua tipeew ngeni:

1. Tinano ngeni DCS meinisin monien aninis mine ngang mi angei seni ekoch chinon chok DCS. Upwe tinano men ngeni DCS non ukukun wanu ran.
2. Upwe mutir asinei ngeni DCS ika pwe nei kewe semirit ir mi angei ewe me nein ekei niwin faniten ewe sam me inn rese tumumu ewe semirit. Ekewe sam me inn rese tumumu ewe semirit ir mi tongeni angei aninisin niwinimang ren ewe memen aninis noum we semirit mi angei. Ka tongeni eis an epwe aneta ekkei mwoni. Ika repwe niwini sefani nge a pwata pwe ewe saam/in a somwono met a meeni, ina kopwene meeni sefani ewe ukukun a somwono won. Non enetin me ururun, ewe sam me inn ren ewe semirit ii epwe chon amasou ngeni ekewe aninis.
 - a. Ew aninisis a kame ngeni ewe Deparmtnie of Labor me Industries ika aninisisin choon angang fansoun feiengaw me non angang a kame seni emon a pwusin meeni neun insurans (self-insurer) a kametiw mwirin Sunae 1, 1990.
 - b. Ew aninis faniten ekewe mi wor terir ika aninisin ritaer seni ewe Social Security Administration mi kametiw murin Sunae 1, 1990.
 - c. Ew aninisis seni ewe neni a kan anisi choon ir mei sounfiu me akkomw (Department of Veterans Affairs) non ika mwirin Sunae 24, 2015.
3. Upwe ureni DCS ike pwe ueisini emon aramas ika agency ren an epwe angei monien aninisin semirit ren fanitei.
4. Upwe ureni DCS ika pwe ai address ika an nei ewe semirit address a siwin.
5. Tinano meinisin kapin meinisin akuno faniten ewe monien aninisin semirit ngeni DCS mine mi ekesiwini ewe aninis mi auchea ika tumunun ewe semirit mine mi iteni me non ai ei keis.
