- Sia fetäl lefilen ekkewe imw afalafal imw me imw me a sereni emén.

- Oupwe meefi pwe a eu minen atoto chengel, ami pwii kkana, lupwen oupwe kuna sossot mi sokkopat.

Pun oua silei pwe sossotun ami luku fan iten DCS?

Iei ua silei pwe ka DCS lúkúei, pún en kese tongeni amwéché "Good cause (Noum We át Seniei)", noum we áláemén mi pwal fichiitikich ikenai an 25%.

Saingoon kapasen pesepes ngeni chon korint ruu DCS?

Ina popun, pwii good cause (noum we át seniei) achengicheng, oupwe uppos me lukucharetiu, Community Services Office (Fan iten angangen, CSO) nge fansoun wisemi. Good Cause (Noum We át Seniei) angang esap:

- Woon unusen fönüfan ra pwal ina chók ussun, ra kükkütta chokkewe mi fokkun mochen silei me angang ngeni.
- A silei ach kewe föfför, ekiek, me kapas me mwen.
- Pwata kopwe pöchökkül ren om silei ifa usun än kot we manaman mi (fel a älisi nöün kot keei) aramas sia silei pwe lupwen sia nonnom.

- Ami pwii kena, oupwe ekieki pwe minen pwapwa enlet fansoun

Nge ika sia aucheani mettochun ngun fansoun meinisin sipwe meefi DCS?

- Ifa B: mwan me emon fefin repwe kunafengenniir DCS silefengenniir me tongefengenniir a pwáaraatá féfféri met epwe apwapwaai.
