INTRODUCTION

The Special Commitment Center (SCC) and the transition treatment teams for persons who have court-ordered conditional releases closely monitor the residents' treatment progress and activities. As a result, the persons ordered by the courts to less restrictive alternative settings, including the secure community transition facilities, have not committed a sex offense or other criminal offense. When early warning signs of potential problems occur, consideration is given to take the person into custody and return him to the SCC for evaluation and recommended action to the court of commitment.

This report is submitted in fulfillment of the requirements of RCW 71.09.325(4). The statute directs the Department of Social and Health Services (DSHS) to compile information in writing on all violations of court-ordered conditions of release committed by all civilly committed sex offenders who are living in less restrictive alternative (LRA) settings. In addition, the department is required to report any penalties and actions taken by the department to remove a person from an LRA setting. The report is issued on an annual basis to the Office of Financial Management and the appropriate committees of the legislature.

This report addresses violations that occurred between November 1, 2012 and October 31, 2013. It also provides a status report on any violations that were addressed in a previous annual report but were not resolved before the report was submitted.

DEFINITIONS

For the purpose of this report the following definitions from the SCC policies are used.

- a. Less Restrictive Alternative (LRA). Court-ordered treatment in a setting less restrictive than total confinement that satisfies the conditions set forth in RCW 71.09.092. LRAs include private homes, secure community transition facilities (SCTF), and other court-authorized settings including contracted residential settings with twenty-four hour staffing.
- b. Secure Community Transition Facility (SCTF). A residential facility for persons conditionally released to a less restrictive alternative, including the SCTF in Pierce County on McNeil Island, the SCTF in King County and any community-based facilities established under Chapter 71.09 RCW and operated by or under contract with DSHS.
- c. **Private Home.** The LRA resident's own home or the home of a family member or other person that the court of commitment has approved as a less restrictive alternative placement.
- d. **General Violation.** Failure to comply with a condition of release set by the court of commitment, by DSHS, or by the Department of Corrections (DOC). A general violation may include a resident's failure to comply with a treatment plan requirement, posting, written instruction or verbal instruction given by an authorized person. A general violation is distinct from a serious violation.

Violations Committed by LRA Residents December 1, 2013 Page **2** of **15** e. **Serious Violation.** A violation by an LRA resident that includes but is not limited to the commission of any criminal offense; any unlawful use or possession of alcohol or a controlled substance; or any violation of a court-ordered condition, which targets the individual's documented pattern of offense that increases the risk to public safety. For purposes of this SCC policy, an accumulation of failure to comply with treatment plan requirements or with rules, infractions of rules, or any behavior that, in the judgment of the SCC CEO, represents a risk to public safety may be considered a serious violation.

CURRENT STATUS

During the period November 1, 2012 to October 31, 2013, there were thirty-three persons in court-ordered LRA settings. Fourteen persons resided in private homes, two were returned to SCC for violations of their court orders and one was unconditionally released. One lived in a contracted residential setting with twenty-four hour staffing. Four persons lived in the SCTF in King County with one being released to a private home as described above. Fourteen individuals resided in the SCTF in Pierce County (SCTF-PC), one was released to a private home as described above, three were returned to SCC for violations of their court orders and one of those was returned to the SCTF – PC.

For these thirty-three persons the following placement movement occurred related to violations.

Report Year November 2012 to October 2013

In November 2012, a resident living at the SCTF – PC was found to have violated their courtordered LRA conditions by failing to comply with the rules, regulation and policies of the SCTF – PC by accepting a Subway sandwich purchased by another resident, refusing to participate in sex offender treatment and failing to remain compliant with prescribed medications. On October 11, 2012 the resident was returned to SCC pending a revocation hearing. – **On October 17, 2013 the resident was returned to the SCTF – PC to continue his LRA.**

From June 2012 to November 2012, a resident living at the SCTF – PC was found to have violated their court-ordered LRA conditions by failing to comply with SCTF – PC rules, regulation and policies by lending/trading/giving food items and money to another resident, threatening another resident, displaying intimidating, aggressive and/or threatening behavior toward a staff member on two occasions, failing to comply with a polygraph assessment, failing to comply with staff directives, failing to consume medically prescribed mental health medications and failing to comply with sex offender treatment resulting in termination from treatment. On October 24, 2013 the resident was returned to SCC pending a revocation hearing. – **On February 1, 2013 the resident's LRA was revoked.**

In December 2012, a resident living in the community on a LRA was found to have violated their court-ordered LRA conditions by accessing the internet on three occasions without approval of their transition team; possessing a laptop computer, computer hard drive, Microsoft X-box game system; accessing the internet, accessing sexually explicit websites on the internet, possessing sexually explicit images of adults engaged in sexual activities; failing to maintain law-abiding behavior by possessing images of minors engaged in sexual activity; failing to abide by sexual deviancy treatment requirements resulting in his being terminated from treatment; having telephonic contact with an unapproved male, failing to comply with the policies of the SCC by

Violations Committed by LRA Residents December 1, 2013 Page **3** of **15** bartering or receiving property from another resident; possessing a T-Mobile Universal Serial Bus (USB) drive; possessing a RCA USB drive; possessing four digital video disc (DVD) movies depicting excessive violence and sex with violence, and possessing a cellular telephone without the approval of the transition team. – On July 24, 2013 the resident was returned to SCC pending a revocation hearing.

Prior Report Year Updates

In November 2011, a resident living in a private home in King County was found to have violated a court-ordered condition. This violation was failing to maintain the established, clearly marked perimeter on the property, as set forth by the Department of Corrections in consultation with the transition team, by removing the orange flag markers without authorization. On January 6, 2012 the resident was returned to the Total Confinement facility pending a revocation hearing. – On January 15, 2013 the resident passed away at the Total Confinement Facility from natural causes.

It was found that between November 2011 and July 2012, a resident living in a private home in Snohomish County was found to have violated a series of court-ordered conditions. These violations were Failing to obtain approval by the transition team to travel to multiple locations since on or about 10/17/11, Failing to keep an accurate log of all places he has visited, Failing to make accurate point to point telephonic contact with the CCO as directed since on or about 10/17/11, Failing to comply with the 8 pm – 6 am curfew on or about 5/23/12 and 7/4/12, as set by the transition team, Failing to comply with GPS monitoring protocols by failing to wait outside the residence for at least 5 minutes, or until a GPS signal is acquired and prior to leaving the residence on multiple occasions since on or about 5/13/12. On July 24, 2012 the resident was returned to the Total Confinement Facility for further care and treatment until a court hearing could be scheduled. **– At SCC pending a court hearing**

It was found that between February 2012 and March 2012, a resident living in a contracted residential setting was found to have violated several court-ordered conditions. The violations were having unapproved contact with a minor child on or about 2/15/12 and Failure to comply with sex offender treatment rules/regulations, resulting in termination from treatment on 3/5/12. On March 2, 2012 the resident was returned to the Total Confinement Facility pending a revocation hearing. – At SCC pending a court hearing

In July 2012, a resident living at the SCTF in King County was found to have violated a courtordered condition. This violation was Failure to comply with sex offender treatment rules, regulations and directives resulting in termination from treatment on 8/2/12. On August 3, 2012 the resident was returned to the Total Confinement Facility pending a revocation hearing. – The resident received a new court order and is now living at the SCTF – PC facility.

In August 2012, a resident living at the SCTF in Pierce County was found to have violated a series of court-ordered conditions. These violations were Failing to comply with the written agreement for internet usage by visiting a site that was inappropriate in nature pertaining to sexual deviancy, Failing to comply with the written agreement for internet usage by failing to report to staff any questionable site or image immediately, Failing to comply with sex offender treatment agreement by possessing prohibited visual depictions of semi-clad children, Failing to comply with sex offender treatment agreement by possessing images of children or viewing

Violations Committed by LRA Residents December 1, 2013 Page **4** of **15** media directed towards or focused upon children without the prior consent of the transition team, Failing to comply with SCTF rules and regulations by possessing an unapproved DVD, Failing to comply with SCTF staff directives, Failing to comply with SCTF rules and regulations by possessing an unauthorized cassette tape, Failing to comply with SCTF rules and regulations by listening to material that is not in the best therapeutic interest of the resident and Failing to comply with sex offender treatment rules/regulations, resulting in termination from treatment. On August 9, 2012 the resident was returned to the Total Confinement Facility pending a revocation hearing. **– LRA was revoked on 11/28/2012**

In October 2012, a resident living at the SCTF in Pierce County was found to have violated a series of court-ordered conditions during July and August. These violations were Failing to comply with the rules, regulations and policies of the SCTF – PC by lending money to another resident and Failing to comply with the rules, regulations and policies of the SCTF – PC by purchasing a cell phone for another resident. This resident was given a treatment assignment and a directive to not have direct or indirect contact with the other resident. The resident was having difficulty maintaining his mental health and during his October 10, 2012 transition team meeting he declined to participate in treatment and was returned to SCC pending a revocation hearing. – At SCC pending a new LRA hearing

In October 2012, a resident living at the SCTF in Pierce County was found to have violated a series of court-ordered conditions. These violations were Failing to take medically prescribed mental health medications since about 7/1/12, Failing to comply with the rules, regulations and policies of the SCTF – PC by borrowing/giving personal property with another resident, Failing to comply with the rules, regulations and policies of the SCTF – PC by displaying intimidating, aggressive and/or threatening behavior toward a staff, Failing to comply with the rules, regulations and policies of the SCTF – PC by intimidating another resident, Failing to comply with staff directives, Failing to comply with SOTP conditions, rules and regulations and possession of alcohol. The resident was returned to SCC on October 17, 2012 pending a revocation hearing. – At SCC pending a hearing

In October 2012, a resident living at the SCTF in Pierce County was found to have violated a series of court-ordered conditions. These violations were Failing to comply with DSHS Special Commitment Center (SCC)/SCTF-PC policies/rules/regulations by threatening another resident, Failing to comply with the DSHS Special Commitment Center (SCC)/SCTF-PC policies/rules/regulations by borrowing and trading during July and August 2012, Failing to comply with DSHS Special Commitment Center (SCC)/SCTF-PC policies/rules/regulations by borrowing and trading during July and August 2012, Failing to comply with DSHS Special Commitment Center (SCC)/SCTF-PC policies/rules/regulations by displaying intimidating, aggressive and/or threatening behavior toward a SCTF-PC Residential Rehabilitation Counselor (RRC), Failing to comply with polygraph assessment on 10/24/2012, and Failing to consume medically prescribed mental health medications. The resident was returned to SCC on October 24, 2012 pending a revocation hearing. – LRA was revoked on 2/1/13

Service Providers

During the period of this report there were no sanctions issued to service providers.
