

Whereas CCHI tests various components, listening, short-term memory, understanding of meaning, etc. in English, after carefully examining which skills that a good interpreter needs, can be measured in English. So much broader assessment that DSHS's single back translation.

My name is Antoinette Wynne, and I am the Language Access Program Manager for DES. I oversee the language access suite of DES statewide contracts.

Option 1: This option may not be available. DES Statewide Contracts are intended for statewide use by eligible purchasers. Eligible purchasers are government entities (federal, state, local, or Tribal) and certain nonprofit organizations are eligible to use statewide contracts. This option requires purchasers to be independent/individual interpreters.

Also, this option causes for a concern which testing contractors and service contractors. This may be a conflict of interest.






