### Minutes for the Meeting of January 23, 2023 Conducted via Zoom

**Call to Order:** *The meeting convened via conference call at approximately 12:35 p.m. A quorum of members was present.*

**Members Present:** *Kari Reardon, Donta Harper, Katherine Michaelsen, David Singley, and non-voting staff Lisa Wolph.*

**Guests Present:** *Dr. Tom Kinlen, Forensic Services Director; Dr. Elizabeth Zinda, NGRI Specialist Administrator; Aaron Goddu, incoming Interim Director of Community Transition*

a. **Business Meeting: (12:35 – 1:00)**

a) Dr. Kinlen addressed the following topics that the Panel requested information on at their January meeting:

- i. Panels request for statistics on the percentage of competency findings over the past three years. Working with data and analytics team to provide the information.
- ii. Addressed Panels request for clarification of 12/14/22 Assistant Secretary Bovenkamp memo announcing hospital admission triaging policy, where do NGRI and 1114 cases fit into this triaging policy? Dr. Kinlen reported that NGRI and 1114 cases are on the high end of the priority list to be admitted. There has been one NGRI that has come through since this was put in place on the East side that was admitted timely, and one on the West side with a slight delay.

Admission is on a case-by-case basis looking at prioritized areas which would include HB1114 individuals and non HB1114 individuals for admission population, NGRI population, competency, expedited admissions or returns. Each is looked at for severity of offenses, criminal history, and current functioning.

Additionally, BHA is working to bring additional beds online:

- 58 beds at WSH for in-patient competency services, the goal is for to open one unit opens in February 2023 and the second unit in April 2023.
  - 16 beds at Maple Lane for WSH civil conversion population at which is opening hopefully in February as well.
  - Working with Health Care Authority to identify additional beds in the community for the excessive amount of civil conversion individuals currently at WSH so more competency individuals can be admitted.
  - Maple Lane NGRI program – 30 bed facility. Currently working on the remodel. Target remodel date in June/July 2023 with a Fall opening. Current levels 3 and 4 NGRI patients from WSH that would transfer to that program.
- iii. Expressed apology for oversight of not including PSRP as a stakeholder.

b. Minutes from the 12/19/22 PSRP meeting were approved.

c. Staff Updates: Governors Boards and Commission is in process of review application for Consumer and Family Advocate position. Work continues to identify applicants for the Licensed Clinical Psychologist vacancy.
