• **Call to Order:**

The meeting convened via conference call at approximately 10:05 a.m. with a quorum of members present: David Hackett, Kari Reardon, Terri Mayer, Katherine Michaelsen, and non-voting Lori Melchiori and Lisa Wolph.

• **Business Meeting: (10:05 – 11:35)**

- A. Office of Forensic Mental Health Services Update: Dr. Tom Kinlen joined to provide a brief update.
- Ross Settlement: A patient ombudsperson for ESH and WSH has been hired and starts April 1st.
 - ESH in substantial compliance with the Ross Settlement.
 - WSH is scheduled for a final audit mid-May.
 - Hospitals have been assisting PSRP staff in updating the NGRI referral coversheet
 - Assistant Secretary Sean Murphy is working to improve ongoing issues such as timeliness of referrals, how to better support the hospitals to get the information to the PSRP, and identifying other opportunities for improvement. Mr. Murphy looks forward to meeting the entire PSRP membership at one of the annual in-person PSRP meetings.
- B. Minutes for the February 2019 PSRP meeting were approved as written.
- C. Discussion of next on site meeting. Panel would like to schedule a meeting at ESH in May or June. Lisa will follow up with members regarding scheduling and arrangements.
- D. Legislative Updates: None of the bills that would directly impact the PSRP are currently moving. 2019 Legislative session impact will be added to the May meeting agenda.
- E. PSRP Membership Application: Lori provided Panel input regarding new applicant. The applicant is now under review.
