

Public Safety Review Panel

Conducted via Conference Call

• **Call to Order:**

• **Business Meeting: (10:05 – 10:25)**

- a. Dr. Kinlen provided update on the three new NGRI positions:
 - 1. NGRI Administrator: Dr. Zinda is the NGRI Administrator and will be transitioning into the position over the next month. She will be the key NGRI contact for the PSRP.
 - 2. Two NGRI Specialist positions: licensed psychologists, reporting to Dr. Zinda. These positions will be instrumental in working with the treatment team, Risk Review Board, and ombudsman.
 - i. WSH NGRI Specialist: position filled, starts on boarding 1/23/20.
 - ii. ESH NGRI Specialist: Currently interviewing and still receiving additional applications.

Discussion: Lori asked if there a comparable position for the 1114 program? No not at this time. Dr. Kinlen will continue to be the point of contact for that program.

- c. Statutory Criteria for Conditional and Unconditional Release – Panel members discussed the letter from Assistant Secretary Sean Murphy. David Hackett will draft a response letter based on discussion
