# **Functional Family Parole**

Family support is critical to preventing youth from re-offending.

JRA has radically shifted how it provides parole aftercare services — from a primary focus on the offender to a service delivery model that focuses on the entire family.

This model, Functional Family Parole (FFP) began in 2002 and is a key component of JRA's Integrated Treatment Model (ITM).

## JRA parole counselors help families:

- Improve how they work together to accomplish family goals.
- Move beyond blaming and negative expectations of each other.
- Learn strategies to support and reinforce the positive changes their child has made while in JRA.

## Sex Offender Parole/Services

Sex offender treatment services use a cognitive behavioral approach which includes:

- An individual, group and/or family treatment setting.
- Family involvement.
- Relevant core components designed to match to a youth's treatment needs.

# **Functional Family Therapy**

Functional Family Therapy (FFT) is a 12-week family intervention program that has shown significant reductions in delinquency, re-arrest, out-of-home placement, violence, and substance abuse in at-risk youth.

#### **FFT Coordinators:**

- Help families develop trusting relationships and learn how individual problems affect each person in the family.
- Actively teach parents, youth, and others how to replace negative blaming experiences with ways to be positive and supportive of each other.
- Teach a variety of parenting skills that are creative and highly effective.

## Mental Health/Substance Abuse

Mental health and substance abuse services include:

- Screening and referral for chemical dependency treatment.
- Assistance obtaining Washington State medical insurance.
- Referrals for medication management and counseling.

## **Mentor Program**

The goal of the mentor program is to match adult mentors to youth involved in the juvenile justice system. Mentors act as role models to help JRA youth lead a crime and substance abuse-free lifestyle.

- Mentors meet with youth at the institutions for the last two to five months of their sentence.
- Mentors continue to meet with JRA youth when they parole to Spokane County.
- The program is researched based and shows promising effects in reducing recidivism.

- Structured Alternative Confinement
- Interstate Compact Supervision
- Referral to job skill training and employment services
- Transportation for appointments
- Graduated Interventions
